- 4. Applicant for Review presents their case (either personally or via legal representation) and introduces witnesses where appropriate.
- 5. Questions by Members to applicant and/or applicant's witnesses.
- 6. Representations by responsible bodies and/or interested parties and w itnesses introduced w here appropriate.
- 7. Questions by Members to responsible bodies/interested parties and/or their witnesses.
- 8. Licence/Club Certificate holder presents their case (either personally or via legal representation) and introduces witnesses where appropriate.
- 9. Parties may question and clarify issues raised with the consent of the Chair.
- 10. If required, applicant/responsible bodies/interested parties to be given opportunity to sum up.
- 11. If required, the Licence / Club Certificate holder to be given opportunity to sum up.
- 12. Members to have the opportunity to clarify any points raised. The Chairshall ask whether all parties are satisfied they have said all they wish to.
- 13. Members to go into closed session to deliberate.
- 14. Chair informs parties of their decision, with reasons.

Subject: APPLICATION FOR THE REVIEW OF A PREMISES LICENCE – 89-91 CHA THAM ROAD, HARTLEPOOL

## 1. PURPOSE OF REPORT

1.1 To consider an application for the review of a Premises Licence in respect of 89-91 Chatham Road, Hartlepool.

#### 2. BACKGROUND

- 2.1Party requesting review :Trading StandardsPremises to which application for review relates:89-91 Chatham Road<br/>Hartlepool
- 2.2 The current licence authorises the following activities: -

Supply of Alcohol (Off Licence)	Monday to Saturday	0800 – 2300
	Sunday	1100 – 0000
	Christmas Day	1200 – 1500

	Good Frid <i>a</i> y	0800 – 2300

2.3 A copy of the Premises Licence is attached as Appendix I.

#### 3. SUM MARY OF THE APPLICATION

3.1 Trading Standards has requested a review of the Premises Licence on the following grounds: -

'On 21<sup>st</sup> September 2005 the licensed premises supplied alcohol to a child of fourteen years of age.

Supplying alcohol to children can have a serious impact on anti-social behaviour in an area and be a nuisance to residents.

Selling alcohol to children can also place that child at risk, both in terms of their health and personal safety.'

3.2 Trading Standards has also provided the following additional information: -

'On 21<sup>st</sup> September 2005 the Trading Standards team conducted a covert test purchasing exercise using two fourteen year old volunteers.

The exercise involved supervision of the children as they attempted to purchase alcohol from off-licensed premises.

The children entered this premise during the evening of the 21<sup>st</sup> September 2005 and purchased an alcoholic beverage.

The store is owned by Mr Joseph Vincent who is also the Licensee.

The sale was recorded on covert video camera. Proof of age was not requested by the store assistant. Mr Vincent was adjacent to the staff member who sold and did not intervene.

On the 16<sup>th</sup> May 2006 Mr V incent was successfully prosecuted for the offence contrary to Section 169A of the Licensing Act 1964.

He was fined £500 for the offence and ordered to pay £825 in costs.'

3.3 A copy of the Application for Review is attached as Appendix II.

#### 4. **ISSUES**

- 4.1 An application for the review of a licence is made under Section 51 of the Licensing Act 2003. The application must be made by either a Responsible Authority or Interested Party as defined by the Act. Trading Standards is a Responsible Authority.
- 4.2 The application must also relate to at least one of the Act's 'licensing objectives'. These are: -
  - The prevention of crime and disorder;
  - Public safety;
  - The prevention of public nuisance; and
  - The protection of children from harm
- 4.3 The application has been advertised in the prescribed manner and two representations have been received.
- 4.4 The Head of Hartlepool Borough Council's Safeguarding and Review Uhit, the competent body responsible for matters relating to the protection of children from harm, has made the follow ing representation, which is also attached as Appendix III: -

'In respect to the four licensing objectives, under the category of protecting children from harm, the implications of supplying alcohol to a minor places the child at risk, both in terms of their health and personal safety; alcohol can have a serious impact on anti-social behaviour in an area and be a nuisance to residents.'

4.5 Cleveland Police have made the following representation, which is also attached as Appendix IV: -

'The position is this; Hartlepool is experiencing disorder on a weekly basis due to under age drinking. Our Response Teams are stretched to the limit, particularly on a weekend in order to deal with this problem.

It is no accident that one Team of officers are specifically tasked and have been for months with dealing with disorder linked with underage consumption of alcohol especially at weekends.

The summer is now upon us, that will inevitably bring yet more problems due to the longer days and the warmer weather.

Furthermore, officers dealing with juvenile drunkenness cannot respond in a timely fashion to more legitimate calls for assistance from members of the public.

My personal view is that enough is enough. The law abiding majority have for too long had to endure the harassment and disorder that juvenile drunkenness imposes on their neighbourhoods. Everyone has a part to play in restoring order to our streets and Licensees in w hatever capacity they function have quite specific responsibilities. A cavalier attitude appears to be at play in some areas and I think that this cannot be tolerated any longer. The juveniles have to be protected from themselves and the law abiding majority reassured that those in positions of responsibility not only can and will take stern action to deal with abuses.

This is not a decision to be taken lightly but I believe revocation is the only viable option.'

- 4.6 Following consideration of the application, relevant representations and any comments of the licence holder, Members may take such steps as they consider necessary for the promotion of the licensing objectives.
- 4.7 The steps are: -
  - To take no action;
  - To modify the conditions on the licence (this may include altering or omitting an existing condition or adding a new condition);
  - To exclude a licensable activity from the scope of the licence;
  - To remove the Designated Premises Supervisor;
  - To suspend the licence for a period not exceeding three months;
  - To revoke the licence.

#### 5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant, responsible authorities and licence holder and determine w hat action, if any, should be taken.

#### **ANNEX 1 – Mandatory Conditions**

No supply of alcohol may be made under the premises licence-

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

#### ANNEX 2 - Conditions consistent with the Operating Schedule

1. Alcohol shall not be sold or supplied for Off Sales, except during permitted hours

The above restrictions do not prohibit:

(a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;(b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

(c) the sale of alcohol to a trader or club for the purposes of the trade or club; the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

2. Alcohol shall not be sold in an open container or be consumed in the licensed premises.


