Subject: APPLICATION TO TRANSFER LICENCE AND

APPOINT AN INDIVIDUAL AS A DESIGNATED PREMISES SUPERVISOR – THE MOWBRAY.

MOWBRAY ROAD, HARTLEPOOL

1. PURPOSE OF REPORT

1.1 To consider two simultaneous applications for (1) The Transfer of a Premises Licence and (2) The appointment of a new Designated Premises Supervisor in respect of The Mowbray public house, Mowbray Road, Hartlepool.

2. SUMMARY OF APPLICATIONS

2.1 Applicant: Mrs Joanne Diggle

Premises: The Mowbray

Mowbray Road Hartlepool

2.2 Applications have been submitted by Mrs Diggle to transfer the premises licence into her name and also for her to become the Designated Premises Supervisor (DPS) in relation to the above named premises.

3. BACKGROUND

- 3.1 As required by the Licensing Act 2003, copies of the applications were served on Cleveland Police. The Licensing Act states that where the chief officer of Police is satisfied that the exceptional circumstances of the case are such that granting the application(s) would undermine the crime prevention licensing objective he must give the Licensing Authority a Notice.
- 3.2 In this case Cleveland Police have given such Notice and therefore the Licensing Authority must hold a hearing to consider the objection and determine whether the applications should be granted or refused. A copy of the Police's objection Notice is attached as **Appendix I**.

4. ISSUES

- 4.1 Applications to transfer the premises licence and vary the DPS into Mrs Diggle's name were submitted to the licensing authority on 10th April 2012 and, as these applications have immediate effect, Mrs Diggle has been acting in these capacities since that date.
- 4.2 A relevant objection Notice has been submitted by Cleveland Police within the prescribed time period. The Police Notice states that Mrs Diggle is currently the DPS of a licensed premise in the Stockton area where there have been reports of after hours drinking, opening beyond the hours allowed, drugs found on the premises during a Police operation, a positive test purchase and a report of Mrs Diggle being violent towards a customer.
- 4.3 A hearing must therefore be held for Members to consider the Notice unless the licensing authority, the applicant and Cleveland Police who gave the Notice, agree that a hearing is unnecessary. At the time of writing this report no such agreement had been reached.
- 4.4 Members must consider the facts detailed in this report and any other evidence presented and take any of the following steps for the promotion of the crime and disorder licensing objective:
 - i) Grant both applications
 - ii) Grant one application but refuse the other
 - ii) Refuse both applications
- 4.5 Should Members decide to refuse either or both of the applications then Mrs Diggle will be deemed to be no longer the holder of the premises licence and/or DPS and responsibility will automatically revert back to the previous licence holder and/or DPS.

5. RECOMMENDATIONS

5.1 That Members consider the objection submitted by Cleveland Police and determine whether to reject or grant (i) The Transfer of a Premises Licence application and (ii) The Variation of the Designated Premises Supervisor application to Mrs Joanne Diggle.

Re:- Application to Transfer Premises Licence and Vary the DPS from Patricia Watson to Joanne Diggle. The Mowbray, Mowbray Road, Hartlepool

I write to inform you that Cleveland Police give notice of objection against the variation of the DPS and the application to transfer the premises licence from Patricia Watson to Joanne Diggle on the grounds that the exceptional circumstances of the case are such that granting the application would undermine the crime prevention objective. The reasons for the notice are as follows:

The Mowbray already suffers from alcohol related crime and disorder and after hours drinking. Cleveland Police have found it necessary to speak to the current DPS, Patricia Watson on numerous occasions and indeed, it was deemed necessary for the hours of opening to be reduced in order to address the problems.

Joanne Diggle has spoken to PC Hussain in relation to this application and advised that she is currently a bar maid at a certain premises in Stockton. However, after speaking to officers in the Stockton area, it has become apparent that Joanne Diggle is currently the DPS at another premises in Stockton.

Whilst Joanne Diggle has been the DPS at this premises in Stockton, there have been reports of after hours drinking, opening beyond the hours allowed, drugs found on the premises during an Operation (Lumberjack) a positive test purchase and also a report of Diggle being violent towards a customer.
