MINUTES 2 AUGUST 2012

The meeting commenced at 3.00 p.m. in the Civic Centre, Hartlepool

1. Apologies for Absence

Apologies for absence were received from Councillor Wells.

2. Declarations of interest by Members

None.

3. Minutes of the meeting held on 22 February 2012

Confirmed.

4. Portfolio Holder's Response to the investigation into Employment and Training Opportunities for 19-25 Year Olds

The Scrutiny Support Officer reported that the final report of the Forum's investigation into Employment and Training Opportunities for 19-25 Year Olds was submitted to Cabinet at its meeting on 30 April 2012 together with a proposed action plan to implement the recommendations. Cabinet agreed all the recommendations and approved the proposed action plan and a copy of the action plan setting out the steps to be taken and the officers responsible was submitted as an appendix to the report.

The Economic Regeneration Manager gave the Forum an update in respect to

progress made on the implementation of the recommendations. It was highlighted that Hartlepool was the third worst area for youth unemployment and much of the work undertaken within the Economic Regeneration team was targeted at youth unemployment. This was an extremely difficult area as one of the town's major employers of young people had been the Garlands Call Centre.

Members highlighted the problems of tackling youth unemployment and a member indicated the council's work in this area was hindered when a recent new funding opportunity launched by the Big Lottery Fund aimed at Local Enterprise Partnerships (LEPs) to target youth unemployment appeared not to have included Hartlepool. It appeared that some funding had gone to Middlesbrough and Redcar and Cleveland. The issue had been raised with the lottery administrators but it appeared that the decisions made had been based on old data which was extremely concerning.

The Chair indicated that Hartlepool had a good track record of accessing pots of additional funding and it was extremely concerning that this one had been missed, particularly as it was aimed at reducing youth unemployment. It did appear that the fault did not lie with the authority but with the Big Lottery Fund and possibly the LEP.

The Chair questioned the implementation of the recommendations set out in the action plan and in particular the work on the Avanta programme with the Department of Work and Pensions (DWP). The Economic Regeneration Manager reported that the main providers were committed to regular liaison meetings. There was concern that some of the implementation was based on national models and discussions were ongoing to ensure the programme met local requirements.

Members suggested that involving Avanta in a meeting with Members may be useful. Members indicated that they had not been made aware of a facility in the Headland for the unemployed being removed which provided free internet access to search and apply for jobs. Members commented that many of the problems related back to the removal of the Working Neighbourhoods Fund. While there had been some duplication of schemes through employment regeneration and adult education, greater integration between the two services was resolving these issues and directing people to the right resource.

Members requested that updates on the progress being made on the implementation of the recommendations be submitted throughout the year.

Recommended

7. The Role of the Regeneration and Planning Services Scrutiny Forum (Scrutiny Support Officer)

The Scrutiny Support Officer reported on the role and functions of the Regeneration and Planning Services Scrutiny Forum. The report outlined the role and function of the Scrutiny Coordinating Committee, the main functions of the five standing scrutiny forums of which Regeneration and Planning Services was one and the specific remit of this forum. The report also detailed the proposed dates of meetings in the 2012/13 Municipal Year.

Recommended

8. Regeneration and Planning Services Scrutiny Forum – Work Programme for 2012/13 (Scrutiny Support Officer)

The Scrutiny Support Officer reported that at the meeting of Scrutiny Coordinating Committee on 15 June 2012 (to which all Members of the Regeneration and Planning Scrutiny Forum were invited), Members were asked to consider potential topics for inclusion in the Regeneration and Planning Services Scrutiny Forum's work programme for the 2012/13 Municipal Year.

The Scrutiny Coordinating Committee delegated responsibility to the Chairs of the Scrutiny Forums to finalise Work Programmes for their respective Forums, identifying specific elements of the Joint Strategic Needs Assessment (JSNA) and budget / collaboration programme. The Chair of the Regeneration and Planning Services Scrutiny Forum agreed that the Forum would focus on the following items for the 2012/13 Municipal Year:-

JSNA Work Programme Item – (i) Employment

Budget and Policy Framework Items

- (i) Corporate and Departmental Plans 2013/14
- (ii) Budget Consultation
- (iii) Development Plan

Recommended

9. Scrutiny Investigation into Employment – Scoping Report (Scrutiny Support Officer)

The Scrutiny Support Officer referred to the previous report in relation to the Forum's work programme and outlined the overall aim and proposed terms of reference for the investigation into the Employment topic within the Joint Strategic Needs Assessment incorporating the Marmot principle to 'create fair employment and good work for all'.

In relation to the potential areas of enquiry and sources of evidence, Members commented that they would wish to include evidence from Tees Valley Unlimited and the Federation of Small Businesses and Catcote Business School. The proposed timetable for the investigation was agreed.

Recommended

That the aim, terms of reference, areas of enquiry and sources of evidence and the timetable for the review as set out in the report be agreed.

10. The Executive's Forward Plan (Scrutiny Support Officer)

The Scrutiny Support Officer submitted details of the key decisions set out within the most recent Executive Forward Plan (August to November 2012) that related to the Regeneration and Planning Services Scrutiny Forum.

Members commented that there were several issues within the Forward Plan that related to the Forum's remit in relation to housing and questioned how the forum would be involved in the development of those proposals, where appropriate. The Scrutiny Support Officer indicated that he would make enquiries with the department and report back to the Forum.

Recommended

That the report be noted.

11. Any Other Items which the Chairman Considers are Urgent

The Chair returned to the debate under minute no. 9 'Scrutiny Investigation into Employment – Scoping Report' to discuss further which bodies should be asked to provide evidence to the forum as part of the investigation. The Scrutiny Support Officer indicated that the Portfolio Holder was the Mayor and that the Mayor and the Member of Parliament would be contacted after this meeting to arrange their attendance at a future meeting. Members questioned what input could be sourced from the LEP. The Economic Regeneration Manager commented that the LEP fell under the management of TVU, so by having their input into the investigation Members would also be able to raise issues in relation to the LEP.

Members also discussed further the failure to gain financial support by means

of the Big Lottery Fund programme aimed at youth unemployment. Members were concerned that there had been a deliberate intervention to close Hartlepool out of the funding. The Economic Regeneration Manager stated that he did not believe that was the case and that a simple mistake had been made in using out of date data. Members also indicated that through the investigation the link between employment and health should be examined in some way and requested that the Director of Public Health be invited to explore this further as part of the evidence gathering.




