## Subject: FEES & CHARGES INCREASE 2013/14

#### 1. PURPOSE OF REPORT

1.1 To provide the Portfolio Holder with the annual review of fees and charges proposed for 2013/14 and provide commentary upon those pricing categories which are demonstrating a significant increase or change

#### 2. BACKGROUND

- 2.1 The Community Services division of the Department and that of Parks and Countryside within Regeneration and Neighbourhoods is heavily reliant upon earned income from a wide variety of fees and charges to maintain service levels and opportunities across the Borough. In total we have in excess of 700 separate fees and charges which are regularly reviewed and updated. These do not include the commercial prices charged at the cafeterias and the ticket prices at the theatre and events which are priced according to costs on an individual basis.
- 2.2 When dealing with relatively small fees, it can be appropriate to leave as existing then revise by a larger percentage every few years. In other instances, conscious decisions are made to leave fees as existing, or even reduce them to meet specific areas of disadvantage and encourage use. The fees and charges are generally increased by inflation and are rounded to the nearest 5p.
- 2.3 The purpose of this report is to seek Portfolio approval to the exceptions which have been identified. These have arisen as part of the current budget setting process and seek to redress specific areas where fees and charges have either been unable to keep pace with the cost of provision or have been benchmarked against regional and sub regional comparators to ensure Hartlepool pricing is not undervalued.

#### 3. AREAS FOR CONSIDERATION

3.1 The fees and charges proposals for 2013/14 reflect a combination of a difficult trading environment, the need to maintain market share and attraction of additional footfall. This applies equally across many of our sporting venues, cultural venues and facilities. I am pleased to say that many of our prices are actually frozen for the forthcoming year, where prices are increased it is in line with the 2.5% inflation trend and in a very small number of cases there are above inflation increases. These are simply due to rounding on small fees and charges or as a correction to certain anomalies.

#### 3.2 **Sports & Recreation:**

- A new charge is introduced at Brierton Sports Centre for the Olympus Suite hire. This is an expansion of capacity and will assist in greater on site activity and income.
- All Leisure Centre standard activity concessionary rates prices frozen. Wary of the impact of price increases and peoples ability to pay – this is a deliberate management action and marketing opportunity.
- All Leisure Centre standard club hire charges prices frozen. This is a deliberate action to offer support to clubs.
- Leisure Centre Fitness Room use, standard fitness class charges and Superpass charges for all users – prices frozen. Again a deliberate management proposal to maintain market share in a competitive market place.
- Grayfields 3G all prices frozen.
- MHLC Community Room Private Hire also frozen.
- Junior Leisure Card membership trying to get the charge back in line with other types of Active Cards. (Price was £5.25 in 2008/09). We had to remove the fee totally when free swimming was introduced.
- Cricket Net Hire at the Headland and Brierton unfortunately has to involve the use of the whole hall unlike at MHLC where being a 6 court hall, only a proportion is required, therefore the new price reflects the need to allocate the whole sports hall.
- Summerhill Kitchen hire and refreshment charges proposed to be removed. No longer appropriate due to the lease of a cafeteria service to a third party provider.
- Anything else above 2.5% is only due to a 5p increase on a relatively small charge and the effects of rounding

#### 3.3 Cultural & Information Services

At the Town Hall Theatre and Borough Hall, the set of charges are frozen to ensure that the venues continue to achieve market share and customer satisfaction.

A series of changes are also in development for the Hartlepool Maritime Experience to enable a much better marketing message to be achieved and with the aim of increasing footfall and income from

entry fees and from ancillary trading at the retail outlets and the cafeterias. The proposal is to freeze current prices, remove certain categories and make the entry charge message simpler and most importantly of all to introduce a 'multiple visit' ticket. This element is not included within the current fees and charges table as the detail has yet to be agreed with our partner the HMS 'Trincomalee Trust who are of course equally dependent upon admission income for the well being of the revenue budget. The developing pricing and marketing structure will be concluded shortly and will be agreed with the Portfolio Holder outwith this specific report.

Within Libraries & Community centres – the capacity for fee and charge income within Libraries is very limited indeed, however where rounding occurs this invariably gives % increases which appear large but clearly fall into the category of small amounts and only occasional increase.

The increases within Community Centre charging are all kept within 2.5%.

3.4 **Tees Archaeology** – a series of new charges have been introduced for Tees Archaeology which reflects the need to become much more commercial in outlook in response to changing funding circumstances. The range of fees recommended is based on comparative fees and charges elsewhere within the archaeological and planning consultative profession.

#### 5. FINANCIAL IMPLICATIONS

- 5.1 The proposed range of fees & charges changes is done in the knowledge that either the 'market' will bear such increases or more importantly the level of increase has been assessed and bench marked against our local competitors or neighbouring local authorities. Invariably Hartlepool continues to have some of the lowest pricing in exchange for the services provided and we have to be careful that we guard against low income generation which will only serve to reduce the value of the service and generally mean the service 'nett cost' becomes more expensive and potentially unsustainable.
- 5.2 This in itself creates a budgetary pressure and this is magnified by the challenges that the current budget reductions are creating in seeking to maintain good services across the full range of cultural

and leisure facilities that the Borough Council provides. For this reason, if no other, it always better to look at the actual pricing being proposed, rather than the illusory and often misleading headline that a simple percentage rise can give.

#### 6. CONCLUSIONS

- 6.1 The annual review of prices has resulted in a range of pricing changes, the overriding factor being either a price freeze or increases in line with inflation only. The fees nevertheless are structured to allow for a wide range of concessions and beneficial pricing for those who take advantage of concessionary cards, active cards etc.
- 6.2 It is important to reflect upon the fact that these charges will still ensure that Hartlepool rates remain very competitive when compared to regional and sub regional comparators and help to maintain investment and income levels to continue to provide good cultural and sporting facilities.

#### 7. **RECOMMENDATIONS**

7.1 The Portfolio Holder is recommended to:

(i) Approve the revised schedule of fee and charge increases for 2013/14.

Subject: INSPIRE

#### 1. TYPE OF DECISION/APPLICABLE CATEGORY

Non key decision.

#### 2. PURPOSE OF REPORT

- 2.1 The purpose of the report is to inform the Portfolio Holder about our intention to put in a grant application to The Big Lottery Reaching Communities England in respect of the Inspire project a joint project between the Culture & Information and Youth Services sections of Hartlepool Borough Council.
- 2.2 Also endorsement for the young people to lead a bid to the Young Roots strand of Heritage Lottery in relation to the 100<sup>th</sup> anniversary of the beginning of World War I.

#### 3. BACKGROUND

- 3.1 The overarching theme of the joint strategy will be to expand the INSPIRE brand used by the sport and physical activity team into a wider jointly delivered programme that challenges young people's aspirations to break out of the vicious cycle that some young people find themselves within whether due to family circumstance, poverty or stereotyping.
- 3.2 Community services and the Youth Work team have traditionally developed joint working arrangements for specific pieces of work. This has been successful over a number of years with projects such as emerge, and the development of the skate park at Rossmere Youth Centre etc. There has been an acknowledgment that both sections have a lot to contribute in relation to improving the skills and life chances of young people in Hartlepool, while addressing the underlying causes of many issues that prove a barrier in relation to a successful transition to adulthood and there is strength in sharing skills and resources to take this forward. In that spirit

work has begun to develop a joint working/funding strategy to take this work forward.

- 3.3 The rationale for the model came from the view point of making an impact on global issues facing young people in order to develop a greater resilience to the effects of them. The early intervention strategy will be in place to provide services to some of the most vulnerable young people within the most deprived localities within Hartlepool whilst offering coverage for the town in relation to identified issues. As assessment will be a key component in the strategy and the identification of issues on an individual basis will be key. This strategy seeks to compliment work within the early intervention strategy by offering a response on a universal level to address some of the broader issues affecting young people within the town. Young people will be able to choose to take part in the offer via self referral or by referral by professionals working in universal, targeted or specialist services and offers an alternative and complimentary approach.
- 3.4 Young people have informed the development of this joint working from the beginning. In total 180 young people have been consulted, 132 have attended events and activities, and a core group of 14 have formed a representative group (Arts4Tees) to develop funding, to consult more widely and to organise events.

#### 4. PROPOSALS

- 4.1 Projects would be based over a three year period to ensure that they can be fully evaluated and give evidence of ability to create change.
- 4.2 Music Project in conjunction with Tees Valley Music.
- 4.3 Identity Arts Books & Mail Art Project with international elements based in Germany, Daytona Beach Florida USA, Melbourne Australia.
- 4.4 Inspiring Hope Photographic project working with young women in Hartlepool and using the Veiled Rebellion exhibition by Lynsey Addario about women in Afghanistan.
- 4.5 Love Books, Love Film project centred at Town Hall Theatre encouraging literacy by using the connection between books and the films they inspire. This has been successfully piloted by the young people through a Grant Givers Bid, 126 young people between the ages 13-19 attended.
- 4.6 World War I project with European collaboration element with artists Gavin Mayhew and Dieter Loechle.

Developing projects:

- 4.7 Sports project building on the Inspire project with young women but targeting young men.
- 4.8 Stars in your mind looking at raising the aspiration levels in young women.
- 4.9 Junior emerge expanding the 'emerge' brand and creating a space for younger emerging artists.
- 4.10 Painting a brighter future, a project designed to embed art and creative activity into all Hartlepool's Youth Centres.

#### 5. FINANCIAL IMPLICATIONS

- 5.1 An outline proposal is being prepared for Reaching Communities England for submission in January 2013. The total amount requested is £308,686.
- 5.2 An outline proposal for Young Roots is being developed with the young people's representative group to look at a bid in relation to World War I. This bid is currently in the region of £40,000.

#### 6. **RECOMMENDATIONS**

6.1 It is recommended that the Portfolio Holder endorses the project.

#### 7. REASONS FOR RECOMMENDATIONS

7.1 It is an opportunity for a sustained period of work between two sections that will improve the life chances of young people in Hartlepool via a number of high quality experiences.

Subject: SHORT BREAKS (PREVIOUSLY AIMING HIGH FOR DISABLED CHILDREN) CAPITAL FUNDING

#### 1. TYPE OF DECISION/APPLICABLE CATEGORY

Non key

#### 2. PURPOSE OF REPORT

2.1 To seek approval for Short Breaks Capital Funding to be spent on redesigning space at Exmoor Grove to provide a private area for children permanently living there. In addition to support refurbishment of Stockton Road Children's Home to ensure it meets Disability Discrimination Act requirements.

#### 3. BACKGROUND

- 3.1 The Government published *Aiming High for Disabled Children* in 2007. It is a transformation programme for disabled children's services in England. The document sets out the vision for the programme and the key improvements that Government wants to see in services and support for disabled children and their families.
- 3.2 Aiming High for Disabled Children is now known as Short Breaks. The vision behind Short Breaks is for all families with disabled children to have the support they need to live ordinary family lives. Capital funding has been allocated as part of this programme.
- 3.3 The total funding available is £64,970. It is proposed to allocate £31,100 to Exmoor Grove and £33,870 to Stockton Road Children's Home.

#### 4. PROPOSALS

#### 4.1 Exmoor Grove

One young person is currently living at Exmoor Grove and it is felt that the accommodation does not provide adequate private space for this young person. It is proposed that £25,000 is spent making internal alterations and adding a small external extension. This will include removal of internal wall (current bathroom) to create a larger living space, conversion of office space into bedroom and locating the wet room into the new extension to be built at the end of the building adjoining the bedroom. The quote includes all building works, bathroom fixtures, flooring, tiling and painting. This will provide the young person with discreet personal living space to reflect his different care arrangements, supporting his identity, and the continuity and stability of the placement. In addition it will ensure any disruption caused by the short term nature of the placement for the other children are kept to a minimum

In addition staff have requested changes to the internal structure to develop a safe place. This is to support staff when caring for a child with particularly challenging behaviour. The purpose of the Safe Space is to provide a child friendly, robust, safe environment where a child can spend time playing, sleeping or simply calming down if in crisis. The service is currently offering regular respite to a young person with autism and significant challenging behaviour which includes a tendency to self harm by head banging walls and floors. A safe space would make a huge difference to both the young person and the staff team. The cost of the safe space is £6,100.

4.2 Stockton Road Children's Home

The remaining capital funding is to be used to ensure that Stockton Road Children's Home meets Disability Discrimination Act requirements. This will ensure that any child, young person or adult with disabilities will be able to access the building. It is proposed that the Short Breaks Capital funding will contribute approx £33,870 to the refurbishment of Stockton Road.

#### 5. FINANCIAL CONSIDERATIONS

5.1 The funding for the above renovations is to be funded through the Short Breaks Capital Funding.

#### 6. **RECOMMENDATIONS**

- 6.1 For the Portfolio to approve the spend of the Short Breaks Capital Funding
  - £31,100 for Exmoor Grove
  - £33,870 for Stockton Road Children's Home

#### 7. REASONS FOR RECOMMENDATIONS

7.1 To ensure that children and young people are able to access appropriate provision in an appropriate environment.

#### Subject: SPORT AND PHYSICAL ACTIVITY TEAM – SIX MONTH PROGRESS REPORT

#### 1. TYPE OF DECISION/APPLICABLE CATEGORY

Non-key.

#### 2. PURPOSE OF REPORT

2.1 The purpose of this report is to inform and update the Portfolio Holder on the work of the Sport and Physical Activity Team which is part of the Council's Sport and Recreation Service. This area of work includes Summerhill Outdoor Activity Centre and Country Park, the Outdoor Activities Service, GP Referral Programme, Learn to Swim Programme (including Primary School lessons) and all targeted work aimed at increasing participation in Sport and Physical Activity.

#### 3. BACKGROUND

- 3.1 The aim of the Sport and Physical Activity Team is to increase participation in sport and physical activity within Hartlepool, encouraging people to "Get Active, Stay Active and Feel Good in Hartlepool".
- 3.2 The Department of Health continues to recommend that adults (16+) should aim to achieve at least 30 minutes of moderate intensity activity on at least 5 days of each week. Engaging more people in sport and physical activity in order to improve health and wellbeing is therefore a key priority at national, regional and local level and given the health inequalities in Hartlepool, remains an important issue for the Council to be addressed.
- 3.3 A previous update on the work of the Team was given as part of a report to the Portfolio Holder on August 14<sup>th</sup> 2012 and this report now covers the period from April 2012 to the end of September 2012.



#### 4. TEAM ACHIEVEMENTS April 2012 – September 2012

4.1 The following highlights some of the work programmes and key achievements of the Team over the six month period of April 2012 to September 2012.

#### 4.2 Learn to Swim Programme

- Nine Primary Schools use Hartlepool Borough Council's service and some schools send two classes together.
- From April to July 2012, 679 pupils accessed the schools Learn to Swim programme from Years 3 to 6, with 66% achieving the 25m standard.

#### 4.3 Summerhill

- This year, the protected Great Crested Newt was discovered in two of the wetland areas at Summerhill. As a result a full site survey was conducted in conjunction with the Borough's Ecologist which has led to Summerhill being designated as a Local Wildlife Site.
- Summerhill will host the North East Cross-Country championships for the third time. It will be organised in conjunction with Bum Road Harriers Running Club on Saturday 8<sup>th</sup> December and is expected to attract more than 500 participants.
- A substantial amount of work was undertaken over 2012 with the North East BMX club in order to fully redevelop the BMX track at Summerhill. As a result of this work funding was successfully secured from BIFFA landfill tax credits and the resulting new track has 4 straights instead of 6 and 3 turns (or berms) with a tarmac surface. Although having less straights than the previous course, it is still one of the longest in the country and capable of hosting major BMX competitions.
- Following the successful grant bid to the Short Breaks Grant Fund, four new play items were installed in the Junior Play Area. The items are specially designed to be all inclusive especially to those with physical and learning disabilities.
- Opportunities for volunteer work have continued to be offered at Summerhill primarily concerning environmental and conservation management.
- A new cafeteria service was opened at Summerhill in June as a result of a lease arrangement to a third party operator. The service is not only providing catering for events and meetings but also provides catering courses such as cupcake decorating to the public.

#### 4.4 GP Referral Scheme- (Hartlepool Exercise for Life Programme)(HELP)

- The Exercise for Life/GP Referral Scheme continues to offer specialist supervised 10 week introductory courses of exercise to support residents to lead a healthier lifestyle.
- The UHH Physiotherapy Dept continues to be the most prolific referring agent with 123 patients in this period. The HELP scheme has also extended support to patients from the Neurological Physiotherapy Team with Parkinson's, Multiple Sclerosis and Stroke patients now attending the scheme at a specialist support session, developed in partnership with the hospital services. It is held weekly at the Mill House Leisure Centre.
- Improved working partnership with NHS Health Trainers has resulted in a marked increase of 47 clients in this period, compared to only 7 in the previous six months. Target area has been Weight Management referrals.
- All Hartlepool GP Surgeries use the service and referrals have increased in this six month period from 363 (Oct – March) to 401 (April to September 12).
- Analysis of this data reveals an accrued retention rate to regular exercise of 81% based on the responses to the postal questionnaire. This is an accrued figure which clearly demonstrates that the Exercise for Life scheme supports long term life style changes to improve the health and well being of residents.
- The Exercise for Life Programme has been successful in obtaining • financial support from the NHS to implement a new strand of delivery. This twelve month pilot for Type 2 Diabetes prevention is directed at those patients who have been identified as at high risk of developing diabetes. The project includes lifestyle intervention of both increased physical activity and dietary support in line with current NICE Guidelines. Gladstone House Surgery Clinical Team agreed to provide the first group of patients to access the E.D.A.N. Project - "Escape Diabetes act Now" and this project has been met with approval from the Diabetes LIT Committee.

#### 4.5 **Outdoor Activities Team**

- The Outdoor Activities team has recently obtained the Cytech Level 3 • Qualification (the industry standard for advanced bike technicians). With two qualified level three bike mechanics based at Summerhill, the Cycle Clinic is now in a position to service forks and other suspension platforms.
- Since the Cycle Clinic was established in February 2012, in excess of 1200 people have utilised the service (many of whom have passed through Summerhill exposing the site to the wider public). This figure is made up of course participants and bike servicing. The team has also secured a contract to service the fleet of police bikes within the town, a service previously provided elsewhere. The Police will also be taking

part in training courses which will be aimed at improving their riding technique. Furthermore Darlington Borough Council are also utilising the service for their bike fleets.

- The cycle hub/clinic at Summerhill has also enabled the team to offer maintenance courses for the general public. A total of 28 hours of maintenance sessions have already occurred with 21 participants.
- As part of the Small Awards Grant Award from Sport England, a large marquee has been purchased, which the team has used as a servicing base whilst attending large scale cycle festivals/events. To date three large events have been attended by the team; one with Darlington Borough Council (South Park) and two with Durham County Council (Newton Aycliffe and Bishop Auckland). These events will not only allow the team to generate further income but it will also attract wider publicity for the programme and expose Summerhill to a wider audience.

#### 4.6 **Core Sport and Physical Activity Team**

#### • Walk About in Hartlepool

- The scheme continues to expand and participation numbers have increased to 352. This is an additional 90 participants taking part in the scheme since March 2012.
- Since March 2012, the Sport and Physical Activity Team has delivered five Volunteer Walk Leader Courses training 37 volunteers / members of various organisations. The Walk about in Hartlepool Scheme now has 105 volunteers actively leading walks, with many of these volunteers specifically leading walks for various organisations.

#### • Ready Steady Walk (RSW)

 The RSW scheme has seen a throughput of 2981 participants since April 2012 from across all participating schools. Total miles walked by the schools in the period April 2012 – September 2012 is 14,658 miles making the total miles walked for this project an excellent 46,170 miles. The programme is now being refocused to work towards Rio Olympics 2016 and also linking into the British Heart Foundation; Younger and Wiser Programme.

#### • Orienteering

• The Sport and Physical Activity Team secured £3,605 of Community Activities Network funding to deliver an Orienteering Programme in Hartlepool. The funding was to support individuals to be trained to deliver Orienteering across the town and to put on various programmes and tasters to engage people into the sport of Orienteering.

#### • The Together Project

- The Together project was developed to support those in recovery or rehabilitation from Breast Cancer and its aim is to improve recovery and fundamental skills through low level activity programme. The project expanded its remit slightly in June 2011 and it aimed to support a broader range of participants who had various forms of cancer, MS, COPD and other long term and limiting illnesses.
- The Together Project continues to support participants most in need of physical activity support within their own environment. Sessions have been held in Hartfield's, Major Cooper Court, Laurel Gardens, Anchor Court and Lynton Court. The programme requires further development and investment to progress and this is currently being explored through external funding applications.
- Within the past six months the programme has engaged over 70 individuals who typically do not participate in any physical activity.

#### Begin to Programme

- The Begin to Programme seeks to address via introductory level activities, the low participation levels of sport and physical activity within the town, encouraging those who are active to do a little bit more and those that are sedentary to begin to be active.
- The programme has engaged over 200 participants during the last month period and will continue to expand.

#### • Street League Football

• Street League restarted in September 2012 for the new season. There are between 95-105 children and young people attending on a Friday evening between 6pm and 9pm aged between 8 years old and 18 years old. The League that runs at Grayfields Recreation Ground has an under 8's coaching session and also a 3 a side Futsal League that supports young people to take part with their friends.

#### • Disability Sport

- The Sport and Physical Activity Team lead on the Disability Steering Group in Hartlepool and look to develop and support disability sport in the town. The group has continued to identify gaps in provision for disabled participants and aim to develop these areas as a priority.
- £300 was secured from the Tees Valley Community Games to deliver a Disability Community Games event on 15<sup>th</sup> August 2012. This was at Brierton Sports Centre and encouraged disabled adults to participate in two Olympic Sports Wheelchair Basketball and Table Tennis as well as Bowls.
- Football coaching has been delivered to young people with disabilities every Saturday morning in partnership with Families First and Aiming

Higher. The session attracts an average of 12 participants who have developed their fundamentals skills, interpersonal skills, behaviour and also football skills through this programme.

#### • Limestone Landscapes

- Heritage Lottery Funding of over £1 million has been secured to develop the Limestone Landscape that dominant a large percentage of the North East Coast. As an element of this programme, there is over £300,000 of funding to develop the landscape for Green Exercise and Hartlepool is fortunate to have the opportunity to access some of this funding.
- As part of this, Hartlepool Big Lime Walk was delivered and attracted 40 participants. The walk explored some of the Limestone Environment within Hartlepool and it showed many individuals areas of the Borough that they had never seen before.
- Hartlepool has also secured funding and status to host the Big Lime Triathlon Event on 6<sup>th</sup> July 2013. In conjunction with this, funding has been committed to develop Triathlon generally in Hartlepool specifically focusing on the novice/recreational competitions and training.

# • Club Development, Action Groups, and National Governing Bodies NGB's) of Sport

- Tees and Hartlepool Yacht Club and Hartlepool Sport and Physical Activity Team have worked closely to create an Olympic Legacy for Hartlepool associated with this sport. A Family Open Day attracted 65 new people visiting the club and participating in activity, the Cadets have increased in membership by approximately 40% and 11 adults have qualified in Level One Dinghy Sailing supporting them to be competent to sail independently. The club also participated in a National Event 'Push the Boat Out' which launched the start of the Olympics and supported over 20 boats onto the water.
- Brierton Sports Centre has been made a target site for the Badminton 'No Strings' Franchise.
- The Tennis Action Group has been supported to submit a bid for £5,000 targeting junior development specifically in Hartlepool.
- Programmes have been delivered pre and post Olympics for Hockey. Hartlepool Caledonian's Hockey Club has seen an increase in their membership by 30 since the Olympic Games.
- The Gymnastics Development Group is ready to launch and has been pending restructure within British Gymnastics.
- A Cycling Development Network is to be established incorporating all levels and disciplines of cycling.
- Hartlepool Indoor Bowls Club has increased participation and membership by 20 people via various methods.
- The Sport and Physical Activity Team sit on the HDCDG (Hartlepool District Cricket Development Group) to support and develop cricket within the town.

- Hartlepool Volleyball Club has been supported to apply for external funding and they have just had their one year anniversary where a new and more sustainable committee was formed.
- Supported a relationship with High Tunstall School and Burn Road Harriers which has resulted in relocation for the club and a base that they can use.

#### • School Coaching/Engagement

- Supporting schools with coaching provision continues with coaches being deployed into school environments to support planning, preparation and assessment time (PPA), after school clubs and other activities.
- Secondary School engagement has increased significantly especially due to the withdrawal of the School Sports Partnership. Support is being offered in the format of funding, coaching and development of new activities that schools do not have the skills to deliver. An excellent example of this has been Orienteering, Handball and Volleyball. Support continues and developments are happening around the Leadership Academy, Gifted and Talented Programme and School Games.

#### • British Heart Foundation – Younger and Wiser

- Hartlepool Sport and Physical Activity Team are the selected physical activity provider for this programme. There has been support offered to all schools specifically focusing on Heart Health relating to Physical Activity. £1400 has been secured from the Harty Lives project in partnership with the Outdoor Activities Team to deliver a Cycle Tots Programme which will increase more sustainable participation from a young age.
- £75,000 has been secured from NHS Hartlepool for a three year family intervention programme for children and their families who are overweight and obese. This is following concern for children identified in the National Child Measurement Programme and others that would benefit from additional one to one support to access support and information for a healthy lifestyle.

#### • Sportivate

• Sportivate is a Sport England initiative, coordinated on behalf of Sport England by the Tees Valley County Sports Partnership and is aimed at encouraging more people aged 14 to 25 years to take part in sport and physical activity. Over £16,000 was secured for Year 2 which is currently in its 3<sup>rd</sup> quarter of delivery. A number of programmes have been delivered totalling over 120 participants.

#### • Coach and Volunteer Development

• Hartlepool Sport and Physical Activity Team has developed a Coach, Leader and Volunteer Development Group to drive forward a coordinated approach to supporting managers or coaches, leaders and volunteers and also the coaches, leaders and volunteers themselves. There are four key aspects to the guidance which are recruitment, induction, development and retention and it gives practical examples and supporting resources to strengthen provision for all organisations.

#### • Leisure Centre Developments:

- Brierton Sports Centre has been supported significantly to establish new sessions to utilise their quieter periods during the day. This has been part of the continuing redevelopment of the site since its refocus from being a dual use school site to a fully operating public leisure centre. There has been an increase in delivery for juniors within the site and also adult programmes such as Bootcamps, Begin to Badminton and Box Fit which have all gone extremely well.
- Mill House Leisure Centre and the Sport and Physical Activity Team have worked closely not only on delivery of activities but programming to utilise the pool, studio and sports hall. Yoga and Aqua Jog have been extremely popular and we are exploring opportunities to meet this continued demand in the future.

#### 5. SUMMARY

- 5.1 This report highlights the key areas of work and progress made over the last six months. It is by no means exhaustive but gives the Portfolio Holder an indication of the range of projects and initiatives which the Sport and Physical Activity work on.
- 5.2 The service continues to seek out opportunities and new partnerships in order to provide innovative physical activity activities in Hartlepool. This is of vital importance as a contributory factor towards the improved health and wellbeing agenda of all residents and an integral component of the Public Health agenda.
