44. Apologies for Absence

Apologies for absence were submitted on behalf of Councillors Shields and Wilcox.

45. Declarations of interest by Members

46. Minutes of the meeting held on 5 November 2012

47. Matters Arising from the Minutes

In relation to Minute 41 relating to the initial budget consultation proposals and in response to the Chair's request for clarification, the Assistant Director advised that the reasons for the proposed closure of Headland Sports Centre at weekends was due to low usage. Cabinet Members had recently been informally briefed on this issue and it had been agreed that Ward Members be consulted in this regard.

51. Scrutiny Investigation into Older People - Covering Report/Presentation (Scrutiny Support Officer/Representatives from the Council's Adult Social Care Service and NHS Tees)

As part of the Forum's investigation into the JSNA topic of 'Older People' representatives from Adult Social Care and NHS Tees had been invited to attend the meeting to provide evidence in relation to the investigation.

The Head of Service, Strategic Commissioning, provided a detailed and comprehensive presentation in relation to the projected level of need/service use focussing on what needs might be unmet and included the following issues:-

Future level of needs

- Number of older people in Hartlepool currently estimated at 15,700 but expected to rise to 22,300 by 2030 (42% increase)
- Sharpest rise expected in 85 plus group from 1,900 to 3,300 (75% increase)

- High levels of deprivation and ill health, number of people with life limiting long term illness predicted to rise from 8,541 to 12,515 by 2030 (46% increase)
- Number of people with a diagnosed dementia projected to rise by 60% before 2030
- Numbers of informal carers likely to reduce over coming years leading to greater reliance on health and social care services
- Increasing number of older home owners on low income unable to repair, maintain or adapt their homes as needs change
 - link to increase in risk of falls
 - greater demand for Disabled Facilities Grants

What needs might be unmet

- Number of people who fund own care and support without contact with local authority
- Of 8,541 people estimated to have a limiting long-term illness (2011 figures) only 2,881 were supported by the local authority
- Unreported fallers who could benefit from advice or treatment
- Early intervention and prevention services for those in early stages of dementia

The Chair welcomed representatives from NHS Tees to the meeting.

The Commissioning Manager from NHS Tees referred to the NHS priorities in relation to older people from a health care perspective which included provision of more accessible information for patients, better access to services, early intervention measures, early diagnosis of long term illnesses and the introduction of management plans with a view to improving quality of life. It was noted that health inequalities were prevalent across the town, details of which were provided.

Dr Posmyk, GP and Chair of the Clinical Commissioning Group for Hartlepool, who was also in attendance at the meeting representing NHS Tees advised that whilst it was difficult to predict the projected level of future need there were a number of measures in place to achieve better health outcomes for the people of Hartlepool. These included early intervention measures such as healthy heart screening and support with lifestyle changes. In terms of life expectancy changes and health behaviour, it was difficult to determine future health pressures and links between any increase in life expectancy rates and more dependent health conditions. However, the aim was not only to increase life expectancy but to provide as much early care and support as possible to enable better health outcomes, quality of life improvements and reduce more radical intervention in the future. Reference was made to current budget

constraints and the impact on future health provision.

In the discussion that followed, a number of issues were raised which included:-

- (i) In response to a request for clarification regarding levels of reablement, it was reported that there were a range of services available. In terms of short term input from the Council's reablement team, early performance measures indicated that, 75% of people receiving this support achieved the outcomes identified at the beginning of the process. The aim was to provide support to anyone who may benefit from low level support and early intervention.
- (ii) A Member of the public raised the issue of universal credit and was advised that it was difficult to determine the full impact of the incremental rise in the number of elderly people affected and work was currently ongoing to identify projections in this regard. However, it was anticipated this would include an increase in homelessness, as well as further pressures on health and social care.
- In terms of addressing needs of older people, a Member (iii) importance ensuring emphasised the of reporting communication arrangements were in place for information to feed into the Health and Wellbeing Board from Sub-Groups like the old peoples group. The importance of clear communication links between the Health and Wellbeing Board and CCG was also emphasised as well as the need to avoid duplication of information feeding into the Health and Wellbeing Board. The Assistant Director outlined the Sub-Groups that were currently in place and advised that work had already commenced with a view to consolidating some groups. When the shadow arrangements ceased and transferred to a more formal arrangement in April it was envisaged that the relationship between the various groups would be clearer.
- (iv) Reference was made to the potential increased dependence on crisis level support and the importance of improving communication methods to alleviate this problem. In response, the representative advised that NHS Tees worked dosely with public health and the north eastern observatory to facilitate a more strategic planning approach to day to day health care needs.
- (v) In response to a query raised in relation to the number of patients suffering with dementia who were undiagnosed, the Commissioning Manager advised that whilst it was estimated that 30% of patients received an accurate and timely diagnosis. It was highlighted that the level of awareness and screening had increased.

- (vi) A Member referred to the benefits of raising awareness in relation to dementia conditions and sought clarification on the impact of ongoing budget cuts on services of this type. Members were advised of the arrangements in place to minimise the impact of reductions in funding as well as the aims and priorities of the service.
- (vii) Some concern was raised in relation to the 6 month waiting time for disabled facilities grants to which the Head of Service provided assurances that work was prioritised based on level of need and temporary adjustments could be made pending completion of disabled facility grant works.
- (viii) Further concerns were expressed in relation to the impact of budget cuts on the level and type of support available to vulnerable people living at home with the early onset of dementia who may be better supported in residential care. The representative from NHS Tees referred to the importance of resources being targeted appropriately to ensure there were no assumptions of need. The Assistant Director outlined the assessment process including the eligibility criteria from a social care perspective emphasising that the assessment process might change but eligibility criteria would not.

The Chair thanked the representatives for their attendance and valid contribution to the investigation.

Recommended

That the information given be noted and the comments of the Forum and evidence provided be used to assist with the scrutiny investigation.

52. Hartlepool Safeguarding Adults Board Statistics and Progress Report – Covering Report/Update 1 April 2012 – 30 September 2012 (Scrutiny Support Officer/Assistant Director for Adult Social Care)

As part of the Forum's investigation into Adult Safeguarding, Members recommended that the Forum be kept up to date on Adult Safeguarding issues in the town through the receipt of relevant aspects of the regular updates received by the Portfolio Holder for Adult and Public Health Services.

The Assistant Director, Adult Social Care presented the report which had been received by the Portfolio Holder in October 2012 and provided information on the Safeguarding Adults Board statistics and progress for the period 1 April to 30 September 2012.

It was highlighted that during the reporting period there had been 258 alerts identifying possible cases of abuse or neglect, 137 of which led to referrals

requiring further investigation and action specifically under safeguarding adult procedures. In comparison with the same reporting period the previous year the total number of safeguarding alerts received in 2012/13 had increased by 34%.

In terms of the type of abuse, care homes continued to be the most common location of reported abuse with neglect being the most frequent identified cause, followed by physical abuse, details of which were provided.

In relation to Deprivation of Liberty Safeguards (DoLS), total activity for 2012/13 was 83 and not 85 as indicated in the report. It was noted that there had been a slight decrease in the figures for the previous year. Members were provided with an update on work currently being undertaken by the Hartlepool Safeguarding Adult Board, details of which were included in the report.

In response to concerns regarding the potential implications of the proposed reduction of funding from the formula grant, the impact of responsibilities for the Deprivation of Liberty Safeguards and training implications of the pending transfer of responsibilities from the PCT to the Council, the Assistant Director provided details of previous funding arrangements as well as details of proposals relating to the transfer of responsibilities to the Council, the financial implications and benefits of which were debated.

A Member referred to evidence which suggested that environmental improvements reduced anxiety in dementia sufferers and queried what work had been done with Tees, Esk and Wear Valley NHS Foundation Trust in this regard. The Head of Service commented on a recent piece of work that had been done with NHS innovation funding, as part of reablement with a number of nursing homes which had revealed that encouraging sufferers to take up additional activities reduced the need for antipsychotic drugs and improved engagement. Tees Esk and Wear Valley NHS Foundation Trust had recently appointed a specialist member of staff to work with individuals and provide staff training and improve support mechanisms with a view to improving quality of life.

In response to a request for clarification, the Assistant Director outlined the recruitment and appointment process for the appointment of the Independent Chair to the Hartlepool Safeguarding and Adult Board and confirmed that she was currently undertaking the chairing role, with a review of the arrangements planned in 2013.

Subject: PROPOSALS FOR INCLUSION IN COUNCIL PLAN

2013/14

1. PURPOSE OF REPORT

1.1 To provide the opportunity for the Adult and Community Services Scrutiny Forum to consider the proposals for inclusion in the 2013/14 Council Plan that fall under the remit of the Committee.

2. BACKGROUND

- 2.1 For 2013/14 a review of the Outcome Framework has been undertaken to ensure that it still accurately reflects the key outcomes that the Council and Partners have identified as being important for the future of the Borough. A revised Outcome Framework, to be implemented from April 2013, was reported to Scrutiny Coordinating Committee on 19 October 2012 and Cabinet on 29 October 2012.
- As in previous years detailed proposals are being considered by each of the Scrutiny Forums in January. A further report will be prepared for Scrutiny Coordinating Committee on 18 January 2013 detailing the comments/observations of each of the Scrutiny Forums to enable a joint response to be prepared for Cabinet.
- 2.3 As discussed at the Scrutiny Coordinating Committee on 19 October 2012, from 2013/14 the three Departmental Plans will be brought together to form the Council Plan which will set out collectively how the key priorities/outcomes that the Council have identified will be delivered. This is a different approach to previous years and therefore there will be no separate Corporate Plan. This will eliminate the unnecessary duplication and reporting of actions that was an unintended consequence of drawing the old Corporate Plan actions and indicators from the three Departmental Plans, without losing the focus that having separate Departmental Plans brings to the overall process.

2.4 The Council Plan is still a working document and as such there are areas where information could change. Where this does occur the information will be included in the final draft of the Plan that is to be considered by Scrutiny Coordinating Committee on 8 March 2013, by Cabinet on 18 March 2013 and by Council on 11 April 2013.

3. PROPOSALS

- 3.1 The Assistant Directors for Adult Social Care and Community Services will deliver a short presentation at the meeting detailing the key challenges that the Council faces over the next year, and beyond, and setting out proposals, from the Child and Adult Services Departmental Plan, for how these will be addressed.
- 3.2 The main focus of the presentation will be on the outcomes that have been included in the Outcome Framework and how these will be delivered in 2013/14. The Assistant Directors will take each outcome in turn, explaining how each outcome will address the challenges faced by the Council. After each outcome Members will be given the opportunity to comment on the proposals before the presentation move onto the next outcome.
- 3.3 The Outcomes that fall under the remit of the Adult and Community Services Scrutiny Forum, and will therefore be included in the presentation are: -
 - Outcome 8: Provision of high quality community learning and skills opportunities that widen participation and build social justice;
 - Outcome 9. Improve health by reducing inequalities and improving access to services:
 - Outcome 12. Vulnerable adults are supported and safeguarded and people are able to maintain maximum independence while exercising choice and control about how their outcomes are achieved:
 - Outcome 14. There is reduced harm caused by drugs and alcohol misuse;
 - Outcome 24. People enjoy equal access to leisure, culture, sport, libraries which enrich their lives, improve the places where they live, and strengthen communities;
- Appendix A provides detail on the proposed actions identified to deliver the outcomes that fall under the remit of the Adult and Community Services Scrutiny Forum. Officers from across the Council have also been identifying the Performance Indicators (PIs) that will be monitored throughout the year to measure progress and these are also included in the appendix. The identified risks are also included for information.
- 3.5 As in 2012/13, it is not possible at this stage to include year end outturn and future targets as these are not yet available. It is normal practice to use a number of criteria when setting targets, such as current performance, budget information and other external factors such as Government policy changes.

Therefore it is normal for targets to be set around year end when more information is known. Where available, this information will be included in the proposals reported to Scrutiny Coordinating Committee in March 2013.

4. NEXT STEPS

- 4.1 The remainder of the Council Plan proposals have already been, or will be, discussed at the relevant Scrutiny Forums between 4 January and 17 January 2013. Comments and observations from those Scrutiny Forums will be added to those received at today's meeting and included in the overall presentation to Scrutiny Coordinating Committee on 18 January 2013. Due to the short length of time between the Scrutiny Forums and the Scrutiny Coordinating Committee meeting on the 18th January it will not be possible to provide a detailed response to the comments and observations made at the Scrutiny Forums at the SCC meeting.
- 4.2 The final draft of the Council Plan, which will have considered the points raised by Scrutiny, will then be considered by Scrutiny Coordinating Committee on 8 March 2013 and Cabinet on 18 March 2013 before being taken for formal agreement by Council at its meeting on 11 April 2013.
- 4.3 Progress towards achieving the actions and targets included in the Council Plan will be monitored throughout 2013/14 by officers across the Council and progress reported quarterly to Elected Members.

5. **RECOMMENDATIONS**

- 5.1 It is recommended that the Adult and Community Services Scrutiny Forum: -
 - considers the proposed outcome templates (Appendix A) for inclusion in the 2013/14 Council Plan;
 - formulates any comments and observations to be included in the overall presentation to the meeting of the Scrutiny Coordinating Committee on 18 January 2013.
