48. Scrutiny Investigation into the JSNA Topic of Environment – Climate Change – Covering Report/One Planet Living Presentation (Scrutiny Support

Officer/Representatives from Middlesbrough Council)

As part of the Forum's investigation into the JSNA topic of Environment, it was reported that representatives from Middlesbrough Council, One Planet Living Team, had been invited to attend the meeting to provide evidence in relation to the climate change element of the investigation.

The representative provided a detailed and comprehensive presentation which focussed on the 'One Planet Living' initiative adopted by Middlesbrough Council, how this linked to the JSNA topic of Environment and included the following:-

Following conclusion of the presentation a discussion ensued which included the following issues:-

- (i) In response to a query as to whether the assessment tool had been developed in house, Members were advised that the tool had been developed in-house with support from BioRegional. The tool could be developed elsewhere provided there was an understanding of the principles of One Planet Living.
- (ii) Given the financial investment in relation to the refurbishment of Stuart Park a query was raised as to how Members were persuaded to invest in order to achieve savings in the longer term. The representative advised that there was extensive political support in favour of the scheme and a policy had been agreed in this regard. The Executive Member for Environment and Deputy Mayor were excellent advocates for the scheme and work was continuing to raise awareness on the benefits of the programme.
- (iii) Clarification was sought as to whether the recent announcement of cuts by the Mayor would impact on the One Planet Living Agenda. The representative advised that whilst reductions in staffing levels had been made, delivery of the scheme would be integrated into service delivery.
- (iv) In response to a request for clarification as to which other partners would be involved in the scheme, the Forum was advised that the Council were working with social housing providers, Teesside University, Middlesbrough College, the fire service and the police.
- (v) The representative went on to respond to further queries raised by the Forum and members of the public in relation to zero carbon and zero waste issues.

The Chair thanked the representative for his attendance and valuable contribution to the investigation.

49. Scrutiny Investigation into the JSNA Topic of Environment – Cleanliness/Enforcement – Evidence from Environment Team - Covering Report/Presentation (Scrutiny Support Officer/Environment Team)

As part of the Forum's investigation into the JSNA topic of Environment, the Forum was advised that officers from the Environment Team had been invited to the meeting to provide evidence in relation to the Cleanliness/Enforcement element of the JSNA topic of Environment.

The Climate Change Officer, Senior Neighbourhood Co-ordinator, Senior Environmental Enforcement Officer and Environment Co-ordinator, who were in attendance at the meeting, provided a joint detailed and comprehensive presentation which focussed on the following issues:-

Local Environmental Quality

- Why is Local Environmental Quality Important (LEQ)?

In the discussion that followed a number of queries/views/comments were raised which included:-

- (i) Following discussion and clarification provided in response to queries raised regarding the inspection assessment process for NI 195 and the additional responsibilities undertaken by the street cleansing operatives, the Forum requested that figures in relation to this issue be provided by ward. The importance of reporting any areas of concern in relation to litter problems was emphasised.
- (ii) With regard to abandoned vehicles, a Member queried the definition of abandoned and sought clarification regarding the powers available to remove abandoned vehicles from outside peoples' homes. The Senior Environmental Enforcement Officer provided details of the powers available to the Council highlighting that various restrictions applied which prevented removal. It was suggested that details be provided following the meeting whereupon the issue would be investigated.
- (iii) Reference was made to the higher level of fixed penalty notices issued in Hartlepool in respect of dog fouling in comparison to neighbouring authorities and the reasons for such levels were questioned. It was reported that given that Seaton Carew and the Headland were popular tourist attractions, there was a significant impact on the level of litter and dog fouling. It was noted that the majority of fixed penalty notices were issued to non-Hartlepool residents. The Forum raised a number of queries in relation to the level of patrols and enforcement arrangements to which the Senior Environmental Enforcement Officer provided clarification. The Forum

queried whether a breakdown of fixed penalty notices issued by ward and street was available and also whether it was possible to identify the numbers issued to Hartlepool and non-Hartlepool residents. Following further discussion in relation to such arrangements and given concerns raised that a number of incidents of dog fouling occurred outside working hours, and not during daylight hours, it was suggested that flexible working arrangements be explored.

- (iv) The Chair was of the view that the option to delegate the power to issue fixed penalty notices to more officers of the Council was something that could be considered.
- (v) The Forum discussed the issue of metal theft and were pleased to note the 75% reduction in this regard.
- (vi) Concerns were raised regarding the problem of cigarette butts and various methods of addressing this town wide problem were debated which included approaching residents associations to assist with distribution of ash trays and the need to review current fine levels. The Forum was advised that the level of fines were set by the Government.
- (vii) A Member queried whether a Section 47 notice could be utilised to prevent parking on grass verges to which the Senior Environmental Enforcement Officer indicated that provided visual evidence was available, this issue could be addressed under the Highways Act.
- (viii) The Forum went on to discuss the Dog Warden Service and allotment issues during which the Environment Co-ordinator responded to issues arising from the presentation. Clarification was provided in relation to the database updating process, micro-chipping service and allotment inspection process as well as future priorities for allotment sites.

The Chair thanked the team for their attendance and invaluable contribution to the investigation and requested that all Members of the Forum be invited to the Environment Roundabout event.

Subject: PROPOSALS FOR INCLUSION IN COUNCIL PLAN

2013/14

1. PURPOSE OF REPORT

1.1 To provide the opportunity for the Neighbourhood Services Scrutiny Forum to consider the proposals for inclusion in the 2013/14 Council Plan that fall under the remit of the Forum.

2. BACKGROUND

- 2.1 For 2013/14 a review of the Outcome Framework has been undertaken to ensure that it still accurately reflects the key outcomes that the Council and Partners have identified as being important for the future of the Borough. A revised Outcome Framework, to be implemented from April 2013, was reported to Scrutiny Coordinating Committee on 19 October 2012 and Cabinet on 29 October 2012.
- As in previous years detailed proposals are being considered by each of the Scrutiny Forums in January. A further report will be prepared for Scrutiny Coordinating Committee on 18 January 2013 detailing the comments/observations of each of the Scrutiny Forums to enable a joint response to be prepared for Cabinet.
- 2.3 As discussed at the Scrutiny Coordinating Committee on 19 October 2012, from 2013/14 the three Departmental Plans will be brought together to form the Council Plan which will set out collectively how the key priorities/outcomes that the Council have identified will be delivered. This is a different approach to previous years and therefore there will be no separate Corporate Plan. This will eliminate the unnecessary duplication and reporting of actions that was an unintended consequence of drawing the old Corporate Plan actions and indicators from the three Departmental Plans, without losing the focus that having separate Departmental Plans brings to the overall process.

2.4 The Council Plan is still a working document and as such there are areas where information could change. Where this does occur the information will be included in the final draft of the Plan that is to be considered by Scrutiny Coordinating Committee on 8 March 2013, by Cabinet on 18 March 2013 and by Council on 11 April 2013.

3. PROPOSALS

- 3.1 The Director of Regeneration and Neighbourhoods will deliver a short presentation at the meeting detailing the key challenges that the Council faces over the next year, and beyond, and setting out proposals, from the Regeneration and Neighbourhoods Departmental Plan, for how these will be addressed.
- 3.2 The main focus of the presentation will be on the outcomes that have been included in the Outcome Framework and how these will be delivered in 2013/14. The Director of Regeneration and Neighbourhoods will take each outcome in turn, explaining how each outcome will address the challenges faced by the Council. After each outcome Members will be given the opportunity to comment on the proposals before the Director moves the presentation onto the next outcome.
- 3.3 The Outcomes that fall under the remit of the Neighbourhood Services Scrutiny Forum, and will therefore be included in the presentation are: -
 - Outcome 9: Improve health by reducing inequalities and improving access to services;
 - Outcome 10: Give every child the best start in life;
 - Outcome 18: Quality local environments where public and community open spaces are clean, green and safe;
 - Outcome 19: Provide a sustainable, safe, efficient, effective and accessible transport system;
 - Outcome 20: Hartlepool is prepared for the impacts of climate change and takes action to mitigate the effects;
 - Outcome 25: Local people have a greater voice and influence over local decision making and the delivery of services.
- Appendix A provides detail on the proposed actions identified to deliver the outcomes that fall under the remit of the Neighbourhood Services Scrutiny Forum. Officers from across the Council have also been identifying the Performance Indicators (PIs) that will be monitored throughout the year to measure progress and these are also included in the appendix. The identified risks are also included for information.
- As in 2012/13, it is not possible at this stage to include year end outturn and future targets as these are not yet available. It is normal practice to use a number of criteria when setting targets, such as current performance, budget information and other external factors such as Government policy changes. Therefore it is normal for targets to be set around year end when more

information is known. Where available, this information will be included in the proposals reported to Scrutiny Coordinating Committee in March 2013.

4. NEXT STEPS

- 4.1 The remainder of the Council Plan proposals have already been, or will be discussed at the relevant Scrutiny Forums between 4 January and 17 January 2013. Comments and observations from those Scrutiny Forums will be added to those received at today's meeting and included in the overall presentation to Scrutiny Coordinating Committee on 18 January 2013. Due to the short length of time between the Scrutiny Forums and the Scrutiny Coordinating Committee meeting on the 18th January it will not be possible to provide a detailed response to the comments and observations made at the Scrutiny Forums at the SCC meeting.
- 4.2 The final draft of the Council Plan, which will have considered the points raised by Scrutiny, will then be considered by Scrutiny Coordinating Committee on 8 March 2013 and Cabinet on 18 March 2013 before being taken for formal agreement by Council at its meeting on 11 April 2013.
- 4.3 Progress towards achieving the actions and targets included in the Council Plan will be monitored throughout 2013/14 by officers across the Council and progress reported quarterly to Elected Members.

5. **RECOMMENDATIONS**

- 5.1 It is recommended that Neighbourhood Services Scrutiny Forum: -
 - considers the proposed outcome templates (Appendix A) for inclusion in the 2013/14 Council Plan;
 - formulates any comments and observations to be included in the overall presentation to the meeting of the Scrutiny Coordinating Committee on 18 January 2013.
