## Belong Network - September Update:

## Regeneration Plan – Pride in Place Programme Delivery will:

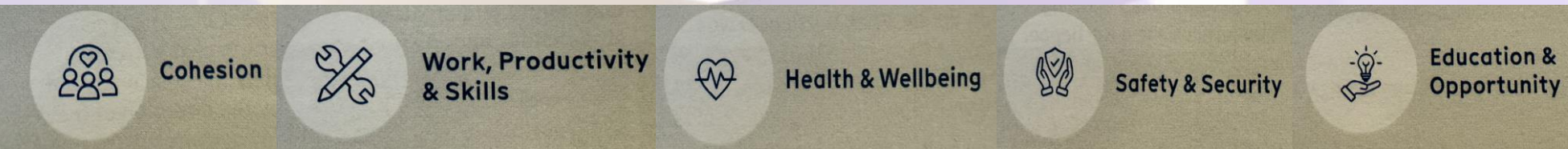


# Commitment to Responsive Support:

## Aligning the Regeneration Plan's Investment Themes through Focused Action, Projects and Investments

Every intervention delivered will align with 1, or more, investment themes:

- Responsively adapting support to meet Ben's key needs and risks, throughout his journey towards positive change & community reintegration.
- Commencing restorative intervention in custody, supporting impacted community members & addressing mis/disinformation re. causation, as part of the wider recovery effort.



- Continuing to work **restoratively** with Ben, following his prison recall.
  - **Cohesion** – Violent Disorder RA – PCC meetings & Police re. recall arrest.
  - **Work, Productivity & Skills** - Clean Slate Solutions. Work-based Trauma. Employability.
  - **Health & Well-being** – DART liaison, drug-free Prison Wing. Psychological well-being.
  - **Safety & Security. Education & Opportunity** – managing re-offending risk, using restorative approaches.



Ben Judge, from Hartlepool, was identified as throwing bricks at officers and a metal object from the ground.

The 28-year-old was also pulling boards from a boarded-up window and was seen to kick through the window behind during violent disorder in the Hartlepool area on July 31.

At Teesside Crown Court on Thursday, he was sentenced to three years in prison.

# Pride in Place - Summerhill Visitors Centre:

**Working together to meet community need, improve safety & security and address ASB & criminality on-site.**

- Community-driven – concerns raised by visitors to the Centre and staff. Responsive - site walk-around.
- Offer of Restorative Circle.
- Pride in Place Programme – project review (e.g. VAWG, Mental Health Walks).

Use of Restorative Approaches to work WITH the local community and HBC employees:.

- Memorial following death by suicide, indirect further incidents of Criminal Damage & harm. Dedicated memorial sites with mutually agreed artwork/design.
- Memorial garden.
- Mindfulness spaces.
- RA/RJ re.fire-setting analysis.



# Summarising Progress - Achievements Made:

## Key Themes in the First Year of the RA Pilot & Scoping Exercise



- **RJ/RA Intervention Delivery** - Ongoing work with convicted harmers of the Violent Disorder.
- Core **restorative principles** informing the basis of safe community support, establishing effective partnerships & referral pathways, shaping strategic approaches to increase cohesion. Utilising opportunities to prioritise relationship-building, foster empathy & understanding, inclusion & participation, empowerment & opportunities to repair harm. Shared **social vocabulary** through use of restorative dialogue.
- **RA Awareness Training & Learning Evaluation** - Hartlepool Probation, Cleveland Police – Local Policing & Hartlepool Adult Social Care. Applied learning.
- **Promoting Access to, & the Benefits of, RA** - Production of 'lived experience' film, sharing the accounts of a couple harmed through Burglary and the responsible male. Illustration of a restorative process and the benefits gained in meeting.
- Support to local **Sports & Visitors Centres**, managing ASB/criminality, using restorative circles, Police & Community Safety.
- **Hartlepool 6<sup>th</sup> Form (College of Sanctuary)** – Challenging mis/disinformation through credible voices of other young people. RJ planned between students and those working with Youth Justice, to shape understanding, challenge hate..
- **Reparative Activities** - Pride in Place & sense of belonging/shared identity. Opportunities to make amends in the community/repair harm & reintegrate harmers. Coordinating partners for efficiency & increased engagement in RA/RJ.



# What Next?

- Integral component in the delivery of the **Regeneration Plan** for **Pride in Place**.
- Integral component in the delivery of Hartlepool's local **Community Cohesion Strategy**.
- Building on the **Health Impact Assessment** through the ongoing **partnership** development with North Tees & Hartlepool and South Tees **NHS Foundation Trusts** (now one group) – embedding of restorative principles and practice within organisational culture, via delivery of RA training, building and repairing relationships, managing conflict & establishing a local restorative network.
- Development of **Hartlepool 6<sup>th</sup> Form** as a **Restorative College**.
- RA **training** within Hartlepool's **Local Policing** teams - Proactive, Neighbourhood & Response.
- RA **training film** launched as part of International RJ Week.
- Exploration of **opportunities** for **broader training delivery** and the development of **HBC** as a registered **Restorative Organisation**, with the Restorative Justice Council.
