13. Apologies for Absence

Apologies for absence were received from Councillor Quewone Bailey-Fleet.

14. Declarations of interest by Members

15. Confirmation of the minutes of the meeting held on 29 September 2025

Confirmed.

16. Periodic Review of the Constitution (*Monitoring Officer/Director of Legal, Governance and Human Resources*)

The Director of Legal, Governance and Human Resources presented a report that outlined the proposed changes to the position of Chair of the Health and Wellbeing Board and Vice Chairs of Committees. It was proposed that given the cross over of health responsibilities, the Chair of the Adult Services and Public Health Committee also Chair the Health and Wellbeing Board. A Member proposed that the Elected

Member appointed to Tees, Esk and Wear Valley NHS Trust as a representative of Hartlepool Borough Council, be also included within the membership of the Health and Wellbeing Board. The Chair suggested that this proposal be presented to the Health and Wellbeing Board for consideration.

In addition, it was suggested that in recognition of recent departmental changes and order to share the role and responsibility, that Committees be given the option to appoint up to two Vice Chairs from within the membership of the Committee.

During the discussion that followed, it was noted that sharing the knowledge and responsibility across the Chair and two Vice Chairs will ultimately provide more support to the Department.

Decision

- (i) That Council be asked to consider the provision for Committees to have the option to appoint up to two Vice Chairs.
- (ii) That Council be asked to consider amending the Constitution to allow for the Chair of Adult Services and Public Health Committee to be Chair of Health and Wellbeing Board.
- (iii) That a report be submitted to the Health and Wellbeing Board to consider appointing the Council representative on the Tees, Esk and Wear Valley NHS Trust to the Board.

17. Periodic Review of the Constitution – Realignment of Committees and Review of Delegations (Monitoring Officer/Director of Legal, Governance and Human Resources)

The Director of Legal, Governance and Human Resources presented a report for information with an updated copy of Part 3 with tracked changes attached at Appendix 1, which reflected the changes brought about by the Senior Management Restructure. The following amendments were also to be included within the updated document:

Social Fund – to be removed as it no longer exists.
Repographics – to be relocated to within the responsibility of Communications and Marketing.
Housing Revenue Account – to remain under the responsibility of Finance and Corporate Affairs Committee.

A discussion ensued on the Housing Revenue Account and it was suggested that this be brought back to the Constitution Committee at its next meeting for further discussion.

Decision

- (ii) That the remaining amendments to Part 3 of the Constitution attached by way of Appendix and undertaken through delegation to the Director of Legal, Governance and Human Resources be noted.
