Subject: ADDITIONAL HIGHWAY MAINTENANCE FUNDING

2014-15

1. TYPE OF DECISION/APPLICABLE CATEGORY

1.1 Key Decision (test (i) & (ii)). Forward Plan Reference No. RN01/14.

2. PURPOSE OF REPORT

2.1 To provide details of additional funding identified in the Chancellor's autumn statement of December 2012 and by the Transport Secretary in March 2014 and to seek approval for this to be used to enhance the five year highway maintenance programme for 2014-15.

3. BACKGROUND

- 3.1 The Chancellor's Autumn Statement on the 5th December 2012 announced an additional £1.5 billion of Government investment to improve the highway network and reduce congestion.
- 3.2 The Government recognises one of the best ways to foster job creation, encourage economic growth and support local communities is to ensure we have well maintained transport infrastructure.
- 3.3 This led to them announcing an additional £333 million for a dedicated fund to provide for essential maintenance to renew, repair and extend life of the highway network in England.
- 3.4 £215 million of this funding was allocated directly to local highway authorities split over the two years (2013/14 and 2014/15) of which Hartlepool Borough Council were allocated £142k and £79k respectively.
- 3.5 It has been left to the individual highway authorities to target the extra funding where it is most needed with a short statement published on the authority's web site at the end of each financial year setting out on what and

- where (in terms of location) this additional funding has been spent and how it has complimented (rather than displaced) the planned highway maintenance expenditure.
- 3.6 On the 20th March 2014 the Transport Secretary confirmed that Councils in the north east of England were to receive almost £6.6 million of government funding to help repair local roads damaged by severe weather.
- 3.7 The funding is an exceptional payment from £183.5 million of extra funding the government has made available to help with road repairs following the wettest winter since records began.
- 3.8 Hartlepool Borough Council's share of the fund has been allocated on a formula basis and amounts to £131,268.

4. PROPOSALS

- 4.1 It has been established that better value for money is achieved by undertaking permanent resurfacing schemes rather than repairing individual potholes.
- 4.2 It is proposed, therefore, that the additional annual funding should be added to the Local Transport Plan (LTP) capital funding for each year to enhance the highway maintenance programme works for 2014-15.
- 4.3 This will enable additional schemes to be undertaken than would be possible with the LPT funding alone.
- 4.4 The additional schemes will be identified and published as per the terms of the grants.

5. FINANCIAL CONSIDERATIONS

- 5.1 Local Transport Plan structural maintenance allocation for carriageways for 2014/15 is £626k (as previously approved).
- 5.2 Revised budgets including additional funding will be £836,268.

6. EQUALITY AND DIVERSITY CONSIDERATIONS

Subject: HIGHWAY MAINTENANCE PROGRAMME 2014-15

1. TYPE OF DECISION/APPLICABLE CATEGORY

1.1 Key Decision (test (i) & (ii)) Forward Plan Reference No. RN10/14.

2. PURPOSE OF REPORT

2.1 To seek approval to the planned Highway Maintenance programme for the period April 2014 to March 2015.

3. BACKGROUND

- 3.1 The condition of the highway network is established from information obtained from SCANNER vehicles and Course Visual Inspections (CVIs), which are carried out by specialist contractors on behalf of the Authority. The information is then analysed, through the United Kingdom Pavement Management System (UKPMS), which allocates ratings to each section of highway ranging from 0 (good condition) to 100 (nil residual life). Condition reports are also put forward by the Highway Inspectors following routine inspections.
- 3.2 For year 2014/2015 the allocation for highway maintenance from the Local Transport Plan (LTP) is £626,000. On this basis, and assuming similar allocations in future years, it will not be possible to reduce the maintenance backlog. Bearing in mind that during this time, the rest of the network will continue to deteriorate, it is likely that the condition of the network will deteriorate faster than repairs can be made within the allocated budgets.
- 3.3 In addition to the LTP allocation for 2014/15 Central Government announced in its Autumn Statement (in December 2012) additional highway maintenance funding which equated to £79,000 for Hartlepool Borough Council for 2014-15 and an additional £131,268 was allocated by the Transport Secretary in March 2014 to address the damage caused by the weather extremes in 2013-14. . Subject to approval it is intended to utilise

- this funding to enhance the highway maintenance programme making a total budget for 2014-15 of £836,268.
- The condition of the **unclassified** highway network is calculated from information obtained from Course Visual Inspections (CVIs).
- 3.5 The surveys are carried out by a specialist contractor on behalf of the Local Authority. The surveys have been commissioned in partnership with all of the North of England Authorities and are carried out annually.
- 3.6 Due to the extent of deterioration of the highway network over the past few years a complete review of previous years' programmes has been undertaken. All roads have been rated on a traffic-light system dependent upon the extent of their deterioration as established by the most recent condition surveys and the programme established on a needs basis.
- 3.7 All roads that have been identified as red or amber have been added to the long list of schemes for future years. As can be expected this is a substantial list which is likely to increase as new surveys are undertaken on an annual basis. Because of this only an annual programme has been identified at this time, with all other schemes identified as future year schemes, giving scope to prioritise on a needs basis in future years dependent upon condition survey results.
- 3.8 The programme of works for 2014-15 is not particularly large in respect of the number of schemes but it is vital that we address the principal and main road networks in the town to ensure that accessibility is maintained to the highest standard possible for residents, visitors, existing business users and to support any potential regeneration opportunities.
- In this respect schemes have been selected on major routes such as the A689, A179 and A178 and major distributors and bus routes.

4. PROPOSALS

- 4.1 The programme is attached as **Appendix 1**.
- 4.2 Reconstruction works are expensive compared to other maintenance measures and have been avoided this year as far as has been possible. Other treatments such as re-surfacing and surface dressing, which are cheaper but have a have a shorter term impact than full reconstruction, will be utilised in order to maximise the available budget.

5. FINANCIAL CONSIDERATIONS

5.1 The programme has been established using estimated costs which may result in an under spend when all identified works have been completed. If

this is the case a further report will be submitted to seek approval for additional works.

5.2 The budget for 2014/15 is made up of the following:

Local Transport Plan Structural Maintenance Block £626,000 Additional Highway Maintenance Funding £210,268

Total £836,268

5.3 Reconciliation of the 2013/14 budget is ongoing and any under spend identified as a result of this will be utilised, together with any under spend from this year's budget, towards further works to be identified in a future report.

Subject: RABY ROAD/ MIDDLETON ROAD TVBNI SCHEME

1. TYPE OF DECISION/APPLICABLE CATEGORY

1.1 Key decision: RN11/14 (test (i) applies).

2. PURPOSE OF REPORT

2.1 To seek approval for a highway improvement scheme at Raby Road/Middleton Road, as detailed in the report.

3. BACKGROUND

- 3.1 The Tees Valley Bus Network Improvement scheme (TVBNI) is a 5 year project, to provide major infrastructure improvements along key bus corridors.
- 3.2 A number of schemes have been implemented so far, including Catcote Road/ Oxford Road junction, Burn Valley roundabout and the York Road improvements.
- 3.3 An additional scheme has been developed for Raby Rd/ Middleton Rd (See **Appendix 1**), as a result of savings made on some of the other schemes implemented. Also, a small number of schemes were not progressed as they were shown to provide little benefit when investigated in detail.

4. PROPOSALS

4.1 The purpose of this scheme is to improve traffic flow through the junction. The main element of the work is the provision of a designated right turn lane, for westbound traffic on Middleton Road seeking to turn right into Raby Road. At present, traffic travelling straight ahead or wishing to turn left towards the Town Centre can be held up by right turning traffic, and the improvement scheme would relieve this congestion.

4.2 The junction is used by Stagecoach services 1, 3 and 6, Arriva services 22 and 23, and the Go North East service X35.

5. CONSULTATION

- 5.1 Consultation has been undertaken with nearby residents and businesses, ward councillors, residents groups, the emergency services and bus companies.
- Only one response was received, from the Addison, Belk and Cameron Residents Group. While the group felt the scheme was a good idea, they suggested that the phasing of the lights could possibly be altered to 4 way, or right turn filters incorporated.
- 5.3 Changing to 4 way lights would significantly increase congestion, as the junction currently operates on a 2 way system. The junction will also be modelled as part of the scheme design, and where right turn filters are found to be beneficial they will be included.

6. FINANCIAL CONSIDERATIONS

- The Tees Valley Bus Network Improvement project is jointly funded by the Department for Transport and the Council's Local Transport Plan, with a 65% (£149,500) / (£80,500) 35% split respectively.
- 6.2 It is estimated that the scheme will cost approximately £230,000.

7. EQUALITY AND DIVERSITY CONSIDERATIONS

7.1 There are no equality or diversity implications.



Subject: SAFER ROUTES TO SCHOOL – SCHOOL

CROSSING PATROL SITE IMPROVEMENT

SCHEMES

1. TYPE OF DECISION/APPLICABLE CATEGORY

1.1 Non key decision.

2. PURPOSE OF REPORT

2.1 To seek approval for a range of Safer Routes to School schemes that will improve Road Safety and help promote walking to school by upgrading a number of School Crossing Patrol sites.

3. BACKGROUND

- 3.1 The Sustainable Travel and Road Safety Team work to enhance and promote safe and active Travel for all journeys that take place within Hartlepool which discharge Hartlepool Borough Council's statutory responsibility under Section 39 of the Road Traffic Act and the 2006 Education and Inspections Act.
- 3.2 By working to facilitate and promote the use of active modes of transport such as walking and cycling, or encouraging more efficient use of vehicles for journeys, there can be significant economic, health and environmental benefits generated. The Team also work to identify casualty concerns and develop projects and initiatives to facilitate safer road user behaviour for key road user groups. This work helps to bring significant cost savings to society (the average cost of a fatal accident in the UK in 2012 was valued as £1.9m).
- 3.3 The work that the unit undertakes helps to achieve the objectives of Hartlepool Borough Councils 3rd Local Transport Plan which include:

- Delivering Sustainable Economic Growth
- Reducing the impact of Transport on the Environment
- Safer and Healthier Travel
- Improving Access to Services
- Improving Quality of Life
- 3.4 As part of the work to improve safety on school journeys, and thereby encourage more people to walk to school, the Team manages the Council's School Crossing Patrol (SCP) service. There are currently 35 SCP sites which provide a service to almost all of the Borough's 13,000 pupils every day during the school year. As part of the management of this service annual risk assessments of SCP sites and Supervision of staff are undertaken. From these a range of safety schemes at SCP sites have been identified, which if implemented, would enhance safety and help provide further encouragement for walking to school.

4. PROPOSALS

4.1 As explained above, a range of safety schemes at SCP sites have been identified as set out below.

4.2 <u>Brougham Terrace</u>

The SCP site on Brougham Terrace operates from a 'build out' to reduce the width of the road crossed and there is guard rail in place to channel pedestrians to the site. However, the gap between the guard rail at the crossing point is excessive and pupils can cross without waiting for the patroller to stop traffic. For this reason, it is proposed to make some amendments to the tactile paving at existing dropped crossing and utilise some bollards to reduce the width of the crossing to improve safety.

4.3 Masefield Road - Junction with Kipling Road (Rift House Primary School)

The SCP site Masefield Road is located immediately to the west of the junction with Kipling Road. The proposal is to install dropped kerbs at this crossing point to improve access for parents with pushchairs, the elderly, and / or people with disabilities utilising this crossing.

4.4 Stockton Road - Junction with Loyalty Road (St Aidan's Primary School)

The SCP site on Stockton Road is located near to its junction with Loyalty Road. The proposal is to provide dropped kerbs at the SCP, extend guard rail to fully channel pedestrians to the site and also replace an old dropped crossing point over loyalty road to install fully compliant tactile paving. The proposals will make it easier for parents with pushchairs, the elderly, and / or people with disabilities to utilise this crossing and access St Aidan's Primary School.

4.5 King Oswy Drive (Outside St John Vianney RC Primary School)

There is an existing SCP site on King Oswy Drive near to its junction with Nesbyt Road outside of St John Vianney RC Primary School. The proposal is to provide dropped kerbs at the crossing location to improve access for parents with pushchairs, the elderly, and / or people with disabilities utilising this crossing. The proposal does not impact upon any existing driveways and is within the area covered by existing parking restrictions.

4.6 <u>Winterbottom Avenue - Junction with Bruce Crescent (West View Primary School)</u>

The existing SCP site on Winterbottom Avenue operates at a site close to its junction with Bruce Crescent without a dropped crossing. The proposal is to provide dropped kerbs at the crossing location to improve access for parents with pushchairs, the elderly, and / or people with disabilities utilising this crossing.

4.7 Grange Road - Junction with Linden Grove (Various Schools)

The SCP site on Grange Road is located at the junction with Linden Grove. Concerns have been raised by the School Crossing Patroller, parents and by staff undertaking risk assessments relating to vehicles driving over the footway at the SCP site. The issue occurs when there is a vehicle travelling east on Grange Road which wishes to turn right into Linden Grove. If such a vehicle comes to a stop, following vehicles can utilise driveways at 134 and 136 Grange Road to drive over the footway to pass the waiting vehicle and this poses a risk the patroller and other pedestrians as the vehicles proceed across the SCP location on the footway. It is therefore proposed to install four bollards to discourage vehicles from doing this. They would be located to enable access for residents of 134 and 136 Grange Road on to their driveways.

4.8 Pupils from High Tunstall College have been observed to exit the School via the gate at this location and proceed to cross directly over Elwick Road as the guard rail at this point does not fully cover the exit gate. It is proposed to install an additional guard rail to the north of the school gate for a distance of 43m. This will also help to prevent inconsiderate parking that has damaged the grass verge at this location. It is proposed to replace the damaged grass verge along this length with a new type of flexible surface that will enable drainage, but will be resistant to damage and be more visually pleasing the existing damaged verge.

5. CONSULTATION

5.1 All of the proposed schemes are of a relatively minor nature, however, where new crossing facilities have been proposed or where bollards have been proposed, consultation with residents has been undertaken.

5.2 Masefield Road

Four properties that are on the northern side of Masefield Road close to the junction with Kipling Road (numbers 30, 32, 34 and 36) are in the immediate vicinity of the proposed crossing location. Letters and a plan detailing the proposals were delivered to these properties on 20/2/14 with response form, asking for comments by 5th March 2014.

Two responses were received from residents in 32 and 36 Masefield Road. Both responses were in favour of the scheme and 1 requested further enforcement of parking restrictions on Masefield Road to improve safety for school pupils.

5.3 Stockton Road

Two properties that are on the northern side of Stockton Road close to the junction with Loyalty Road (146 and 148 Stockton Road), The Greenside Public House, and St Aidan's Primary School are in the immediate vicinity of the proposed crossing location. Letters and a plan detailing the proposals were delivered to these properties on 20/2/14 with response form asking for comments by 5th March 2014.

The only response that has been received is from the Headteacher of St Aidan's Primary School to say they are in favour of the proposed scheme.

5.4 King Oswy Drive

The proposed location to install the dropped crossing is outside of St John Vianney Primary School and is located in the frontage of a number of properties on the eastern side of King Oswy Drive (numbers 22 to 30). Letters and a plan detailing the proposals were delivered to these properties on 13/2/14 with response form asking for comments by 26th February 2014.

Four responses have been received. Three are in favour of the proposal (from numbers 20 and 28 King Oswy Drive and the School) and one is against the proposal (from number 22). The reason given against the scheme is that necessary paving works associated with the crossing would be unsightly and may reduce houses prices when it comes to selling. There was also a suggestion of removing the grass verge that separates the footway and cycleway to allow off road parking (as is the case further north on King Oswy Drive).

5.5 Winterbottom Avenue

The proposed location to install the dropped crossing is on Winterbottom Avenue outside of numbers 73 and 80. Both of these properties had a letters and a plan detailing the proposals delivered on 13/2/14 with response form asking for comments by 26th February 2014.

One response was received from 80 Winterbottom in favour of the proposal.

5.6 Grange Road

The proposed scheme to provide bollards to protect the school crossing patrol site from vehicles driving over the footway, would mean placing bollards outside of numbers 134 and 136 Grange Road. Letters and plans detailing the proposals were sent to both properties on asking for comments on the proposals by 5th March 2014.

One response was received from number 134 Grange Road that was in favour of the scheme.

6. FINANCIAL CONSIDERATIONS

6.1 The table below sets out a summary of the proposed schemes, their costs, and the schools / wards that would benefit.

2. PURPOSE OF REPORT

- 2.1 To acknowledge of the following points raised within the letter from Esther McVey MP and how Hartlepool Borough Council has shown its commitment to addressing these considerations.
 - a) Consider how inclusive your own local community and environment is.
 - b) Consider whether your own local community and environment could be improved both for the benefit of disabled people but also for the benefit of local businesses.
 - c) Consider how working in partnership with disabled people... could help you do this.

3. BACKGROUND

- On 20th August 2013 Parliamentary under Secretary of State and Minister for disabled, Esther McVey MP wrote to local authorities. The letter was titled 'Access to open spaces and beaches for disabled people' and directed authorities to reflect upon the accessibility and attractiveness of local areas of beauty and interest. (See Appendix 1).
- 3.2 <u>Ward Implications:</u> The works already carried out by the Council to create and improve access have, and will hopefully continue to impact across the whole Borough.
- 3.1 **Appendices 2, 3** and **4** provide more detailed information highlighting a variety of improvements and initiatives that have looked to enhance the vision of 'Access for All'.

4. OBSERVATIONS ON POINTS RAISED WITHIN MP'S LETTER

4.1 <u>Point a) in relation to Hartlepool: Consider how inclusive your own local community and environment is.</u>

Appendix 2, Access to Open Spaces and Beaches for Disabled People sets out how the Council has looked to improve open space and beach facilities in Hartlepool by including local communities in the concept and design of access improvements. A wide range of developments have taken place and include simple access improvements to the local access network; new and enlarged car parking facilities complete with toilet facilities for able and disabled users; and new or improved inclusive play facilities for children and teenagers.

4.2 <u>Point b) in relation to Hartlepool: Consider whether your own local community and environment could be improved both for the benefit of disabled people but also for the benefit of local businesses.</u>

Appendix 3 provides an excellent example of how this can be achieved through the 'Short Breaks Services' initiative. The statement explains the short breaks concept, what types of short break are needed, and describes the participation of families of disabled children at all stages. This work has culminated in improvements of services for disabled children and helped ensure and promote better outcomes for their families. It provides a valuable example of service user lead improvements which have provided greater opportunity for discovery and life enhancement for the children and the families involved.

4.3 <u>Point c) in relation to Hartlepool: Consider how working in partnership with disabled people... could help you do this</u>

Appendix 4: The Design and Access Statement provides an example of how this is achieved in practice and was commissioned as an accompanying document to a planning application for the Seaton Town Frontage Sea Defence scheme. This scheme, when complete, will provide vastly improved access facilities for disabled and able-bodied people. The sea defences will also provide safer access for equestrian users onto the beach, at Seaton Carew.

5. PROPOSALS

5.1 To sustain the current practices and inclusive approaches to access improvements undertaken throughout the Borough

6. RISK IMPLICATIONS

6.1 The potential impacts of continued reductions in Local Authority funding in physical capital scheme renewal programmes and ongoing revenue funding to sustain physical assets and service support elements.

- 7.1 Many capital improvement programmes rely predominantly on external funding, and as a consequence on the availability of the necessary competencies within the organisation to successfully lobby, produce funding bids, and subsequently manage and deliver them when successful.
- 7.2 Almost all external funders expect match funding and the need to create reserves for future renewals becomes a much higher priority in times of austerity when revenue budgets and repair programmes are tightened.
- 7.3 External grant funding has traditionally created the new opportunities to expand and improve the access provision in to areas of open space and recreational value.

Access to open spaces and beaches for disabled people

Dear Council Leader.

This Government's ambition is create a fair and equal society in which disabled people are enabled to play a full and equal part in society. As part of the Government's Strategy, Fulfilling Potential, 'Making it Happen' was published on 2 July and captures almost 200 actions and plans across the whole of Government. On 18 July, we held a disability conference, which marked the start of our two year Disability Confident campaign, to work together with business to employ more disabled people. At the conference the Prime Minister, David Cameron outlined his ambitions for an inclusive Britain. He suggested that one focus for this summer is to ensure that our beaches are accessible.

As nearly 20% of the population is disabled, it is essential that we work together to ensure that our open spaces and beaches are accessible to all of our population. This means the Government, local authorities, environmental trusts and disabled people all working in partnership to achieve a more inclusive society. The Disability Action Alliance has been set up to bring disabled people's organisations together with other organisations from the public, private and third sector – to work together to deliver actions that improve the lives of disabled people. Alliance member organisation, 'Living Options Devon', run a scheme to make the country side more accessible which has been developed through partnership with many organisations that manage country side sites (for e.g. councils, park authorities, National Trust). 1. INTRODUCTION

1.1 The Engineering Consultancy of the Regeneration and Neighbourhoods Department was commissioned to prepare a Design and Access Statement to accompany a planning application for the Seaton Carew Town Frontage MA13.B-E Sea Defence scheme on Coronation Drive.

2. EXISTING CONDITIONS

2.1 Site Location

The site is in on the sea front at Seaton Carew on land owned and maintained by Hartlepool Borough Council. It stretches from the existing vehicular access ramp opposite Station Lane at the north end of the site to the dunes near the Northumbrian Pumping Station in the south.

2.2 Existing Land Use

The site is a mix of verge and paved footways behind the existing elevated sea wall with pedestrian access onto the shore line via various staircases and restricted vehicular access available via access ramps at three locations – opposite Station Lane, behind The Front opposite Church Street, and adjacent the former fairground site at the north end of the Seaton coach park. A concrete parapet wall to the top of the sea wall forms the protection to the drop from the promenade to the beach. Lighting to the existing promenade is provided only to the area behind the Longscar Centre between the ramps opposite Station Lane and Church Street.

3. DESIGN PROCESS

3.1 Proposed Development

The proposal involves the replacement of approximately 700m of the existing sea wall and parapet with a new sea wall designed to match the height and style of the existing wall between the North Shelter and Beacon Steps. This new wall alignment will be set offline on the beach side of the existing sea wall, tying into

the existing structure from the comer near Station Lane and running past the parade area behind the Clock Tower before turning diagonally across the beach to the comer near the ramp from the coach park then completing the alignment in front of the existing sea wall and terminating at the sand dunes near the Northumbrian Water Pumping Station.

The new wall is to be constructed with concrete to match the existing wall and paving to the new promenade area is to match the existing paving in the parade area behind the Clock Tower. New lamp columns are to be installed along the full promenade length to improve street lighting in this area.

It is intended to replace the existing concrete access ramps and various small beach access steps with new larger stair cases and ramps realigned parallel to the new wall to enable a continuous minimum 5m width promenade along the full length of the new wall.

3.2 Proposed Highway Access

No highway access is required to be altered in the provision of this scheme.

3.3 Pedestrian Access

Pedestrian access will be improved around the area of the existing ramps by moving the access points parallel to the wall and the promenade will be extended along the beach front down to the dunes. The new staircases and ramps will be designed to meet current DDA legislation.

3.4 Cycle Facilities.

Cycleway route, which runs along the promenade as a shared facility with the pedestrians, will be improved by the realignment of the sea wall and promenade areas. Upon completion of the works a continuous route will then be provided from the Hartlepool Marina area down to the dunes near the pumping station at Seaton Carew.

4. TRAFFIC ISSUES

4.1 The new 5m wide beach access ramps are located at the same locations as the existing ramps so any restricted vehicular access to the beach and promenade areas is maintained and therefore will be unaffected by the new scheme.

5. MITIGATION MEASURES.

- 5.1 The proposal does not create significant environmental problems that require mitigation as it is remodelling necessary to prevent coastal erosion and the offline construction of the new sea wall reduces the impact of the scheme on the environment during and after construction.
- 5.2 The site is in a Conservation Area so measures have been taken to match the proposed designs with existing surroundings and materials selected to compliment existing.

6 SUSTAINABLE TRAVEL ISSUES

6.1 The realigned and extended promenade route adds value to sustainable travel by providing improved facilities for pedestrians and cyclists alike.

7. CONCLUSIONS

- 7.1 The Engineering Consultancy of the Regeneration & Neighbourhoods Department was commissioned to prepare a Transport Statement to accompany a planning application for the above proposal to Seaton Carew Town Frontage MA13.1BE.
- 7.2 This is a necessary proposal to prevent coastal erosion that would affect the Town Frontage to Seaton Carew. If the scheme was not carried out it would


eventually mean the loss of verge, road and ultimately housing and businesses. Full details are contained in the submission for planning approval.

This has been done mainly through Short Breaks for Families of Disabled Children and through the Sixth Parent Led Conferences that were held by parents, carers and involving professionals to work closely together to help change and shape the future of Short Breaks. Hartlepool's Vision

'Our vision is that we are committed to ensuring that all disabled children and young people and their families in Hartlepool should have equal access to a range of flexible services that support their ambition to live ordinary lives, enjoy a happy and fulfilling childhood and grow up to achieve their full potential.'

What are Short Breaks?

Short Breaks provide disabled children and young people with the opportunity to spend time away either with or without their parents to be able to relax and have fun, positive experiences with their friends and peers. They also provide families with a break from their caring responsibilities; giving parents a chance to unwind rest and spend time with their other children.

Our aim is to ensure that families of disabled children have the support they need to live 'ordinary lives' as a matter of course. Disabled children and their families have the same human rights as others, including the right to the same quality of life as those who do not have a disability. However we recognise that all families are different, so they need different levels of support and different types of short breaks depending on the age of the child; families may need more support because of their family circumstances, this may be a short period of time or it may be for longer.

How does the council know what type of short breaks are needed and how much?

The council does not presume to know what short break support parents and carers of disabled children require, our role is to facilitate what parents tell us they want so that children, their parents/carers and their families get the breaks they need.

Hartlepool began its consultation process in September 2008 as part of the Aiming High for Disabled Children Transformation Programme launched by the government to transform services for disabled children and their families. An integral part of the transformation programme was to work in partnership with families to understand their needs and design services to meet those needs. Engagement and participation continues to drive the development and shaping of services for the future through its short breaks programme.

Feedback is sought through a number of ways, including: Parent led Conferences, focus groups, feedback and evaluation of services. The council identified priorities and designed service specifications to deliver a short break offer. The offer currently includes:

- Holiday Play schemes
- After School Clubs & Holiday Clubs
- Extended Activities Provision

- Swimming Sessions
- Access to training for both parents and practitioners
- Overnight Stays, including local residential or foster care provision
- Weekend Clubs
- Social groups
- Formal childcare placements
- Specialist Toy Loan Service (including Stay & Play)
- Family based short break activities

We continue to work with our families and providers collating feedback to ensure that the short breaks offer is still relevant to their needs.

There is a variety of data available to us about children and young people with disabilities and additional needs. This ranges from the number of children whose family is in receipt of Disability Living Allowance, Direct Payments, and Disability Prevalence Rates and numbers of children with a Statement of Special Educational Needs. However this data can only tell us how many children and young people may have a disability in Hartlepool. We understand that every family is different and it is therefore quite difficult to predict exactly how many short breaks will be needed year on year.

We know how many families currently access short breaks, how often and the type of short breaks they use. We use this information and anticipate how many more children are likely to use short breaks within each year and how many young people will move on to adult services, no longer requiring short breaks within children's services. This gives a figure that helps us to commission sufficient short breaks throughout the year. These figures are reviewed quarterly which enables us to assess the demand for services and plan accordingly.

This is what parents said about the services accessed via funding through the Early Intervention Grant Short Break Funding

Summer Play scheme

'My children have really enjoyed the summer scheme, the organisation; staff and range of activities have been excellent'

'It is an invaluable service during the summer holidays as six weeks is a long time to find things to occupy my child. It gives my son a voice as he has poor communication'

'Without the summer scheme and outings my summer would be unbearable. I am so grateful for the support it provides, professional, caring staff, well organised, offers flexibility and the knowledge that as a parent you are listened to and your child's needs are being met.'

Extended Activities

'Our son thoroughly enjoys his time at the activity and he has made new friends. It really is an invaluable resource.'

'My child really looks forward to coming to the group and enjoys the activities.'

'The staff are great and have a good understanding of my child's needs.'

'Couldn't be better!'

'Excellent place for all children and will continue to use the service. The staff are very helpful and very approachable and will go out of their way to make it a positive experience for the child.'

Toy Loan Service

'Kids have a brilliant time and I get to relax and chat with friends.'

'Meeting other parents and carers sharing experiences, information and passing on tips.'

'The toy library is a lovely place for children. My child looses interest very quickly with a toy, so it is great that I can loan them for a short period of time. It is fantastic what the staff deliver, and they show me how to use the toys, then collect them as I have no transport.'

'Special needs toys are so expensive to buy. The toy loan service gives you the opportunity to try them first. The play and stay sessions are an ideal way to meet other parents and discuss other ideas with parents.'



Supported Childcare Provision

'My child uses British Sign Language OR Makaton to communicate. The club my child access's is ideal as it is part of the school he attends and he knows all of the staff. They all understand his needs and can communicate with him'

'Access for my child has enabled me to continue work and provided the opportunity for my child to make new friends and have fun.'

Family Based Overnight Activities

'Carlton Camp is such an iconic place, all the kids should experience it. Should never be shut down due to cuts. Carlton Camp is so important in building family, friends and teamwork together. Long live Carlton Camp!!!!'

'Brilliant time with friends and family'

'Brilliant time, staff great and would do again. Water sports next time please.'

'When/how will we know when/where next short break will be..... can't wait loved Carlton Camp would love to do it again (mobile number provided)'




How have families of disabled children participated in the development of short break services?

In Hartlepool we have a very proactive Parent Led Forum that works in partnership with the Local Authority Short Breaks Lead Officer and other relevant agencies and groups to ensure that service delivery meets the need of families of disabled children.

There is also parent representation on a number of other strategic and operational groups, including the Special Educational Needs and Disability Pathfinder Programme (SEND), which provide a platform for parents to contribute and influence change.

Previously parent's hosted a number of focus groups to support and shape service delivery. Parents made a conscious decision to direct their focus on hosting one Parent led meeting bi monthly to increase representation from both parents and practitioners and to also reduce the time spent at and preparing for meetings. This way forward came from a parents person centred thinking day, and included a plan of action that parents have taken forward.



Children and young people are actively engaged in having their say about the things they like to do. This has been and is still carried out in a number of ways, including: questionnaires, face to face discussion, and group work within short break sessions. This information is collated to plan for future delivery.

This is what some of the children and young people have said about some of the activities they have accessed:

'This week the best thing I like was swimming, I really enjoyed it when the animal bus came but was scared when the chicken sat on my lap!'

Neil

'I enjoyed playing with the play dough and making men out of them'

Ben

'Leah has enjoyed going on the bouncy castle and having her hair and makeup done by the girls'

'Paige liked the swimming and face painting and drew a picture of herself'

All of our commissioned services are required as part of their terms and conditions of grant to engage service users in evaluating services on a regular basis, so that services are designed to meet needs at an individual level.

What do the council offer to families that need a Short Break?

Hartlepool Borough Council offer a range of short breaks for all families who care for a disabled child. Families maybe eligible for more specialist short breaks if their child has a substantial and/or permanent impairment, which may have a substantial and long-term effect on their ability to carry out day-to-day activities.

The range of short breaks available is meant to meet the needs of a broad range of need and family circumstances.

Universal Short Breaks

All families can access a number of short breaks for their child. These breaks are short, regular sessions that provide the carer with the opportunity after school, at weekends, school-holidays, to relax have time to themselves or spend time with other family members. These take the form of clubs that offer a wide range of activities for children such as art and crafts, sport and physical activity, or simply a place to meet with friends and chat.

Targeted Short Breaks

Carers may need support and services individually tailored to their child's needs. This level of support is available to families following an initial assessment of the child by a social worker. Any family that feels their disabled child's needs cannot be met using universal services can ask for this assessment. Following the assessment the social worker will work with the family to identify support which may include short breaks. If the child requires support that cannot be met by universal services, the family and the social worker discuss which services are available and which of those services work best for the family. The options are considered through the relevant personnel/panels who will respond to the request and its suitability, ensuring that the family get a package of support that works for them and meets the assessed need. This might include a Family Resource Worker, Day Care or a Direct Payment for the family to arrange support of their own. The support package is reviewed regularly by a social worker to ensure that services continue to meet the changing needs of the child as he or she grows and matures and those of his/her family.

Specialist Short Breaks

Sometimes a child or a family have more significant or complex needs due to their child's disability and/or family circumstances, and need additional support and interventions. The specialist short break package may include universal provision and targeted short breaks, and could include overnight stays within a residential or foster placement or breaks commissioned specifically for the child's needs. The authority is currently exploring the use of individual budgets which will enable families to arrange services themselves. They may also receive help from a short break unit with nursing care. These arrangements are discussed by the Hartlepool multi agency

Commissioning Panel. Health-commissioned breaks are paid for by the Primary Care Trust and will follow a specialist health assessment which is not arranged by the Council but can be discussed with the health professional and social worker involved with the family. Complex and high need cases such as this may require the continued support of a social worker to ensure that the child and carer's needs continue to be met.

Where can families get more information about Short Breaks?

Currently information on short break activities can be accessed by contacting the Families Information Support Hub in Hartlepool (FISH), a practitioner working with the family, or a family can simply contact the provider and refer themselves. FISH is a universal service providing advice and signposting to all families in Hartlepool looking for services for their children. Parents can subscribe to a free texting service that informs them of the opportunities to access various short breaks, meetings and events. As well as this service, FISH maintains a website of activities/events available to families across the borough called Family Service Directory, where there is also a link to the Parents website www.onefuture.org.uk. The council has developed a Guide to Services to support both parents and providers which can be accessed via the council's internet and is also available in hard copy. A Parent Led Newsletter is produced at least twice a year and is made available to all families of disabled children both in a booklet format and or via both websites.

How is the council developing the workforce?

The vision in Hartlepool is for all children and young people to be supported to develop their speech, language, communication and social skills in order to ensure that they can access learning develop social networks and attend activities and local groups, including childcare provision to make positive contribution to the wider community.

The short break training requirements have been agreed and developed alongside parents and are incorporated in the wider Hartlepool Children's Workforce Plan and can be accessed by any provider working with children and young people with additional needs and/or disabilities.

Training delivered specifically through Short Breaks and to be delivered in the coming year:

- Introduction to Communication Passports/Pocket Profiles
- Attitudinal Fear (2 sides of the coin)
- Sleep Management
- Portage Training
- Early Support Key Working
- Moving & Handling (children), including use of hoists
- Detailed Communication Passport Training
- Autism Awareness
- Safeguarding Children with Disabilities
- Helping Children to Develop their Social Skills and Understanding

• Practical and Effective Ways of Using Multi Sensory Equipment

The council will continue to offer development opportunities to maintain the quality and capacity of short break workers in the future and this will feature within the authority's children's workforce plan.

This is what parents have told us:

Key Working

'The course gave me a wider perspective on issues, helped me not to be so emotionally attached to some issues and being given the chance to work with professionals. It made me feel that I was listened to and that my opinion was valued. It made me feel that the Key Worker role was something that could be achieved and that I did have the skills that would help me fill that role.'

Portage

'Very enjoyable, I will use the techniques that I have learned and take them to my work place.'

'Hannah Mortimer made the training very interesting and made the group feel relaxed.'

'The trainer was very helpful, passionate, encouraging and supportive'

Use of Multi Sensory Equipment

'One of the best courses I could ever have been on, everything explained in a very good way.'

'Enjoyed the day and will take away lots of ideas.'

'Pleasant and friendly and I wasn't afraid to ask questions'

Pocket Profiles

'As a parent of a child with communication difficulties finding a way to tell us his needs to others are very important to me. The pocket profile is a quick and simple way for children and parents to share information about how their child expresses their needs, and other information a carer would need to know about a child. The course helped to develop knowledge, skills and experience and we all had the opportunity to go through the process to a finished product.'

How does the council support transitions to adult services?

In Hartlepool we want to support all young people with a disability into adulthood successfully. Becoming an adult is about developing independence, enjoying a social life and getting a job. This means that a young person with a disability may need support to access further education, training and employment, social opportunities and housing advice. The young person's family may continue to need short breaks, so, young people

approaching adulthood and their families should be involved in planning their adult lives in order to ensure that support and services are genuinely responsive to their needs.

A Transitions Working Group identifies all young people who may require the continued provision of support and services into adulthood. Each young person has an identified transitions lead person who will support the young person and their family through the critical transition period.

In July 2012 Child & Adult Services Department in Hartlepool established the Disability Team (0-25). It was felt that it was important to reduce transitions for young people and their families and this prevents the need for a young person to have to develop new relationships with a Social Worker at 16+ who will guide them into adulthood.

For those disabled children, young people, adults and their families who require it this will be a consistent throughout the important transitions in their lives.

The local Authority will ensure it meets the needs of the new approaches to Special Educational Needs and Disability (SEND) and any changes to policy or legislation arising from the Legislation on Reform of Provision for Children and Young People with Special Educational Needs.

How accessible are universal Council services?

Across the Council, there is a strategy to ensure that our public buildings and services are accessible to all. A programme of development has been taking place to ensure that buildings can be accessed by wheelchairs, induction loops are installed and that there are accessible toilets. In addition, every reasonable effort is made to ensure there is access to all areas in public buildings, and where this is not possible, alternative arrangements are put in place to ensure that people with disabilities are not prevented from accessing services and support. Other developments include: additional disabled parking bays, drop off zones and kerbs being installed at bus stops to make public transport more accessible.

Fully equipped accessible changing places have been installed in 3 venues in the Borough, located at: Millhouse Leisure Centre, Hartlepool Maritime Experience and Coronation Drive, Seaton Carew. In addition to the above accessible changing places are also located within a number of settings, for example: The One Life Centre and Central Library.



What is the council doing to help families with transport?

The council is working with short break providers to improve accessibility to services, so now more short breaks are offered in different areas across the Borough.

Some short break providers as part of their service provide transport services to and from home to enable children and young people to access services for a nominal charge and this service also offers the carer with additional hours of a short break.

As part of our roll-out of the Independent Travel Training Programme (Safe on the Move in Hartlepool), we have encouraged any person who feels they may require support during their journey to sign up to the scheme to assist in their safe travel around the town.

From time-to-time those accessing the programme may require some additional support while undertaking their journey. The best way to offer support would be through staff at the facilities accessed by users on the programme. This support could range from assisting the person to read a bus time table, directing them to the appropriate bus stop or help in making a call to a parent or carer. Special signage is displayed in various outlets that have signed up to the scheme and received training.

What are the council's priorities to develop services for disabled children, and how are they being tackled?

During the development of this Statement and through a number of delivered short break services, parents and young people told us what their priorities are for the development of short break provision. The next steps identified at the Sixth parent conference and during a parent/ provider workshop delivered in March 2012 highlighted a number of areas as issues that need development or improvement. The table below shows these issues and the actions being taken to improve or develop them:

Better Outcomes for Families of Disabled Children

The delivery of the above short break priorities are designed to improve the outcomes for disabled children and their families. As part of our service delivery the outcomes detailed below are designed to make a difference to families of disabled children.

- Short Breaks aim to support parents and carers in their caring role and reduce levels of stress and anxiety due to the demands of caring
- They will aim to support disabled children and young people to access activities whereby they can
 make friends, have fun and support the development of their social, communication and independence
 skills
- When disabled young people are leaving school and making the transition to adulthood that they will
 be supported and are able to express their wishes and make appropriate choices
- Short Breaks will provide opportunities to enable families to spend time, relax together and for parents
 and their children to get to know other families to build up a network of support and develop
 friendships

Appendix A

Draft Regulations laid before Parliament under section 104(3A) of the Children Act 1989, for approval by resolution of each House of Parliament.

The Breaks for Carers of Disabled Children Regulations 2010

Made 2010

Coming into force 1st April 2011

The Secretary of State for Education makes the following Regulations in exercise of the powers conferred by paragraph 6(2) of schedule 2 to the Children Act 1989 (1).

In accordance with section 104(3A) of that Act, a draft of these regulations was laid before Parliament and approved by resolution of each House of Parliament.

Citation and commencement

 These Regulations may be cited as the Breaks for Carers of Disabled Children Regulations 2010 and come into force on 1st April 2011.

Interpretation

- 2. In these Regulations-
- "the 1989 Act" means the Children Act 1889;
- "carer" means a person who provides care for a disabled child and who is-
- (a)

The child's parent, or

(b)

A person who is not the child's parent but who has parental responsibility for that child; and

"disabled" has the meaning given in section 17(11) of the 1989 Act (2).

Duty to make provision

- 3. In performing their duty under paragraph 6 (1)(c) of schedule 2 to the 1989 Act (3), a local authority must-
- (a) have regard to the needs of those carers who would be unable to continue to provide care unless breaks from caring were given to them; and
- (b) have regard to the needs of those carers who would be able to provide care for their disabled child more effectively if breaks from caring were given to them to allow them to-
- (i) Undertake education, training or any regular leisure activity,

- (ii) Meet the needs of other children in the family more effectively, or
- (iii) Carry out day to day tasks which they must perform in order to run their household.

Types of services which must be provided

- 4.- (1) In performing their duty under paragraph 6(1)(c) of schedule 2 to the 1989 Act, a local authority must provide, so far is reasonably practicable, a range of services which is sufficient to assist carers to continue to provide care or to do so more effectively.
- (2) In particular, the local authority must provide, as appropriate, a range of –
- (a) day-time care in homes of disabled children or elsewhere,
- (b) overnight care in the homes of disabled children or elsewhere,
- (c) educational or leisure activities for disabled children outside their homes, and
 - (c) services available to assist carers in the evenings, at weekends and during the school holidays.

Short breaks services statement

- 5. (1) A local authority must by 1^{st} October 2011, prepare a statement for carers in their area (a "short breaks services statement") setting out details of –
- (a) the range of services provided in accordance with regulation 4,
- (b) any criteria by which eligibility for those services will be assessed, and
- (c) how the range of services is designed to meet the needs of carers in their area.
- (2) The local authority must publish their short breaks services statement, including by placing a copy of their statement on their website.
- (3) The local authority must keep their short breaks services statement under review and, where appropriate revise the statement.
- (4) In preparing and revising their statement, the local authority must have regard to the views of carers in their area.

APPENDIX 4

Access to Open Spaces and Beaches for Disabled People

Foreshore and Beaches

There has been a constant improvement of the facilities and services that are available not just to able bodied people but also to mobility impaired public. These services, facilities and access improvements are exampled below and in other appendices attached to the report.

- New Sea Defence Wall (Seaton Carew south) Design and Access Statement Susan Thompson (see Appendix 1)
- Disabled changing and toilet facilities (Seaton north at Coronation Drive and south at Clock tower/Bus Station) Tracy Liveras (see Appendix 2)
- Disabled Parking at Newburn Bridge, Coronation Drive and Rocket House
- All the public beaches have disabled/mobility impaired friendly ramps/routes down onto the sand areas (via Brus Tunnel; Marine Drive, Block Sands and Fish Sands at the Headland, Newburn Bridge; The Cliff and The Front at Seaton Carew)

Open Spaces (Play Grounds, Parks and Recreation Grounds)

When looking to build new or to enhance existing play areas; inclusivity of mobility impairment is paramount in decisions made and has been embedded within the process of play development, through conformity with Disability Discrimination Act 1990 and more recently Equality Act 2010.

For example; some of the play equipment or surface material used is not just mobility impairment friendly in relation to the children who use it but also for the parents/guardians etc, who may be disabled and who may need the right surface material, for them to access the [play area safely, when supervising the children's play time.

With regards to Parks and Recreation Grounds; the Council continue to look to provide, where possible, mobility impaired friendly equipment and facilities for the public, as well as the staff.

For example: Place in The Park Café, Ward Jackson Park - disabled toilets and easy access doors; Grayfields Pavilion, Grayfields Recreation Ground – Disabled/Mobility Impaired Friendly lifts to 1st Floor, Disabled Toilets and Automatic Front Door.

Public and Permissive Local Access network of paths

Around the Borough there is a network of public and permissive rights of way, ranging from footpaths and bridleways to byways open to all traffic. Where possible, the borough's open access has been embedded within the process of managing, maintaining and improving these routes.

More recently, with the enactment of the Equality Act 2010, the Council is actively looking to improve both the path surfaces as well as the associated furniture (gates and stiles). This has been started at the urban fringe of the Town and is extending further into the countryside (the Council is not looking to create a homogenous style of surface or 'look' but to create a more enjoyable 'journey' for the user and visitor).

Surfacing can take the form of many styles and types, ranging from simple re-profiling of the surface, using the existing materials through use of wood chips to aggregate and dust surface materials when the 'traffic' is great. When looking to either repair or replace a stile we now actively work with the landowner to replace the stile with either a self-closing gate or a mobility friendly kissing gate. Our ultimate aim is to reduce the furniture and have gaps in place instead of gates or stiles. However in some circumstances stock control or illegal motorbike use means that certain types of furniture are needed.

The number of paths where new or improved furniture has been installed is increasing year on year due to internal and external funding opportunities.

When the Council receives an application to divert a path, it insists on having existing furniture upgraded or replaced with more access friendly types so that stiles will be replaced with gates

LOTTERY UPDATE

1. TYPE OF DECISION/APPLICABLE CATEGORY

1.1 For information only.

2. PURPOSE OF REPORT

2.1 To inform Neighbourhood Services Committee of the final outturn for 2013/14 in relation to Ward Member Budgets and to provide an update on the Civic Lottery programme.

3. BACKGROUND

Ward Member Budgets

- 3.1 On 30 April 2012, Ward Member Budgets and the associated application and approval framework were approved by Cabinet. Ward Members were allocated £5,500 each to be used for the wider and discernible community benefits of their ward, with further allocations of £5,000 per Ward Member agreed by Council in February 2013 (for 2013/14) and 2014 (for 2014/15).
- 3.2 It is assumed that the budgets are not available for individuals, or intended to be expended on services provided by the Local Authority or other public agencies, unless the purpose is to enhance or supplement what is being delivered. Ward Members are expected to consult each other to ensure that there is no duplication in expenditure and projects supported must be lawful, and cannot undermine the Council or partners' priorities or service delivery.
- 3.3 Procedural arrangements have been implemented to ensure accountability and transparency, with all Ward Member Budget submissions being subject to an approval process under delegated authority of the Director of Regeneration and Neighbourhoods (in conjunction with Legal and Finance Departments). Progress on Ward Member Budgets is reported on a quarterly basis to the Neighbourhood Forums and is published online. In

- addition to this, an annual report is taken to Neighbourhood Services Committee for information.
- 3.4 On 19 September 2013, as part of the 2014/15 budget proposals, Finance and Policy Committee recommended allocating £165,000 from the reserves review to continue Ward Member Budgets in 2014/15 (i.e. £5,000 per Member). On 19 December 2013, Finance and Policy Committee subsequently recommended that the 2014/15 Ward Member Budgets should be topsliced by 20% in order to continue the Environmental Apprenticeship Scheme, and that any unspent funds remaining from the 2012/13 and 2013/14 allocations should be retained and carried forward, in order to continue the Ward Member Budgets programme in future years. This was agreed by Full Council on 6 February 2014.

Civic Lottery

- 3.5 From 1977 until 1982, a Civic Lottery was promoted by Hartlepool Borough Council and a Civic Lottery Grants Fund established. The Civic Lottery ceased in 1982 and restrictions apply to any expenditure of the capital reserve without specific Secretary of State approval. The Civic Lottery Grants Fund is composed of annual interest earned from the capital investment. Interest is credited to this fund using either the interest rate earned on the Council's investments, or the average interest rate paid on the Council's long term borrowings, depending on which is highest. The total funding available for distribution in 2013/14 is £17,023, and this is a rolling programme. The capital investment (£427,000) remains untouched.
- 3.6 In 1989, approval was given by the Secretary of State for an amendment in the Civic Lottery, to include the provision of grants to local charitable organisations. Consent was also given for an increase in the maximum amount that could be awarded from the Civic Lottery from £500 to £2,000 to any one beneficiary. Any further departures from the current criteria would require consent from the Secretary of State.
- 3.7 From August 2013, the administration of Civic Lottery was transferred to Community Regeneration and Development, with each Elected Member responsible for the distribution of £500 of Civic Lottery funding in their ward. The Civic Lottery criterion supports charitable organisations in the delivery of leisure, recreational and environmental projects; thus providing an additional ward level resource, coordinated by Ward Members. Procedural arrangements are in line with the Ward Member Budgets programme, as outlined in Section 3.3.

4. SCHEMES APPROVED IN 2013/14

Ward Member Budgets

4.1 In addition to the total budget allocation of £165,000 for 2013/14, an underspend of £61,397 was carried over from 2012/13. On a town wide level, a total of £207,064 has been approved on over 100 projects and / or

- schemes to date, with £19,333 remaining unspent. Full details can be found at **Appendix A**.
- 4.2 A variety of projects have been funded, with a breakdown per Ward Member attached as **Appendix B**. General areas being supported by Elected Members encompass the following:
 - Contributions to services and / or events delivered by the Voluntary and Community Sector;
 - Works to community buildings;
 - Environmental and horticultural schemes;
 - Apprenticeship and training programmes; and
 - Highways and traffic related projects.
- 4.3 There are some examples of collaborative working across wards, including the following:
 - The town-wide Environmental Apprenticeship Scheme which working in partnership with Hartlepool College of FE has provided work placements for 15 apprentices within the Council's Neighbourhood Management Team for 12 months. The funding to extend this project will be topsliced from the 2014/15 Ward Member Budget allocation; equating to £1,000 per Ward Councillor.
 - The Community Transport Project which assists in the sustainability of the Community Bus service that currently runs through Rural West, Jesmond, Victoria and Headland and Harbour wards in response to a withdrawal of public transport routes.
 - A number of organisations including Hartlepool Carers, Hartlepool Access Group and Hartlepool Voluntary Development Agency (HVDA). have received support from a number of Ward Members in order to support the delivery of their services.
- 4.4 Ward Members in the Fens and Rossmere, Foggy Furze and Victoria wards adopted an alternative approach to the expenditure of their Ward Member Budgets in 2012/13 and allocated a proportion of their funds to establish a community grants programme for local voluntary and community groups to access; this arrangement has continued in 2013/14.
- 4.5 One unapproved scheme has been received in 2013/14, details of which can be found at **Appendix C**.

Civic Lottery

4.6 A total of £4,604 has been approved out of a total allocation of £17,023 to date in 2013/14. The funds have supported a total of nine small to medium scale Voluntary and Community Sector (VCS) groups with assistance provided towards fees, general overheads (including insurance), materials and equipment, and travel costs. A full breakdown of projects supported can be found at **Appendix D.**

5. RISK IMPLICATIONS

- 5.1 Through the implementation of the application and approval framework, a robust and transparent process has been put in place to ensure that the expenditure of Ward Member Budgets and Civic Lottery is for the purpose for which it is intended
- In addition to this, consultation with other Ward Members, the community and key partners is required through the application process for Ward Member Budgets to guarantee that monies are not used adversely and that projects and / or schemes are responding to local need. An annual report is taken to Neighbourhood Services Committee for information on both funding programmes, with specific reports on Ward Member Budgets also considered on a quarterly basis by the Neighbourhood Forums, and available online.

6. FINANCIAL CONSIDERATIONS

Ward Member Budgets

- 6.1 On 14 February 2013, Council approved a recommendation from Cabinet (4 February 2013) allocating a total of £165,000 for 2013/2014 for Ward Member Budgets, equating to £5,000 per Elected Member. As part of this decision, it was also outlined that any underspend remaining from the 2012/2013 allocation would be carried forward by each individual Ward Councillor for their use in the new financial year.
- 6.2 On 19 September 2013, as part of the 2014/15 budget proposals, Finance and Policy Committee recommended allocating £165,000 from the reserves review to continue Ward Member Budgets in 2014/15 (i.e. £5,000 per Member). It was subsequently recommended by Finance and Policy Committee on 19 December 2013 that the Ward Member Budget allocation for 2014/15 be top sliced by 20% (£1,000 per Ward Member) for the continuation of the Environmental Apprenticeship Scheme, and that any unspent funds from the 2012/13 and 2013/14 allocations be set aside and utilised to continue the Ward Member Budget programme post 2014/15. This was agreed by Full Council on 6 February 2014.
- 6.3 Any further allocations in future years will have to be considered as a budget pressure.

Civic Lottery

6.4 As outlined in Section 3.5, the Civic Lottery Grants Fund is composed of annual interest earned from the capital investment. Interest is credited to this fund using either the interest rate earned on the Council's investments, or the average interest rate paid on the Council's long term borrowings, depending on which is highest. The total funding available for distribution in 2013/14 is £17,023, and this is a rolling programme. The capital investment (£427,000) remains untouched.

7. LEGAL CONSIDERATIONS

- 7.1 Within the original Cabinet decision on 30 April 2012 to approve Ward Member Budgets, it was agreed that a delegation of powers to the Assistant Director (Neighbourhood Services)¹ be awarded; this was facilitated through 'executive arrangements' outlined within the Local Government Act 2000 which enables decision making powers to be delegated by the executive, individual Portfolio Holders, or through an Officer. These procedural arrangements also apply to the Civic Lottery programme, as agreed by Finance and Policy Committee on 23 August 2013.
- 7.2 Ward Members Budgets must be used for purposes which originally fell within the 'well being powers' enshrined in the Local Government Act 2000. The well being powers as far as they relate to England have now been repealed under Schedule 1 of the Localism Act 2011 which provides for the 'broader power of competence'. This gives local authorities an explicit freedom to act in the best interests of the community, unless the local authority is prevented from taking that action by common law, specific legislation or statutory guidance. As such, the power of competence can be applied to working in the best interests of Hartlepool Borough Council's Ward Member Budgets.
- 7.3 As outlined in Section 3.6, specific criterion relating to the Civic Lottery Grants Fund is prescribed by the Secretary of State. In 1989, approval was given for an amendment in the Civic Lottery, to include the provision of grants to local charitable organisations. Consent was also given for an increase in the maximum amount that could be awarded from the Civic Lottery from £500 to £2,000 to any one beneficiary. Any further departures from the current criteria would require consent from the Secretary of State.

8. STAFF CONSIDERATIONS

8.1 The Council's Community Regeneration and Development Team provide the administration function for Ward Member Budgets and Civic Lottery including supporting project development, completion of submission and decision record paperwork, and the management of payments. There are no staff considerations in addition to this.

9. ASSET MANAGEMENT CONSIDERATIONS

9.1 As set management considerations are not applicable in this instance.

10. EQUALITY AND DIVERSITY CONSIDERATIONS

10.1 There are no direct Equality and Diversity considerations in relation to Ward Member Budgets.
