## 10. Boys Achieve ment – Bridging the Gap – Scoping Report (Scrutiny Support Officer)

The Scrutiny Support Officer presented a scoping report for the Forums investigation into 'Boys Achievement – Bridging the Gap'.

#### The aim of the investigation

To examine the achievement level of boys in Hartlepool with a view to identifying possible ways of improving performance to bridge the gender gap.

#### The terms of reference for the investigation

- (a) To gain an understanding of national policy issues relating to boys achievement levels and the bridging of the gender gap;
- (b) To gain an understanding of the national and regional picture relating to the gender gap in education achievement levels;
- (c) To gain an understanding of work undertaken nationally and regionally to identify factors affecting boys achievement and the strategies/models identified to address the gender gap;
- (d) To consider examples of good practice in other Local Authorities;
- (e) To examine boys achievement levels in Hartlepool and explore:
  - The reasons for/factors linked to underachievement by boys and the gender gap;
  - (ii) The strategies in place to improve boys achievement levels and close the gender gap; and
  - (iii) The effectiveness of the strategies in place.
- (f) To compare strategies/practices implemented in other Local Authorities, and strategies/models identified nationally, with those in place in Hartlepool with a view to identifying possible areas for improvement; and
- (g) To seek the view s of local residents, parents, children/young people, teachers, school governors and adults other than teachers w orking in schools on the issue.

## 11. Boys Achievement – Bridging the Gap – Setting the Scene (Scrutiny Support Officer)

The Scrutiny Support Officer submitted a report outlining the background to the investigation. Members were advised that boys' achievement and the gender-gap had been a high profile issue since the early 1990s and the Government had introduced strategies through the DFES to address it Locally the issue was one of the key priorities within the Council's Children and Young Persons Plan. Details were also provided of the Local and National Issues which could be given consideration as part of the enquiry.

Concerns were raised that the investigation was too wide ranging for the Forum to consider effectively. This was a national issue and major educational concept and a lot of time could be spent with little to show for it. In addition the fact that the gender gap was smaller than the national average suggested scrutiny could be unnecessary in this case. The Chair acknowledged that Hartlepcol was doing very well on this issue but felt that anything which could assist young people in Hartlepcol ought to be pursued and encouraged. While the gender achievement gap was lower in Hartlepcol than the national average, there was still a gap that needed to be closed.

### 12. Presentation by Children's Services Department

(Assistant Director of Children's Services)

The Senior Advisor, Secondary AFL and Literacy Co-ordinator and KS3 Strategy Co-ordinator gave two presentations on the issue of Boys Achievement — Bridging the Gap. The first — 'The Hartlepcol Challenge' — analysed the performance of the two genders from the foundation stage to GCSEs. The analysis showed that girls always outperformed boys in literacy-based subjects whereas the gender gap was less wide in Maths and Science-based subjects and in some cases boys outperformed girls. The analysis also revealed that there was very little difference between the gender gap in Hartlepool and the national average. Details were given of the action taken so far to remedy the problem and proposals for the future.

Concerns were raised that the scrutiny investigation may be a pointless exercise given the evidence that the gender gap at GCSE was smaller than the national average. How ever it was felt that improvements could be made and so long as girls were outdoing boys improvements should be made.

The second presentation addressed the theme of bridging the gap in boys achievement. This included dealing with different learning styles, self esteem, the barriers to learning for boys and strategies which were amongst the most successful in changing attitudes of boys

As part of the presentation members took part in a number of practical activities, designed to highlight differing forms of learning and roles within teams.

During the debate on the report and the issues raised through the presentations, the following issues were raised by members and responded to be the officers present.

As a general rule are boys better than girls at solving practical problems? The issue was not as "black and white" as that. It depended on the task in hand and the experience of the participants.

Are there statistics available to compare gender achievement in single sex schools? Was it that current teaching styles are more orientated toward females? There were no statistical comparisons available for single sex schools. However this was a complex issue with a whole series of affecting factors to be taken into account.

Did schools which excelled at sports excel in other areas? Officers were unable to confirm this but felt it was probably the case.

With reference to the analysis figures for Key Stage 2 did boys learning drop significantly below Level 4? What was the achievement gap in the lower levels? Officers did not have this information at hand. The Chair requested that it be brought to a future meeting if available.

How relevant were the listed barriers to learning for boys? Officers reported that they had originally come from auditing and analysis of the issues by an acknowledged expert in the field. Officers accepted, however, that this was only one person's opinion and experts were not always right. There would be issues that were not addressed in the list.

What was the function of the parent skills register? This was designed to give fathers more involvement in their sons' education by using their skills with their child. Single parent families would be able to utilise fathers from other families.

Members felt it was clear that the achievement gender gap lay in English rather than education as a whole. This was the area which needed special focus. Members also pointed out that not all children were academically minded; some were more practical.

The Chair thanked the officers for their presentation and for answering members' questions. The Scrutiny Support Officer suggested an invitation be extended to a representative from the DfES for a future meeting, in order to gain a more national perspective on the matter.

#### De cision

That the presentation be received and taken into consideration as part of the Forum's investigation.

The Chair advised that she had received a letter from lain Wright, MPf or Hartlepool, regarding the proposed closure of First Steps nursery and requesting the possible involvement of the Forum in this matter. The Chair requested that members adopt a holding response on this issue.

#### 1. PURP OS E OF THE REPORT

1.1 The purpose of this report is to provide Members of the Forum with an update on the progress that has been made in relation to the Involving Young People investigation six months after the Forum made its recommendations.

#### 2. BACKGROUND INFORMATION

- 2.1 During the 2005/6 Municipal Year Members of the Children's Services Scrutiny Forum conducted an investigation into Involving Young People.
- 2.2 On 16 February 2006 the Final Report of the Children's Services Scrutiny Forum was submitted to Council for approval.
- 2.3 This report has been produced six months after the Committee's recommendations were considered by the appropriate decision-making body and as such provides an outline of the progress made to date in relation to the recommendations made by the Forum.
- 2.4 An updated Action Plan is attached at **Appendix A** with the progress made to date outlined in bold text under the proposed action.

#### 3. OVERALL AIM OF THE SCRUTINY INVESTIGATION

3.1 Members will recall that the overall aim of the Scrutiny Investigation was, "the co-ordination of the development of a strategy to involve young people and the development of mechanisms – identified by the young people themselves – to engage in district affairs."

## 4. DEPARTMENTAL RESPONSE TO THE PROGRESS MADE TO DATE UPON THE DELIVERY OF THE ACTION PLAN

4.1 The attached action plan shows that clear progress has been made in the past six months. Each of the 18 recommendations have been moved forward ensuring a firm base from which to further enhance the participation of children and young people. We are still to develop a brief questionnaire that is to go to schools as identified in action 1b. This action has been delayed in the short term due to a range of factors including the pressures on schools during the summer term. We will now undertake this work during the autumn term. The Children's Services Department has ensured that actions agreed by scrutiny are timed appropriately to fit into all of the plans for which we have responsibility. The Participation Strategy that is currently being developed will provide further opportunities for the involvement of children and young people in service development and democratic process.

#### 5. RECOMM ENDATION

5.1 That Members note the progress to date in relation to the delivery of the Action Plan, and where felt appropriate seek clarification upon the achievement / none achievement of the delivery timescales / recommendations.

#### 1. PURPOSE OF THE REPORT

1.1 To inform Members of the Children's Services Scrutiny Forum that the Children's Fund Manager and representatives from Bamardo's and Hartlepool Young Carers will be in attendance at this meeting to set the scene in preparation for consideration of the three possible options for involvement of young people in the Children's Services Scrutiny Forum.

#### 2. BACKGROUND INFORMATION

- 2.1 Members will recall that during 2005/06 the Forum completed a very comprehensive 'Involving Young People' investigation.
- 2.2 A detailed Action Plan was produced for completion of the reports recommendations and a six-month update on progress against this Plan presented to this Forum earlier in the meeting.
- 2.2 In looking at the Action Plan specific consideration is now needed regarding recommendation 1(e) which requires that 'the Forum actively pursue the possibility of co-opting young people onto the Forum'.
- 2.3 Suggested options for the way forward in involving young people in the work or the Forum are to be considered later in the agenda. In preparation for consideration of these options the Children's Fund Manager and representatives from Bamardo's and Hartlepool Young Carers are to be in attendance at this meeting to give short presentations to set the context and detail what has been done so far.

#### 3. RECOMMENDATION

3.1 That Members of the Children's Services Scrutiny Forum consider the content of the presentations.

**Subject:** Proposals for Involving Children and Young People in

the Scrutiny Process

#### 1. PURPOSE OF REPORT

1.1 The purpose of this paper is to provide options for consideration by Children's Scrutiny Forum members on the practicalities of co-opting children and young people onto the local authority's Children's Scrutiny Forum.

#### 2. BACKGROUND INFORMATION

2.1 Hartlepool Borough Council's Children's Scrutiny Forum has been debating the issue of co-opting young people on to the Forum for some months now and agreed to receive these proposals and options at a meeting held on 7 March 2006. These proposals will build on the ideas discussed by the Scrutiny Forum as part of the investigation into the participation of children and young people into the political process.

#### 3. PROPOSALS FOR CONSIDERATION:

- 3.1 If children and young people are to be involved in the Scrutiny process, it is proposed that the following action points are implemented:
  - a) The timing of future meetings are arranged to maximise the possibility of children and young people attending whatever forum is agreed.
  - b) There is a reduction in the formality of the meetings. Forum members would be able to refer to other group members by their forenames and minutes of the meeting would be produced in a manner that was easy for children and young people to understand. All Forum members would adhere to the current guidelines on confidentiality and would be particularly sensitive when discussing items that directly relate to children and young people. Due to the wide ranging scope of responsibility the forum has, the chairperson may have to make a decision about suitability of agenda items and the running order in which they are taken. The aim should be not to exclude children and young

people from the process. A process of applying pink sheet or confidential status can be applied to items coming to scrutiny. These items could then be discussed in a closed session that children and young people do not attend. The use of such a process would need to be monitored to ensure that it was being evoked appropriately; and that this procedural necessity was explained by the Chair to the children and young people.

- c) That the children and young people involved in the Forum are given media awareness training by Press Relation Officers within the Council.
- d) That the Terms of Reference (including the formal membership) for the Scrutiny Forum are re-written to reflect the involvement of children and young people and any of the above points that are agreed.
- e) That an annual seminar is held that facilitates wider engagement with other elected members and children / young people who are not core members of the Forum. This annual event could be twinned with other similar events or initiatives. ("Big Day" event)

## 4. OPTIONS FOR CO-OPTING CHILDREN AND YOUNG PEOPLE ON TO THE SCRUTINY FORUM:

4.1 In putting these proposals together Tony Brown the Chief Solicitor was consulted and provided the following information:

"In current circumstances, the right to vote on issues before the Scrutiny Forum extends only to the elected members. The exclusion from voting of copted members would apply to children and young persons co-opted to the Scrutiny Forum.

- 4.2 However, it is open to the Council, if and when it sees fit, to adopt a scheme for voting rights for co-opted members on overview and scrutiny committees under provisions introduced by the Local Government Act 2003. Such a scheme may include provisions setting minimum and maximum numbers of co-opted members entitled to vote. At the present time, the power of the Council to make a scheme is unregulated as the Secretary of State has not yet exercised his power to made regulations in this respect. Under the Council's Constitution a voting scheme for co-opted members would first have to be considered by the Constitution Working Party and Committee, before being referred to the Council for adoption."
- 4.3 The following options for involving children and young people are being presented for consideration. It is suggested that the points made in the previous section are implemented to cover all options, with the obvious exception of option one. The strengths and weaknesses of each option have been evaluated.

#### • Option One – No Change

4.4 The Children's Services Scrutiny Forum continues to function in its current format with the existing membership and maintains the status quo.

- Option Two A Shadow Scrutiny process is set up.
- 4.5 This is a process adopted by some organisations as a way of involving children and young people in part of the process. In essence, a group of children and young people would meet with the chair, vice-chair and other nominated members of the forum to discuss issues with them and inform them of those particular issues they want Scrutiny to discuss. The views of this shadow board would then be reflected at the usual scrutiny forum without children and young people being present.

- Option Three Children and young people are given pre-meeting briefings
- 4.6 It is suggested that children and young people are invited to join the Scrutiny Forum and that all the proposed action points made in section 3 of this paper are implemented. It is further suggested that the Children and young people who become members of the group are invited to a briefing, immediately prior to the main meeting, to be held jointly by the Chair of the Scrutiny Forum and the Scrutiny Support Officer. This briefing will act as a mechanism to brief the children and young people involved, analyse the agenda and allow the children and young people to ask questions and seek any points of clarification.

#### • Option Four – Elected members act as mentors

4.7 It is suggested that children and young people are invited to join the Scrutiny Forum and that all the proposed action points made in section 3 of this paper are implemented. It is further suggested that each child or young person invited to become a member of the Scrutiny Forum is affiliated to an elected member who will be responsible for ensuring that the child or young person receives the support they need to become members of the group. It is envisaged that elected members may use other areas of expertise within the Council to help them discharge this proposed mentoring function. It is also proposed that should this option be implemented consideration should be given to including details of this scheme in the Induction Pack and subsequent training for new and returning elected members.

- 4.8 The young people will receive practical support to aid their involvement within the Scrutiny process. For some young people this may mean the enhancement of existing support mechanisms (For example, the young person may already have an allocated personal adviser from Connexions). Practical support will be provided via existing means whenever this is possible as a positive professional relationship between the young person and the support worker should have already been established.
- 4.9 For those young people who do not have a support worker already, practical support and guidance will be provided by staff that have experience of working with children and young people. This may include information, advice, guidance or assistance with transport to attend Scrutiny meetings or prearranged meetings with their mentor. The support worker may also play a coordinating role in ensuring that the young person has contact with their elected mentor.
- 4.10 It is envisaged that elected member mentors, young people and support worker will become a close-knit team developing a positive working relationship around the scrutiny process.

  All support provided to children and young people as part of this trial process will be provided in kind or as part of an organisations daily operational role.
- 4.11 This option would ensure that there was a direct and demonstrable link between the elected members and the children / young people. In addition, children and young people will receive the benefit of experience and may go on to enhance other democratic processes.

#### 5. Number and Selection of Children / Young People to be involved:

5.1 It is proposed that this will be an area of transition and development and that interim measures will be put in place as the component parts of the Participation Strategy (to be produced in 2006) are gradually implemented. It is proposed that as an interim measure that six children and young people will be selected from the Hartlepool Young Voices group. This group is made up of children and young people from a variety of backgrounds and concerted efforts have been made to involve children and young people who have been hard to engage in the past. This group is now well established and acts as a hub for other forums. The six children or young people selected will represent a range of agencies and backgrounds and will be able to channel these wider views into Scrutiny. As well as ensuring there is a gender balance, this representation will also ensure that some of the Town's most vulnerable children and young people are engaged. This initial arrangement will gradually give way to a more democratic process, and the future intention is that children and young people in the Town will be able to vote for their chosen representative. The detail in making this happen will be contained in the Participation Strategy. It is also proposed that children and young people with individual expertise in a given area be invited to join Scrutiny if the discussion on a particular agenda item would benefit from their expert input.

#### 6. CONSULTATION WITH CHILDREN AND YOUNG PEOPLE

6.1 Consultation with children and young people on the proposals contained within this document is currently taking place and will be reflected in the final outcome.

#### 7. SUMMARY AND RECOMMENDATIONS

- 7.1 This paper has presented a number of proposals that can assist in co-opting children and young people on to the Council's Scrutiny Forum. It is suggested that these proposals be implemented regardless of what model of involvement is decided upon.
- 7.2 This paper recognises that maintaining the status quo is an option, however given the obvious desire of Scrutiny members to involve children and young people it is hoped that any further debate will focus on how best to involve children and young people as opposed to whether or not this should occur. Three further options are presented for consideration; these relate to the differing mechanisms required to support the involvement of children and young people. They all have benefits as they ensure there is support and guidance provided directly to the children and young people.
- 7.3 This paper has also made interim suggestions as to the number and selection of the children and young people to be involved; it is suggested that six young people are selected from, and by, the Hartlepool Young Voices group. This is very much an interim measure and will ultimately be replaced by a democratic process that will be introduced via the implementation of the town-wide Participation Strategy.
