# **Report of:** Director of Public Health

Subject: APPLICATION FOR A NEW PREMISES LICENCE, SUPPA OFF LICENCE SHOP, 104 MILTON ROAD, HARTLEPOOL

### 1. PURPOSE OF REPORT

1.1 To consider an application for a new premises licence in respect of Suppa Off Licence, 104 Milton Road, Hartlepool

### 2. SUMMARY OF APPLICATION

2.1 Applicant: Mr Krishna Jeya Siri Krishna Pillai

Premises: Suppa Off Licence 104 Milton Road Hartlepool TS26 8DX

2.2 The applicant has applied for the following activities: -

Supply of Alcohol (Off Sales)

Monday to Sunday 08:00 – 23:00

A copy of the application is attached as **Appendix 1**.

A map of the area is attached as **Appendix 2** and photographs of the premises concerned are attached as **Appendix 3**.

2.3 The premises to which this application relates was previously a computer shop.

# 3. BACKGROUND

- 3.1 The application has been advertised in the prescribed manner and 13 letters and e-mails of objection have been received (appendices 4 11 and appendix 12 which was a pro forma letter submitted by five objectors) plus a petition containing 50 signatures (appendix 13).
- 3.2 The objections collectively refer to, amongst other things, concerns over potential nuisance and anti-social behaviour, safety issues for children going

to school, car parking and litter. Members will note that the petition also refers to a potential for an 'increase in racial tension between community groups'.

- 3.3 The objections which have been received refer to the potential impact of granting the application on the four licensing objectives which are:-
  - Prevention of Crime and Disorder
  - Public Safety
  - Prevention of Public Nuisance
  - Protection of Children from Harm

# 4. **ISSUES**

- 4.1 As relevant representations have been received within the prescribed time period a hearing must be held for Members to consider the application (unless all parties agree a hearing is unnecessary).
- 4.2 Members are advised that the applicant has agreed to the attachment of a number of conditions to the licence, should it be granted, which are aimed at preventing the sale of alcohol to children and reducing potential crime and disorder. These conditions are detailed in Appendix 14.
- 4.3 Members of the sub-committee are reminded that paragraph 4.25 of Hartlepool Borough Council's current Statement of Licensing Policy states the following in relation to licensing hours: -

The licensing authority does not accept that longer opening hours have been a benefit to Hartlepool but rather that they place an undue and unnecessary strain on the local transport infrastructure, Accident & Emergency services and law enforcement agencies and creates a nuisance for those residents who are affected by revellers returning home during the early hours.

Shops, stores and supermarkets will in general be licensed to provide sales of alcohol for consumption off the premises at any time when the retail outlet is open for shopping but licences for before 9:00 a.m. or after 10:00 p.m. in residential areas will generally be refused.

- 4.4 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:
  - i) To approve the application in its entirety
  - ii) To approve the application in part with or without the addition of further conditions
  - iii) To reject the whole or part of the application
- 4.5 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received.

## 5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant and the objectors and determine what aspects, if any, of the application should be granted and, if appropriate, what conditions, if any, should be attached.

Groups will be discouraged from congregating around the premises

d) The prevention of public nuisance

Training records, signed by both the staff member and the Designated Premise Supervisor/Store Manager/Business Owner will be retained for future reference and shall be updated at least every 6 months. All staff training records will be made available to the Licensing Authority and/or Responsible Authorities upon request.

e) The protection of children from harm

A 'Challenge 25 Policy will be implemented with all staff insisting on evidence of age from any person appearing to be under 25 years of age and who is attempting to buy alcohol. There shall be notices displayed at all points of sale and at all entrances and exits to inform customers and remind staff that the premise is operating a 'Challenge 25' policy.

. Only UK "photo card style" driving licence valid non – expired Passport identification (id) is to be accepted as a form of id at the premises.



If, however, the licence also authorises the use of the premises for the supply of alcohol or the provision of late night refreshment, a fee will be required.



### Dear Sir/Madam,

I am writing this letter to object to the proposed opening of an off licence type establishment on the corner of Milton Road and Tankerville Street.

Whilst you as an individual or a company are only interested in the financial returns emanating from a business venture, I am a resident in the area for more than thirty years who has seen the devastating impacts of alcohol being sold from this very location.

The area already has levels of anti-social and criminal behaviours and it is evident that some of the residents take pleasure from sitting outside their houses whilst drinking copious amounts of alcohol. You will only add to this by opening such an establishment and further encourage such behaviours.

There has been a history of people purchasing alcohol and drinking it on the street corners or the nearby school field. Again you will be adding to this except you do not have to deal with the direct ramifications of verbal and physical abuse and threats of violence from individuals stood intoxicated in the street. We have experience of this. Our children witness this. Our friends and families have been victims of this. I would be really interested to know what your views would be if either you or your children faced the same situation on your doorstep. No doubt you would strongly object.

There is an elderly people's home and often these fragile people are seen walking to and from their residence. I have no doubt whatsoever they would feel very vulnerable walking past people who are congregating on street corners and being highly vocal whilst under the influence.

Notwithstanding the above there are already a number of shops selling alcohol within a half a mile radius so why is there a need for yet another one. I can recall about four shops all within a 5 minute walking distance. A cheap outlet will only attract scum from further afield and encourage them to buy and drink on our doorsteps.

Any decent member of society will travel to appropriate vendors and purchase alcohol should they wish to consume it. With this there is a guarantee they will take it home and

drink within the confines of their property. An off licence supports sales of cheap alcohol which is then consumed by those who purchase it as they walk around. They then sit outside their properties and abuse those that either walk past or are within earshot. You are continuing to encourage this instead of denouncing such irresponsible behaviours. Why don't you do something meaningful and instead open a training provision and get these vile individuals into something constructive in order to minimise their lack of aspiration.

You might be of the view that some of these objections are a bit far fetched but I personally have the stories and scars resulting from incidents that started directly with the purchase of alcohol from these very premises. I do not wish to continue fighting these battles again. I spent a long part of my working life aiming for a relatively peaceful retirement. The sad part of all this is that I have limited control over this because of a lack of community awareness and greed by individuals such as yourself.

I really do hope you see sense in this and object to the opening of an off licence. Whether you do or not will poignantly reflect on you and what you wish to achieve within the local communities.

I am writing in respect to the proposed opening of an off licence in Tankerville street / Milton road.

I am concerned that you would allow for this because firstly there are a number of similar kind if shops within a few minutes of each other. Within a two or three square mile radius there are likely to be no fewer than four establishments so why is there an inherent need to promote the use of alcohol in this society and make it more openly and cheaply available to the masses.

This area already suffers from significant amounts of anti social and criminal behaviours and frequently people are standing outside their houses drinking. Another establishment of this kind will merely reinforce that view and these people will now be able to stagger to the end of the block to purchase cheap two or three pounds worth of alcohol to fuel their insatiable desires.

I have three young children who walk to and from school and on an evening go to either family or friends houses. They are already very sceptical about going outside because of what the area boasts so they might as well stay indoors all year around.

We, the undersigned submit this petition in objection of the proposed offlicence at 104 Milton Road, Hartlepool, as we believe that if this proposal goes ahead it is likely to:

Increase Racial tension between community groups - caused by youths hanging around the premises. Milton Road is an extremely diverse area with Pakistani, Bangladeshi, Kurdish and White British families living there and has already experienced problems in the past between youths from various groups and with large numbers of Asian children leaving at the same time to attend mosque, clashes will be inevitable.

**Put elderly people more at risk** – An off licence was opened before in the same place and an elderly Asian man was attacked by a white youth. The attack left elderly members of the community feeling scared and vulnerable and prevented them from leaving the house in the evening.

*Increase in Alcohol related crime and vandalism* - including damage to residential properties and vehicles, which we have already seen on Grange Road when people are leaving bars and pubs after having had a drink.

*Increase in the amount of litter and rubbish in the area* – causing problems with smell and hygiene.

*Increase in underage drinking* – as there are already a number of off licences in the area and more access to alcohol is only likely to increase the problem.

*Increase the amount of traffic* - in a quiet residential street putting young children more at risk and increasing the noise in the area.

Further to your recent correspondence concerning the above. I confirm that if the above application is successful, I am willing to accept that the following legally binding Condition be attached to the Operating Schedule.

### Conditions

- 1. A "Challenge 25" policy will be implemented with all staff insisting on evidence of age from any person appearing to be under 25 years of age and who is attempting to buy alcohol. There shall be notices displayed at all points of sale and at all entrances and exits to inform customers and remind staff that the premises is operating a "Challenge 25" policy.
- Only valid passports, UK "photo card style" driving licences, PASS approved proofof-age cards or Ministry of Defence "Form 90" identification cards shall be accepted as proof of age.
- 3. Before any person is authorised to sell alcohol they must have attempted the Alcohol Sales written test (Document TSAS1 as produced by Hartlepool Trading Standards). The completed test must have been assessed, signed and dated by a person whom the Premises Licence Holder deems competent to do so. This written test must be retaken at least every three years.

A person is only be permitted to supply alcohol after completing the test to the satisfaction of the Premises Licence Holder (or a suitable person who has been delegated this responsibility)

The completed Test forms shall be made available to Responsible Authorities for inspection upon request.

Hartlepool Trading Standards can temporarily suspend or amend this requirement by way of written notification.

- 4. The business will maintain a refusals book to record all instances where the sale of alcohol has been refused. This shall include the date and time of the attempted sale, together with a description of the incident. The Designated Premise's Supervisor/Store Manager/Business Owner will check and sign each page and the refusals book will be make available to the Licensing Authority and/or Responsible Authorities upon request.
- 5. There will be a minimum of two notices displayed on the premises indicating that the sale of alcohol to those under the age of 18 is illegal and that those adults who buy alcohol for immediate disposal to those under the age of 18 are committing an offence.
