Subject: CIVIC LOTTERY GRANT APPLICATIONS

1. PURPOSE OF REPORT

1.1 To consider Civic Lottery Grant Applications.

2. BACKGROUND

2.1 In accordance with the procedure previously approved by Members, the current criteria for eligibility and distribution from the Civic Lottery Fund requires Members to consider applications three times a year in order that an overall view of applications can be obtained.

2.2 This is the third a final tranche for consideration of applications. Members previously agreed to distribute the balance available at three meetings proportionately. Normally the amount of grants requested outweighs the allocation available. In that case, awards are usually made on a pro rata basis. In this tranche the sum of the grants sought totals £2,030. Each of the three tranches were allocated £5,633 at the start of the financial year. However, following the allocation of grants in the second tranche there was a balance of £4,486, which has been added to this tranche's balance. Therefore a total of **£10,119** is available for distribution. In this tranche, Members will be able to fully support each of the grant applications
