Procedure for Hearings

6. Representations by responsible bodies and/or interested parties and witnesses introduced where appropriate.
7. Questions by Members to responsible bodies/interested parties and/or their witnesses.
8. Parties may question and clarify issues raised with the consent of the Chair.
9. If required, responsible bodies/interested parties to be given opportunity to sum up.
10. If required, the applicant to be given opportunity to sum up.
11. Members to have the opportunity to clarify any points raised. The Chair shall ask whether all parties are satisfied they have said all they wish to.
12. Members to go into closed session to deliberate.
13. Chair informs parties of their decision, with reasons.

Report of: Director of Public Health

Subject: Application for a Premises Licence – Kullar News and Booze, 2 & 3 Brus Corner, Hartlepool

1. PURPOSE OF REPORT

- 1.1 To consider an application for a new Premises Licence in respect of Kullar News & Booze, 2 & 3 Brus Corner, Hartlepool.

2. BACKGROUND

- 2.1 Applicant: Mr Gurvir Singh Kullar

- 2.2 The applicant has applied for a licence to supply alcohol from the above premises during the following times: -

Supply of Alcohol (Off Sales) Monday – Sunday 08:00 to 22:00

A copy of the application is attached as **Appendix 1**.

A Map of the area is attached as **Appendix 2** and a Street View image is attached as **Appendix 3**.

- 2.3 The initial application was to supply alcohol from 07:00 to 22:00 throughout the week, but, in agreement with Cleveland Police, the applicant has subsequently amended the start time to 08:00, as detailed above.

- 2.4 The application has been advertised in the prescribed manner and three representations have been received from local residents.

Copies of the representations are attached as **Appendices 4, 5 and 6**.

- 2.5 A number of conditions that will be attached to the licence, should it be granted, have been agreed following discussions between the applicant, Environmental Health and the Police. These are designed to reduce the possibility of sales of alcohol to children and the installation of a CCTV system and the applicant's acceptance of them have resulted in there being no objections from either Environmental Health or the Police.

- 2.6 The objections that has been received refer to the potential impact of granting the application on the four licensing objectives of: -

- Prevention of Crime and Disorder
- Public Safety
- Prevention of Public Nuisance

- Protection of Children from Harm

2.7 Among the issues specifically raised by the objectors are that selling alcohol at the proposed times and location would increase the problems already being experienced by local residents.

3. ISSUES

3.1 As relevant representations have been received a hearing must be held for Members to consider them and determine whether, and under what terms, a licence should be granted (unless all parties agree a hearing is unnecessary).

3.2 The applicant is currently the holder of a Premises Licence which authorises the sale of Alcohol (Off Sales) at 14 Brus Corner (Kullar News & Booze) and has stated that he intends to surrender that licence should this licence application be successful.

3.3 The proposed times to supply alcohol fall outside of the Council's current Statement of Licensing Policy.

3.4 Members are reminded that paragraph 4.25 of the Council's current Statement of Licensing Policy states: -

The licensing authority does not accept that longer opening hours have been a benefit to Hartlepool but rather that they place an undue and unnecessary strain on the local transport infrastructure, Accident & Emergency services and law enforcement agencies and creates a nuisance for those residents who are affected by revellers returning home during the early hours.

Shops, stores and supermarkets will in general be licensed to provide sales of alcohol for consumption off the premises at any time when the retail outlet is open for shopping but licences for before 9:00 a.m. or after 10:00 p.m. in residential areas will generally be refused. In addition, licence applications for the supply of alcohol for consumption on the premises for before 9:00 a.m. or after 11:30 p.m. in residential areas will generally be refused.

In non residential areas applications for licences to allow the sale of alcohol or the supply of late night refreshment beyond 2:00 a.m. will normally be refused subject to relevant representations being received.

3.5 The above paragraph should be read in conjunction with paragraph 4.3 of the policy which states: -

In determining a licence application the overriding principle adopted by the licensing authority will be that each application will be determined on its individual merits.

3.6 Members of the sub-committee are reminded that they must only consider those aspects of the objections that relate specifically to the four licensing objectives which are: -

- i) The prevention of crime and disorder
- ii) Public safety
- iii) The prevention of public nuisance, and
- iv) The protection of children from harm

3.7 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:

- i) To approve the application in its entirety
- ii) To approve the application in part - with or without the addition of further conditions
- iii) To reject the whole or part of the application

4. RECOMMENDATIONS

4.1 That Members consider the representations made by the applicant and the objectors and determine what aspects, if any, of the application should be granted and, if appropriate, what conditions, if any, should be attached.

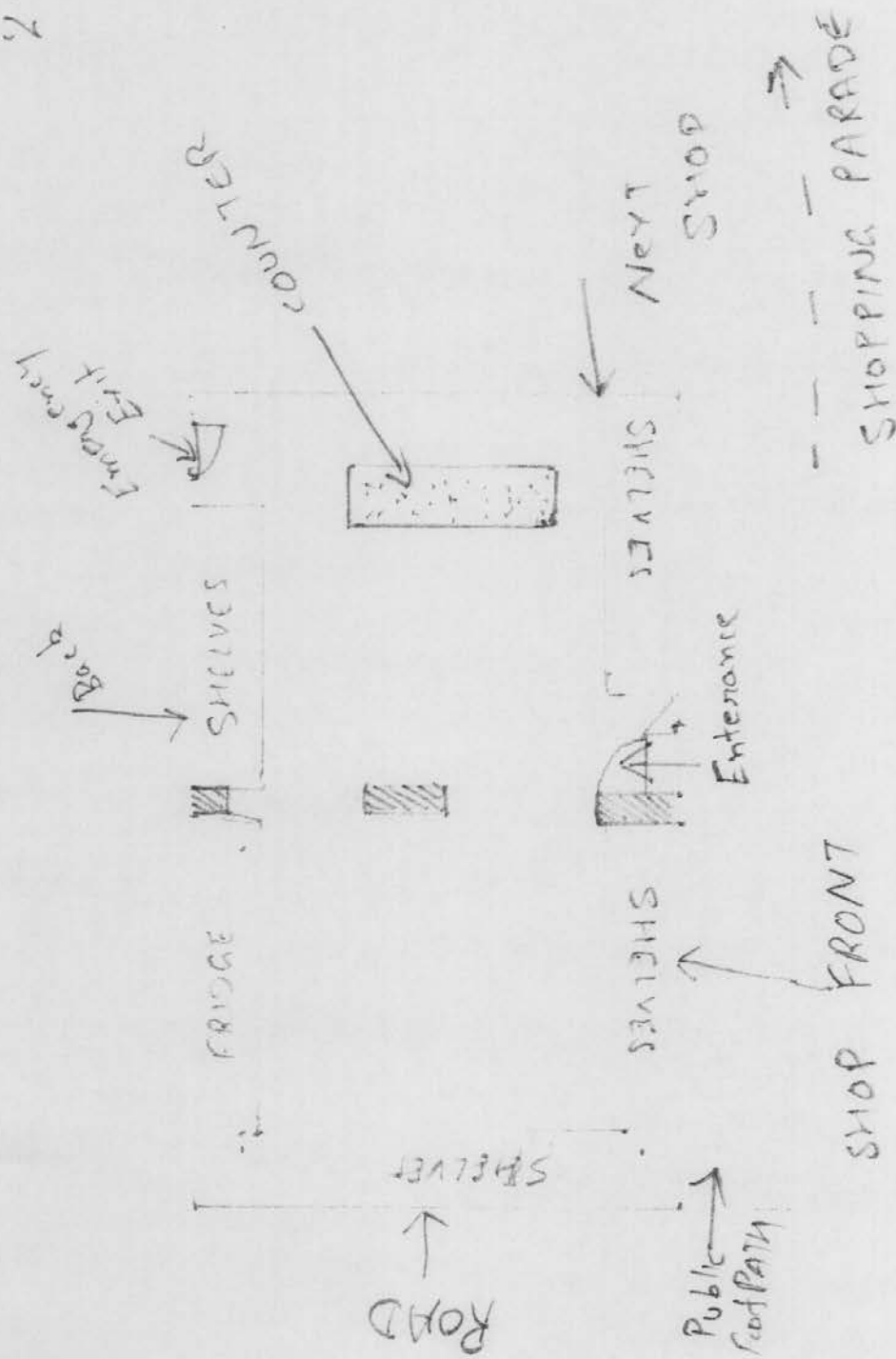

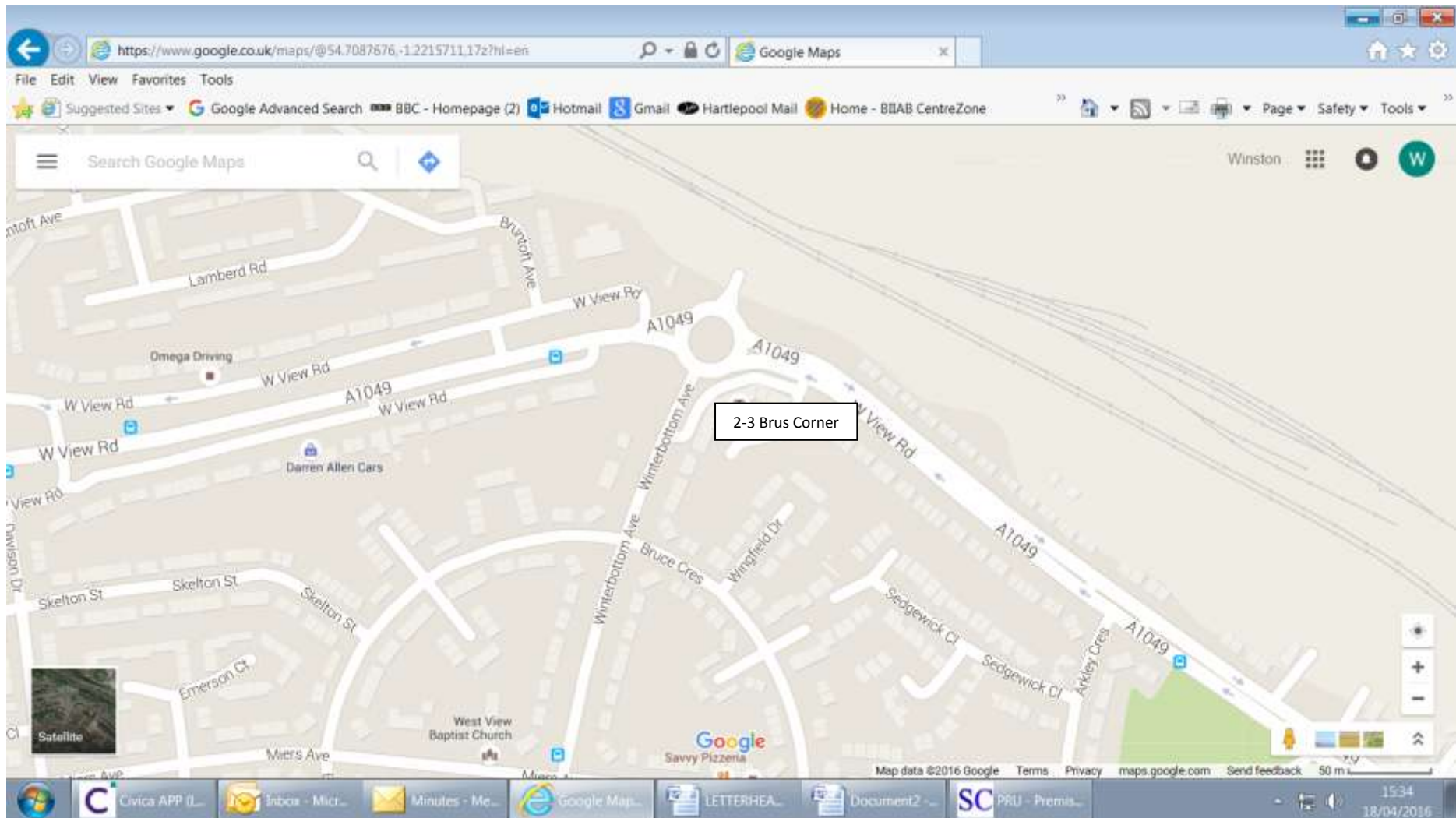

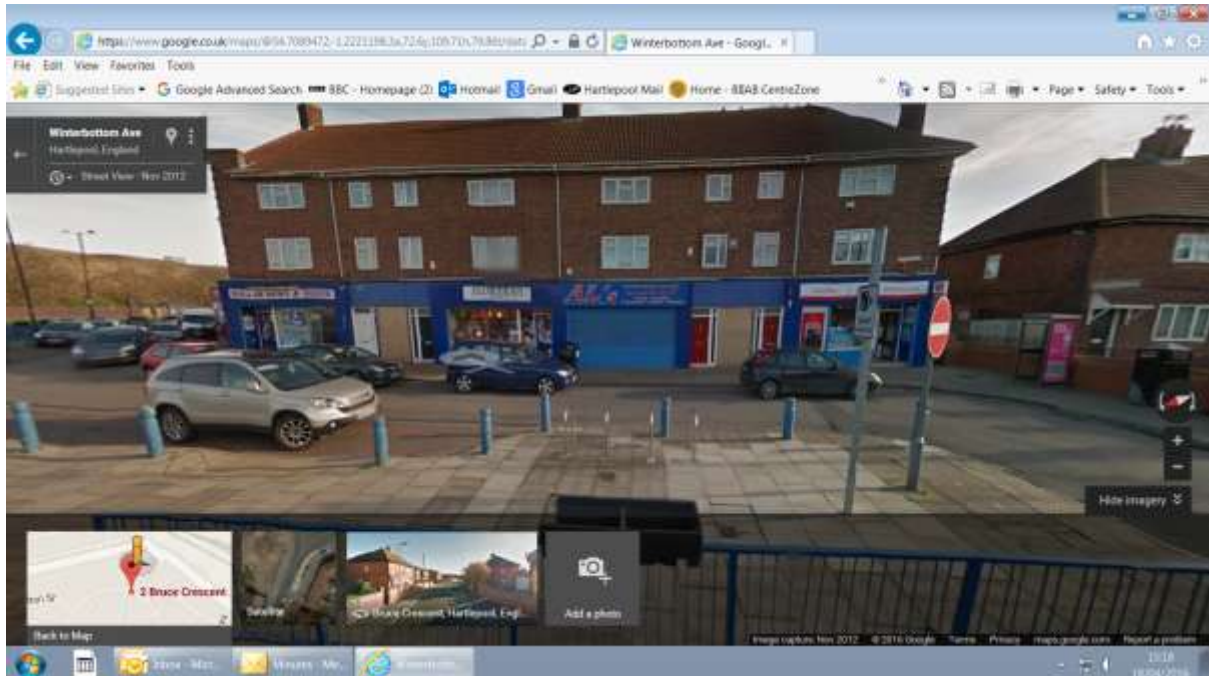

In this area within 1 mile 7 off licence shop and Iceland serving alcohol to community.
