17. NOTES FROM MEETING HELD ON 8 FEBRUARY 2016

18. INTRODUCTION AND PRESENTATION – MENTAL HEALTH SERVICES

The Chair outlined the key focus for this meeting which was Mental Health Services. A presentation was provided by representatives from Tees, Esk and Wear Valley NHS Foundation Trust (TEWV). Further details were provided around the national and local context and the recent changes to the service provision for Mental Health. The presentation outlined the services commissioned by the Clinical Commissioning Group and Hartlepool Borough Council. The representatives from TEWV concluded by summarising the vision for the future of Mental Health services and the plans for local engagement through the Mental Health Forum and the Local Government Association.

The Working Group moved into two break-out sessions to consider the following:

Mental Health Services

- 1) What services have you used?
- 2) What worked well?
- 3) How could they have been improvement?
- 4) Priorities for the future.

Upon return from the break-out sessions, each group provided the following feedback:

Group 1

Education, training and raising awareness with professionals and public and ensuring easy access as early as possible to make certain that the first assessment counts with all options available being considered, including self help and IT solutions, not just prescribing medication.

Better integration with health services and local authority services.

Group 2

Increase and improve navigation to services and ensure they were facilitated, raising awareness of services available including online and face to face.

Better use of community and voluntary sector as they have a key role to play to support individuals in their home and help patients navigate services.

Working together for change document to be considered in developing the Local Health and Social Care Plan Working Group. A discussion ensued on the support for baby bereavement group which was provided by one volunteer in the town and was a well used and much loved service which had been provided for a number of years. However, there was concerns expressed at the level of reliance on the community and voluntary sector across the town, such as MIND where there was a waiting list for appointments in operation. A representative from TEWV referred to the development of community based services including a liaison service, crisis service and a children's service.

In response to a question from the Chair, a representative from TEWV confirmed that there was support provided to all employees of TEWV in the form of an in-house counsellor, occupational health services and referral to a psychologist who would support staff who were struggling with work related issues.
