Subject: APPLICATION FOR A NEW PREMISES LICENCE IN RESPECT OF 34A DUKE STREET, HARTLEPOOL

1. PURPOSE OF REPORT

- 1.1 To consider an application for a Premises Licence in respect of 34A Duke Street, Hartlepool.

2. BACKGROUND

- 2.1 Applicant Thai Pan Limited

Premises 34A Duke Street
Hartlepool

3. SUMMARY OF THE APPLICATION

- 3.1 The applicant has applied for a new Premises Licence for the following activities: -

Sale of Alcohol Mon – Sat 0900 - 2230

- 3.2 A copy of the application is attached as Appendix I.

- 3.3 The application has been advertised in the prescribed manner and five representations have been received from **interested parties** (including one petition). These are attached as Appendices II – VI.

- 3.1 The nature of the objections received can be summarised as follows:

- Extension of hours would cause nuisance and adversely affect residents' quality of life
- Potential impact on public safety caused by increased traffic congestion.
- Proximity to residential accommodation and potential late night disturbance and anti-social behaviour

- 3.2 Following receipt of the above representations, and in compliance with statutory requirements, a Notice of Hearing has been sent to the applicant and those parties making relevant representations.

4. ISSUES

- 4.1 As relevant representations have been received within the prescribed time period, a hearing must be held for Members to consider those representations (unless all parties agree a hearing is unnecessary).
- 4.2 Members are advised that the original application received in respect of these premises requested permission for the sale of alcohol and late night refreshment until midnight, Monday to Sunday. All representations received referred in part to the proposed closing time.
- 4.3 Following receipt of representations the applicant has now amended their application and it now relates solely to the supply of alcohol until 2230 hours, with the premises being closed on Sundays in line with recently granted planning permission. Permission for late night refreshment is no longer required.
- 4.4 Due to the lateness of the amendment it has not been possible, at the time of drafting this report, to establish whether any interested parties now wish to withdraw their representations.
- 4.5 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:
- 1) Grant the application without amendment
 - 2) Grant the application with conditions, or amended conditions
 - 3) Reject those parts of the application that are relevant to the representations received
- 4.6 The licensing objectives are:
- 1) the prevention of crime and disorder
 - 2) public safety
 - 3) the prevention of public nuisance; and
 - 4) the protection of children from harm
- 4.7 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received

5. RECOMMENDATIONS

- 5.1 That Members consider the representations made by the applicant and interested parties and determine what aspects of the application, if any, should be granted and, if appropriate, what conditions, if any, should be attached.

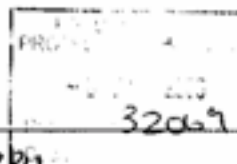

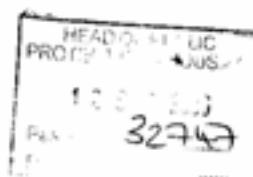



This is a letter of objection against that application. When the Thai pan approached the council of relocation to duke street it was on the understanding that it would keep the same opening times (5:30 to 10:30, six days a week). In the Thai pans own words this closing time contributed to no complaints of noise disturbance in the area. Now this shop wants to stay open longer (Midnight and 7 days) than the current two shops and the club in Duke Street that sells alcohol.

This late opening time and the selling of alcohol will bring people from the surrounding areas to this shop to buy alcohol, causing a disturbance late at night (people talking and shouting, car doors slamming, engines revving, etc) knowing this is the only shop in the area that opens late to sell alcohol.
