1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a premises licence for Trinity Guest House, Church Street, Seaton Carew.

2. SUMMARY OF APPLICATION

2.1 Applicant: Mr Lee Pennick

Premises: Trinity Guest House

Church Street Seaton Carew Hartlepool

- 2.2 A copy of the existing premises licence, detailing current licensed activities, is attached as **Appendix 1**.
- 2.3 A copy of the application to vary the licence is attached as **Appendix 2.**
- 2.4 A map of the area and street view images are attached as Appendices A & B.
- 2.5 In summary, the applicant has applied to extend the hours for the sale of alcohol to 0900 2300 hours seven days a week (current hours are 17:30 22:30 Monday Saturday and 12:00 16:30 on Sundays).

3. BACKGROUND

- 3.1 The application has been advertised in the prescribed manner and ten representations have been received all from Hartlepool residents (**Appendices 3 12**).
- 3.2 All of the representations refer to the potential for nuisance should the application be granted.

4. ISSUES

- 4.1 As relevant representations have been received a hearing must be held for Members to consider the application (unless all parties agree a hearing is unnecessary).
- 4.2 Members may wish to note that there is a condition on the current licence stating "Alcohol shall only be supplied as part of a table meal" and the applicant has not requested that this condition be removed. The breach of a licence condition is a criminal offence.
- 4.3 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:
 - i) To approve the application in its entirety
 - ii) To approve the application in part with or without the addition of further conditions
 - iii) To reject the whole or part of the application
- 4.4 The licensing objectives are:
 - i) The prevention of crime and disorder
 - ii) Public safety
 - iii) The prevention of public nuisance, and
 - iv) The protection of children from harm
- 4.5 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received.

5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant and the objectors and determine what aspects, if any, of the application should be granted and, if appropriate, what conditions, if any, should be attached.

ANNEX 1 – Mandatory Conditions

- 1. No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
 - Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 2. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

 (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 (ii) drink as much alcohol as possible (whether within a time limit or otherwise):
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—

 (i) the outcome of a race, competition or other event or process, or
 (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 3. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other

person is unable to drink without assistance by reason of a disability).

- 4. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 6. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

ANNEX 2 – Conditions consistent with the Operating Schedule

- 1. A CCTV system shall be operational during all trading hours and, where more than one camera is in operation, at least one shall be permanently directed at the sales counter so as to record all sales taking place.
 - Images recorded by the system shall be retained for a minimum of 28 days and shall be made immediately available to police officers or other authorised officers on request.
- 2. There shall be in place a written policy to prevent the sale of supply of alcohol to persons under 18 years of age. That policy shall require any person who appears to be under the age of 21 to produce a recognised proof of age card accredited under the Proof of Age Standards Scheme (PASS), a photo driving licence, a passport or official HM Forces or EU ID card bearing photo and date of birth.
- 3. At least one notice shall be displayed at the entrance to the premises where it can be clearly seen and read and shall indicate that it is unlawful for persons under 18 years of age to purchase alcohol or for any person to purchase alcohol on behalf of a person under 18 years of age.
- 4. A written record shall be maintained detailing the training provided to each member of staff authorised to sell or supply alcohol. Such a record shall be signed by the member of staff to confirm the date that such training took place.
- 5. The licence holder shall implement a policy of regular monitoring and review of all staff authorised to sell or supply alcohol. Such a policy shall include periodic analysis of CCTV footage.
- 6. Notices shall be displayed in prominent positions requesting patrons to be respectful and quiet when they leave the premises, so as not to cause public nuisance to residents nearby.
- 7. Unaccompanied children are prohibited from the premises.
- 8. Alcohol shall only be supplied as part of a table meal.
- 9. Doors and windows shall be closed at all times to reduce noise.
- 10. Deliveries shall be made via the back entrance to the premises.
- 11. Internal signage shall be displayed detailing free parking areas nearby.
- 12. The licence holder shall liaise regularly with all relevant authorities to ensure public safety at the premises.







I wish to oppose the Premises Licence Variation - Trinity Guest House/Tea Rooms, 5 Church Street, Seaton Carew -

- The current location is small quiet terraced street within a conservation area of Seaton Carew. The street has families located next door and directly opposite the proposed premise. (photo attached) We collectively are very concerned about allowing the Trinity premise have an extended drinks permit for numerous reasons.
- The premise has had numerous police attended incidents in the past relating to anti-social behaviour, primarily drunken guests spilling into the street rowing or unable to get into the guesthouse leaving keys inside. This goes without saying the unattended police incidents we've had to listen to on a regular basis! With no onsite management they are left to kick the door to arouse other guests when they can't gain access or rely on us residents to call police when events get out of hand. Guests continue to smoke on the street disposing of cigarette buds where they like. This all occurs with the current permit in place I'm in no doubt this will become a regular thing should the new proposed hours be passed.
 - The streets residential parking is directly to the front of the proposed premise —leaving trade will potentially cause damage after a late nights drinking having to pass through cars to cross the road or get into any awaiting taxi. I personally would not want my car used as a drunken barrier! I have previously had a drunken guest kick the front of my vehicle & try to get in when I was leaving my address this occasion the police attended. I feel by extending the alcohol license anti-social behaviour will increase and become a real problem no doubt turning the premise into local pub instead of a guest house. We don't need our quiet street turning into a undesirable location to live due to this irresponsible requirement for an extended drinks license. The noise from music has been noted several times in the past which would certainly be a ongoing disturbance to the locality single glazed windows retain no noise. With local residents attending work or children school we do not wish to be hearing people leaving a premise at after 11pm 7 nights a week in a street that otherwise deadly silent. We would also certainly see increased noise traffic / taxi drop offs/collections in the street until who knows what time of the night. The street is a single pass lane & the increased traffic during the day will endanger the local residents/ children & elderly care home residents out walking. The issues surrounding excessive vehicles has been a cause for concern since the premise has started offered a 'food carvery' each Sunday causing chaos in the street with parking & passing this will only worsen an already frustrating issue.

I cannot see why a guest house requires a license for such extended periods to satisfy guests when the street already has a fully functioning pub at the end of the road – also several on the sea front with active permits. The

location of the proposed extended hours is a quiet family orientated street with a purpose built young gentlemen's disabled home & elderly care home within the same street. I struggle to see this causing anything but problems with passing trade & anti-social behavious Mesticina conservation area buying properties fully expecting a quiet setting- not to live beside a licensed bar operating until 11pm with no on site management. For all the reasons above I OPPOSE the extended drinks license application.

Objection of the grounds of public nuisance/noise

1. I object firstly as our family live next door at no 7 Church St to the premises and the licensing hours put in place already where done so by the council to have some consideration for us/the neighbours and the noise that comes from the premises especially when people come to and vacate from the property whilst waiting for taxis/or waiting to be picked up...the noise from the people when they waiting outside of our houses/living room windows as clients from the premises can be very loud.

People usually stand around in front of our living room windows area when waiting for taxis etc.

2. There is **no sound proofing** in the walls at present. **Is there going to be sound proofing put in the walls?**

The walls are not thick where the fire breast recesses are in both downstairs living rooms, so sound proofing would benefit us all.

Existing noise up to now from clients when in use is constant scraping of chairs/tables across the floor, clanking of bottles and the cheerful/lively voices of the clients behind the walls.

We as a family up to now have been tolerant when the premises has been in use but only because we knew the **current licensing hours** means we all know when we can go to bed and have a quiet undisturbed sleep.

We work too.....we are also carers of my son who needs 24 hour care and do not need to have the extra stress of being kept awake until a later time from extended licensing hours noise.

Half an hour extra in premises also equates to another half hour on top of this to **leave** the premises. This is not fair on our family or that of the neighbours living in the street. They need to sleep too...Peoples loud voices, taxis, vacating the property would affect our home life.

3. **The present** licensing hours work ok at the moment by us residents/neighbours being **tolerant**, but **not** to extended evening times.

Please, please keep the existing opening hours the same. We need to rest after work and we are carers too.

We have lived here over 20 years and have experiences of late night noise/events coming from this premises even during lockdown and speak with experience. This has been an issue for a few reasons.

Finally. I just want to reiterate we all wish any business well but **not** at the cost of us living next door and not to the the residents across the road who some have young children and already have moved their bedrooms to the **back** of their house because of the noise that did occur. We have had previous experiences with noise from clients leaving the premises and I have myself addressed this to the last Manager/ and owner of the premises and so has neighbours. However we have been very **tolerant**.

The current licensing hours were allowed by the council to take into consideration the views of the neighbouring properties/people. This is what was said at the original appeals meeting as I was there.

The current finish times at present works ok. PLEASE do not extend by even half an hour....as then vacating premises time by people is also added on top of this too/ and so it the noise factors.
