Procedure for Hearings

Subject: APPLICATION TO VARY A PREMISES LICENCE IN RESPECT OF HORNBY PARK, ELIZABETH WAY, SEATON CAREW.

1. PURPOSE OF REPORT

1.1 To consider an application for the variation of a premises licence for Hornby Park, Elizabeth Way, Seaton Carew.

2. SUMMARY OF APPLICATION

- 2.1 Applicant: Hornby Park Ltd Premises: Elizabeth Way Seaton Carew Hartlepool
- 2.2 A copy of the application is attached as Appendix 1.
- 2.3 A map of the area is attached as Appendix 2 and street view images are attached as Appendix 3.
- 2.4 At present, the premises licence only authorises licensable activities on Saturdays and Sundays until 19:00 hours. The application is to extend trading to as late as 23:30 hours, seven days a week.

3. BACKGROUND

- 3.1 Hornby Park operates as the venue for Seaton Carew Community & Sports club and currently has a *club premises certificate* to authorise most of its licensable activities. A copy of the club premises certificate is attached as Appendix 4.
- 3.2 A club premises certificate is similar to a premises licence but only authorises licensable activities when the premises is operating as a private members club (a 'qualifying club').
- 3.3 As can be seen from Appendix 4, the club premises certificate authorises licensable activities until as late as 0100 hours seven days a week.
- 3.4 As a club premises certificate is for 'members only', Hornby Park obtained a premises licence in 2009 allowing them to sell alcohol and provide

entertainment to members of the general public on Saturdays and Sundays. A copy of the premises licence is attached as Appendix 5.

3.5 The application to vary the licence has been advertised in the prescribed manner and five objections have been received – all from local residents and all relating to the potential for noise nuisance. These objections are attached to the report as Appendices 6-10.

4. **ISSUES**

- 4.1 As relevant representations have been received a hearing must be held for Members to consider the application (unless all parties agree a hearing is unnecessary).
- 4.2 Hornby Park Ltd has applied to extend the hours and days on which they can offer licensable activities to the general public.
- 4.3 Hornby Park Ltd has indicated that if the variation of the premises licence is granted, they will surrender the club premises certificate.
- 4.4 The area covered by the premises licence, and this application, applies to both the clubhouse and the outside playing fields area.
- 4.5 The law relating to the licensing of regulated entertainment is, unfortunately, complicated.
- 4.6 Due to the government's de-regulation of regulated entertainment, the provision of live and recorded music, even from an outside venue, is not licensable unless the audience is more than 500 people (at any one time) or it takes place after 2300 hours.
- 4.7 Where there are fewer than 500 people and it is before 2300 hours, the entertainment is not licensable and cannot be prevented, or regulated, by a licence.
- 4.8 However, due to the nature and size of Hornby Park, it is reasonable to assume that there may be events that take place where the audience exceeds 500 and therefore it is appropriate for the licensing sub-committee to consider whether music being played to an audience of over 500 people should be permitted and, if it is, whether it would be appropriate to regulate it by means of conditions or restricted hours/days.
- 4.9 Any restrictions or conditions imposed would have no effect where the audience is under 500 or it is not yet 2300 hours.
- 4.10 Where live or recorded music is provided to fewer than 500 people and before 2300 hours and it causes a noise nuisance, a review of the premises licence can be applied for by any affected party. One of the options available at the subsequent licence review hearing is for the sub-committee to 're-regulate'

the musical activity that has caused the nuisance and either ban it, or regulate it (by hours restriction and/or conditions).

- 4.11 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:
 - i) To approve the application in its entirety
 - ii) To approve the application in part with or without the addition of further conditions
 - iii) To reject the whole or part of the application
- 4.12 The licensing objectives are:
 - i) The prevention of crime and disorder
 - ii) Public safety
 - iii) The prevention of public nuisance, and
 - iv) The protection of children from harm
- 4.13 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received.

5. **RECOMMENDATIONS**

5.1 That Members consider the representations made by the applicant and the objectors and determine what aspects, if any, of the application should be granted and, if appropriate, what conditions, if any, should be attached.

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

- 1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
- 2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display
 of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day,
 provided that the audience does not exceed 1000. Combined fighting sports defined as a
 contest, exhibition or display which combines boxing or wrestling with one or more martial
 arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting
 event.
- Live music: no licence permission is required for:
- a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
- a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- a performance of amplified live music between 08.00 and 23.00 on any day, at the nonresidential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
- any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the

relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.


- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
- any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
- any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
- any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
- any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.



 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that–
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

 (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

Applications for consent, giving detailed descriptions of the equipment to be used and details of the event, including dates and times must be made not less than 28 days before the date of the event.

- 3. The licensee must ensure that the electrical socket outlets in the licensed premises, which are used for the purpose of providing licensed entertainment are protected by a residual current device being a 30 MA tripping circuit.
- 4. There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials for use by patrons.
- 5. Staff shall be trained in the law relating to under age sales.
- 6. Gambling machines are prohibited to persons under 18 years of age.
- 7. Children under 16 years of age are prohibited from the downstairs bar after

21:00 hrs.

- 8. Alcohol shall not be served to persons who are deemed to be drunk or disorderly.
- 9. Only members, guests of members and day members shall be permitted to use the club
- 10. The maximum number of persons who shall be allowed to use specific parts of the premises is as follows.

Bar 80 persons Lounge 100 persons

- 11. North side windows shall be kept closed during the provision of regulated entertainment, so as to prevent public nuisance.
- 12. All persons under 18 years of age must be under the direct control of a responsible adult.
- 13. Sports sections shall have qualified personal to protect children (and vulnerable adults) from harm.
- 14. In the event of the fire alarm being activated a suitable relay must be provided so that the electrical power supply to all sound amplification system in the licensed premises must be immediately intercepted so that the alarm can be clearly heard in all parts of the licensed premises.

- 4. There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials for use by patrons.
- 5. A CCTV system of a type and specification approved by Cleveland Police shall be operational during all trading hours and, where more than one camera is in operation, at least one shall be permanently directed at the sales counter so as to record all sales taking place.

Images recorded by the system shall be retained for a minimum of 28 days and shall be made immediately available to police officers or other authorised officers on request.

- 6. There shall be in place a written policy to prevent the sale or supply of alcohol to persons under 18 years of age. That policy shall require any person who appears to be under the age of 21 to produce a recognised proof of age card accredited under the Proof of Age Standards Scheme (PASS), a photo driving licence, a passport or official HM Forces or EU ID card bearing photo and date of birth.
- 7. At least one notice shall be displayed at the entrance to the premises where it can be clearly seen and read and shall indicate that it is unlawful for persons under 18 years of age to purchase alcohol or for any person to purchase alcohol on behalf of a person under 18 years of age

- 8. A written record shall be maintained detailing the training provided to each member of staff authorised to sell or supply alcohol. Such a record shall be signed by the member of staff to confirm the date that such training took place.
- 9. The licence holder shall implement a policy of regular monitoring and review of all staff authorised to sell or supply alcohol. Such a policy shall include periodic analysis of CCTV footage to ensure sales and refusals correspond with till records.
- 10. There shall be a means of alerting staff to verify the age of a prospective purchaser whenever an age restricted product is presented for purchase.
- 11. Volunteers shall be provided to assist in the promotion of the licensing objectives.
- 12. Regular public announcements shall be given to make people aware of hazards and rules.
- 13. Sufficient numbers of security staff shall be employed to prevent crime and disorder.
- 14. The local Police Authority and Fire Brigade shall be kept informed of events.
- 15. Suitable signage shall be in place warning people of possible hazards and exits.

With reference to the proposed changes to Licensing at the Hornby Park, Elizabeth Way, Seaton Carew, I should like to register a strong objection to the Proposals.

87 - - - -

I have been the owner of a property across the road from the premises in question for fifty years and have long experience of the problems arising from loud music late at night, noise and disturbance from traffic, taxis and patrons who have over indulged. I enclose a short video example from a recent event held on a Sunday afternoon two weeks ago for your consideration. I also enclose photographs of various examples of congestion and illegal and inconsiderate parking, on numerous days, from recent weeks and earlier.

The proposed changes would allow the present 'members only social club' facilities to then operate as a commercial licensed premises/pub, offering public access to outdoor daytime and late-night drinking and entertainment every night of the week. This cannot be acceptable for nearby residents of any age, particularly the elderly and those with young children.

My objections to the proposal are concerned with:-

1). Noise and disturbance from music and late night traffic in a Residential Area. Elizabeth Way estate is not a part of the central commercial area of the village. My house is rated in Band E for the Hartlepool Community Charge.

2). The Hornby Park sports facilities are excellent and of great value to the community but parking arrangements are totally inadequate even for existing users. This causes considerable difficulties every weekend with cars using grass verges, pavements and Residents Only areas and blocking bus routes.

Attracting increased numbers of patrons for functions and events would only exacerbate this further. Local residents have to pay for Parking Permits outside their own houses and infrequent visits from Parking Wardens do little to deter casual visitors.

3). The Club has refurbished the clubhouse recently, including large extensions to the front exterior forecourt area and balcony space above, providing 40+ large permanent seating/tables which are used during the day and evenings throughout the week for food/casual drinking, with additional seating being available on the cricket field area immediately adjoining the clubhouse. This allows the young children of patrons to play

unsupervised on the cricket area sometimes into the late evening. This has led already to a noticeable increase in noise throughout the day and into the late evening, particularly at weekends.


The upstairs function room opens directly onto the new enlarged balcony and it is almost certain that guests to any function held there would spill out onto the balcony allowing the 'entertainment' to be heard across a much wider area up until the proposed 11.30pm. restriction at any time during the week. The time taken to clear the building after any function would mean ongoing disturbance in car park areas until past midnight.


