#### 1. PURPOSE OF REPORT

1.1 To consider an application for the review of a premises licence in respect of King Kaz, 98 York Road, Hartlepool.

# 2. SUMMARY OF APPLICATION

2.1 Party requesting review: Hartlepool Borough Council

Licensing Team

2.2 The current premises licence holder is: Mr Muhammad Umar Arshad

- 2.3 The current premises licence authorises the provision of late night refreshment until 0300 hours seven days a week. A copy of the licence is attached as Appendix 1.
- 2.4 A copy of the review application is attached as Appendix 2.
- 2.5 Google streetview images of the property are attached as Appendix 3.
- 2.6 The application for review refers to the following licensing objectives:
  - Public Safety
  - Prevention of Crime & Disorder
  - Prevention of Public Nuisance

# 3. BACKGROUND

- 3.1 In 2021 Hartlepool Borough Council's Licensing Team began receiving complaints from the taxi trade that a silver Ford Mondeo was regularly providing lifts for members of the public, late at night, but was not licensed as either a hackney carriage or private hire vehicle.
- 3.2 The silver Mondeo was regularly seen at King Kaz takeaway, 98 York Road and was thought to be operating from the premises.
- 3.3 In addition to the above, the Licensing Team became aware that King Kaz was continuing to provide hot food after 2300 hours, despite its licence being suspended for non-payment of its licence annual fees.

- 3.4 On 10<sup>th</sup> January 2022, Ian Harrison, Trading Standards & Licensing Manager, wrote to the licence holder of King Kaz, stating the premises licence was currently suspended and that trading after 2300 hours must stop until the outstanding fees had been paid. He also informed the licence holder that he was aware of an illegal taxi driver operating from the premises.
- 3.5 The premises licence holder denied knowledge of the premises being open late and completely denied having any association with the unlicensed taxi driver saying that he had been in the premises just once and had been immediately barred. The licence holder also paid the outstanding fees meaning that the premises could remain open until 0300 hours.
- 3.6 As Mr Harrison had reason to believe that the premises was trading after 0300 hours and that the illegal taxi was continuing to operate, he tasked Hartlepool Borough Council's CCTV Control Room to monitor the premises.
- 3.7 Mr Harrison has provided evidence, attached as Appendix 4, detailing the results of the CCTV monitoring.

### 4. ISSUES

- 4.1 An application for the review of a licence is made under Section 51 of the Licensing Act 2003.
- 4.2 The application must relate to at least one of the Act's 'licensing objectives' which are:
  - i) The prevention of crime and disorder;
  - ii) Public safety;
  - iii) The prevention of public nuisance; and
  - iv) The protection of children from harm
- 4.3 The application for review relates to allegations that the premises has traded beyond its licensed hours and has been the operating base for an unlicensed taxi driver.
- 4.4 Having considered the evidence detailed in this report and any further information provided, or representations made, at the licensing hearing, the steps available to the Licensing Sub-committee are: -
  - To take no action;
  - To modify the conditions on the licence;
  - To remove or amend licensable activities currently authorised by the licence and/or the times that they may take place;
  - To suspend the licence for a period not exceeding three months;
  - To revoke the licence.

- 2. A CCTV system to a standard approved by Cleveland Police shall be installed and maintained. Tapes shall be kept for a minimum of 28 days and made available upon request to Cleveland Police or Hartlepool Borough Council.
- 3. The licensee shall arrange for regular collections of litter from outside the premises.
- 4. Doorstaff shall be provided after 2300 on Fridays, Saturdays and Sundays preceding Bank Holidays. All doorstaff to be SIA registered.

The premises licence holder is aware of the licensed hours on the premises licence but it regularly trades much later.

There is a condition attached to the premises licence requiring CCTV to be used and for footage to be made available to the police or licensing service on request.

A request has been made for such footage and nothing has been provided.

There is a condition attached to the licence that doorstaff must be provided after 2300 hours at weekends. A request has been made for proof of this condition being complied with but nothing has been provided.

The licence holder has also been advised that someone suspected of acting as an unlicensed taxi driver has been operating from the premises. The licence holder denied this, and of knowing the driver in question, but evidence will be provided at the review hearing demonstrating that the driver is, without question, associated with the premises and is known to staff.

Hartlepool Borough Council has strict vetting policies for taxi drivers so that the general public can travel in safety – particularly late at night when they may be more vulnerable. Unlicensed taxi drivers have not been vetted and therefore may present a risk for the travelling public. As the unlicensed driver operates from King Kaz, the premises is not promoting the public safety licensing objective.

Statements, documents and CCTV footage will be provided as evidence prior to the licensing hearing.





# Statement of Ian Harrison

I am Ian Harrison and I am Hartlepool Borough Council's Trading Standards & Licensing Manager – a position I have held for 20 years.

The Licensing Act 2003 requires that premises that provide hot food or drink after 2300 must hold a *premises licence*.

In order to remain in force, an annual fee must be paid for every premises licence. Where the fee is not paid, the licence is suspended until such time that it is. While the licence is suspended, hot food cannot be supplied after 2300 hours.

On and before 10<sup>th</sup> January 2022 I received information that led me to believe that King Kaz takeaway, 98 York Road, Hartlepool was trading after 2300 hours despite its licence being suspended for non-payment of its annual fee. I also had reason to believe that King Kaz may have been the base for a silver Ford Mondeo, registration [redacted], which I suspected to be operating as an unlicensed taxi in Hartlepool.

On 10<sup>th</sup> January 2022 I e-mailed the premises licence holder, Mr Muhammad Umar Arshad, with a copy of a letter addressed to him, which stated that he must cease providing hot food from the premises until such time as the outstanding annual fees were paid. I also advised that I suspected one of his staff to be operating as an unlicensed taxi driver and that he had an obligation to ensure his staff were not breaking the law. The e-mail, and subsequent e-mails that were sent and received, are produced as Exhibit IH/1.

My letter also clearly explained that there was a Council CCTV camera located close to the premises and that it would be monitoring the shop's activity. I produce a copy of this letter as exhibit IH/2.

On 10<sup>th</sup> January, Mr Arshad replied immediately stating the following regarding the unlicensed taxi driver: -

This is not true. No such thing has ever happened as far as our shop is concerned. We sell food, and that's all. We do not work with any unlicensed taxi drivers, and none of my workers are helping any unlicensed taxi driver operate. This allegation is not true. We would like you to present evidence as far as this allegation is concerned.

We are responsible for what happens inside our property, and have no power over who stays around the shop or outside the shop. We cannot tell anyone anything as far as things outside our premises are concerned. We are not responsible for what goes on outside on the public roads, and do not accept any responsibility for anything that happens outside on public property.

At present, we feel targeted and vulnerable in hartlepool. I have reported several racist attacks to the police with no real conclusions or help, and have told the council of several issues we are having in the city.

Further e-mails were exchanged on the same day during which Mr Muhammad made the following statement when advised by me that the illegal taxi driver had been seen behind the counter of his shop: -

I will speak to the employees about why anyone was behind the reception but we do not have anyone here who is employed by me who does that and none of my employees support or help with that. I have told about this many times due to situations I heard about elsewhere and we do not promote they behavior here.

A number of further e-mails were exchanged in relation to the outstanding annual fees and these were ultimately settled on 31<sup>st</sup> January 2022.

On 7<sup>th</sup> February 2022 I received a photograph from a taxi driver showing the silver Mondeo parked at the rear of King Kaz and an allegation that the driver was behind the counter inside the shop.

I sent this to Mr Muhammad asking for an explanation. He replied, by e-mail, with the following comment: -

Hi, this person came into the shop without permission. We told him to leave the premises when he came. We have not employed him, have no links with the person and told him to leave when he came. He was told he isn't allowed to come into the shop, and was kindly told to stop annoying us.

He doesn't just come to our shop, he goes to various shops all around hartlepool from what we know. Like previously told, we are not responsible for anything which takes place outside of our shop. **No one from 98 York is telling the person to come here.** No one from 98 York is telling him to pick up anyone. We can't force him to stop being in the area, nor can we force him to stop whatever he is doing.

We did our part by banning him from the shop, telling him to leave and informing him that his presence is causing issues for us and the council and police are looking for him.

If you see him anywhere, feel free to do whatever you want with him. You are free to arrest him, ban him or do whatever you feel like is appropriate. We do not know him personally like previously told, don't give him any work like previously told and do not take any responsibility for anything he does.

I replied to Mr Muhammad, asking whether he actually worked at the shop and received the following reply: -

Yes. I am usually at the shop with my father. Currently I tested positive for Covid so I'm not there. My father is there full time, and we talk everyday to see what's going on.

This person you are referring to, he isn't employed by us, nor is he someone we welcome to the shop.

In the above e-mail, Mr Muhammad refers to his father. His father's name is Arshad Chaudhry.

In April 2022 I tasked Hartlepool Borough Council's CCTV Control Room to monitor the late night activity at King Kaz and the silver Mondeo.

The following summarises what was subsequently recorded and is available for viewing. Mr Arshad Chaudhry (the licence holder's father) can be seen in the CCTV footage in many of the above incidents. Still photos taken from the CCTV footage are exhibited as IH/3 and a summary of the activities of the silver Mondeo are exhibited as IH/4: -

# 18th April 2022

- 04:23 Mondeo arrives
- 04:28 Mondeo driver goes into shop after watching fight between members of the public outside King Kaz
- 04:54 Shop still open
- 04:57 Mondeo gives someone a lift
- 05:04 Shop still open

## 05:09 People leaving with food

- 05:11 Mondeo returns
- 05:22 Shop lights out

# 2<sup>nd</sup> May 2022

- 3:24 Mondeo arrives (driver goes into shop)
- 3:27 Mondeo driver comes out of shop, on phone
- 3:29 Member of staff talks to Mondeo driver and both go back into shop
- 3:32 Mondeo driver leaves shop (and presumably drives away)

### 4:33 - Last customer leaves with food

- 4:40 Mondeo arrives. Driver talks to staff and goes inside
- 4:46 Staff place small suitcase in boot of Mondeo and it leaves

# 8<sup>th</sup> May 22

03:23 Silver Mondeo arrives

03:25 Silver Mondeo gives lift to 4 members of public

04:31 Food still being served

04:35 Food still being served

04:36 Food still being served

# 9<sup>th</sup> May 22

3:25 Two customers arrive at King Kaz and then one urinates on neighbouring premises

3:29 Customers come out with food

3:29 Customers arguing

3:35 Customers come out with food

3:37 Significant littering from customers

# 14th May 2022

Between 3:21 and 4:38 – The silver Mondeo is parked at King Kaz and the driver can be seen inside the shop, talking to members of the public and giving them lifts.

# 15th May 2022

4:25 - Mondeo arrives and blocks pavement at right angle to road

4:34 - Someone leaves with food

4:44 - Someone leaves with food

4:56, 4:57 and 4:58 – Staff member throws chips onto street

4:59 - People leave with food

# 16th May 2022

23:50 – Two men are seen leaving the rear of the neighbouring premises, *Three Brass Monkeys*. They walk passed the rear of King Kaz. Mr Chaudhry can be seen coming out of King Kaz and then talks to the men 'off camera'. Mr Chaudhry goes back into King Kaz and brings out the driver of the silver Mondeo and introduces him

to the two men. The four men talk and then the silver Mondeo gives the two men a lift.

# 20th May 2022

3:30 - Customer leave the shop

Mr Muhammad, the licence holder, is fully aware that his premises licence only authorises sales until 0300 hours as he, himself, sent me a copy of his licence on 28<sup>th</sup> January 2022 and this clearly shows the operating hours on it.

On 5<sup>th</sup> May 2022 I asked a licensing officer to begin a criminal investigation into Mr Muhammad's persistent breaches of his licence and she wrote to him on 5<sup>th</sup> May 2022 asking for him to provide evidence that he was complying with the conditions attached to the licence – specifically asking to see copies of CCTV footage from the CCTV cameras he is required to operate and for the names of the licensed doorstaff that are required to work at the premises at certain times. No response was or has been received to this request. I exhibit a copy of the letter as Exhibit IH/5.

27th June 2022
