**15.** Hackney Carriage Tariffs – Annual Review (Head of Public Protection and Housing)

# Purpose of report

To re-consider a proposal to increase Hackney Carriage tariffs following the receipt of objections/comments to the original proposal considered by the Licensing Committee in June 2006.

#### Issue(s) for consideration by the Committee

At the Licensing Committee meeting held on 28<sup>th</sup> June, it was resolved that a proposal to increase hackney carriage tariffs be accepted, a copy of which was attached by way of appendix. The proposal was advertised in the form of a public notice and a petition objecting to the proposed increase and one objection letter had been received. In addition to this, one letter of support had been received. The background to the current position was provided within the report.

The Head of Public Protection and Housing indicated that although originally the hackney carriage vehicle owners had supported this proposal, there had been change of heart and they had suggested an alternative proposal. The main reason for this being that the variation in operating hours of licensed premises had meant that the demand for drivers was now stretched out over longer hours.

Attached by way of appendix were two options for the proposed tariffs for 2006/07, along with a comparison of costs for a 2 mile hackney carriage journey. It was noted that the figures in proposal 2 on the comparison table were incorrect and should read as follows:

08:00	3.80
15:00	3.00
Midnight	5.20

It was noted that the option recommended could be subject to a further review in two months time if necessary. Members noted that the decision taken at the previous meeting had been taken after consultation undertaken with the hackney carriage vehicle owners and that at the time there were no objections to the proposal from them. However, Members were concerned that the number of responses to the consultation had been fairly low. The Principal Licensing Officer explained that a large number of single owner drivers may have other sources of income and therefore may not rely solely on the income from operating their hackney carriage vehicle. Any decision taken not to increase fares may have a bigger impact on the professional owner drivers where it was their sole income. A representative from the Hackney Carriage Vehicle Owners Group attended the meeting and was invited to comment on the proposals.

#### Decision

It was agreed that no fare increase be implemented and that this be reviewed later in the year.

# 16. Statement of Licensing Principles – Gambling Act

**2005** (Head of Public Protection and Housing)

# Purpose of report

To inform Members of the outcome of the consultation exercise carried out in respect of the proposed Gambling Policy as required by the Gambling Act 2005.

# Issue(s) for consideration by the Committee

Members were reminded that as of 1st September 2007 Hartlepool Council would assume responsibility for the licensing of gambling premises, with licence applications being submitted from 1st February 2007.

A draft Statement of Licensing Principles was appended to the report for members' information along with a timetable for adoption of the Statement and ultimately implementation of the Gambling Act. The Head of Public Protection and Housing advised that all the guidance on the Act had not yet been published and further reports would be submitted to Members. However, in order to meet deadline the consultation had been undertaken at a local and national level and a total of four responses had been received. The responses were attached to the report by way of appendix.

A lengthy and detailed discussion took place regarding the advantages and disadvantages of adopting a No Casino Policy, the main concerns being:

- There was a view that gambling was associated with social problems
- That members of the public should be allowed the right to choose whether to attend a casino or not, although Hartlepool was not currently a site being proposed for the location of a casino
- There were several categories of casino and that while some Members could see advantages in having a 'super' casino located at a disused site within Hartlepool, they were concerned that some venues may operate small casino facilities within their main premises

The Principal Licensing Officer informed Members that any policy adopted by the local authority must be reviewed in three years time, if not reviewed before then.

## Decision

It was agreed that the draft Gambling Policy be recommended to Cabinet and full Council for adoption and that a 'No Casino' policy be included.

# 17. Quarterly Report on Licensing Act Sub Committees and Hackney Carriage and Private Hire Sub Committees Activity (Assistant Chief Executive)

# Purpose of report

To update members on the work undertaken by the five Licensing Act Sub Committees and the three Hackney Carriage and Private Hire Licensing Sub Committees.

At the meeting on 15th March 2006 the Licensing Committee had agreed to receive quarterly reports on the work of the sub-committees.
