Subject: HACKNEY CARRIAGE TARIFFS

1. PURPOSE OF REPORT

1.1 To consider a request from the hackney carriage trade to change some of the times at which current tariffs are charged and to increase the 'soiling charge'.

2. BACKGROUND

- 2.1 By virtue of the Town and Police Clauses Act 1847 licensing authorities are responsible for the setting of hackney carriage tariffs that may be charged in its area.
- 2.2 Members of the hackney carriage trade have submitted a request that the times at which some of the current tariffs are charged should change and that there be an increase in the maximum charge that can be levied if a passenger's actions require the hackney carriage to be cleaned (a 'soiling charge').
- 2.3 The current tariff rates are attached as **Appendix 1** and the proposed rates are attached as **Appendix 2**.
- 2.4 The proposed changes have been considered and approved by the Taxi Owners Working Group which is a small group of hackney carriage owners, elected by the trade, which meets with Council officers on a periodic basis.
- 2.5 All 81 hackney carriage owners have been consulted on the proposed rise and, at the time of writing this report, a small number of objections have been received. Exact details on the number and nature of objections will clarified on the day of the committee meeting itself.
- 2.6 Experience has shown that it is extremely difficult to obtain 100% trade agreement for any proposed change to tariffs. As such, as the elected Taxi Owners Working Group has proposed the increase it is recommended that the Licensing Committee consider the proposal that has been put forward.

2.7 Members are reminded that the proposed tariffs represent the highest fare that can be legally charged and it is entirely permissible for a hackney carriage driver to charge a lower fare if they wish.

3. ISSUES FOR CONSIDERATION

- 3.1 Licensing authorities are responsible for the setting of hackney carriage tariffs.
- 3.2 The proposal received from the hackney carriage trade consists of a change to the days and times that current tariff rates can be charged. If approved, these will result in an increase in costs for the travelling public only on the specified dates/times. Exact details of the increases are as follows:
 - a) Sundays (7 a.m. midnight) will be charged at tariff 2 rather than tariff 1. This would increase the cost of a 2 mile journey between those times on a Sunday by £1.40.
 - b) Between 7:00 a.m. and 6:00 p.m. on 24th December and 31st December tariffs will be charged at tariff 3 rather than tariff 1. This would increase the cost of a 2 mile journey on those days by £3.20.
 - c) Between 7:00 a.m. and 6:00 p.m. on 18th 23rd December tariffs will be charged at tariff 2 rather than tariff 1. This would increase the cost of a 2 mile journey by £1.40 on those days.
- 3.3 In addition to the above, the trade has requested an increase in the 'soiling charge' from £35 to a maximum of £100. The 'soiling charge' is a discretionary levy imposed by the driver if they believe that their passenger has soiled the vehicle and that subsequent cleaning is required.
- 3.4 As the amount of cleaning required will vary, depending on the amount of soiling that has occurred, the proposed increase is for there to be a maximum charge of £100 but where the cleaning required is less serious, the driver should charge less.
- 3.5 The council rightly demands that licensed vehicles are of a high quality and fit to carry the travelling public and therefore drivers must ensure that any soiled vehicles are cleaned before they carry further passengers. On occasion, this may require the vehicle to be 'off the road' for a number of hours denying the driver any further fares during this time. An increase in the soiling charge to a maximum of £100 will provide greater compensation for the driver where there is a significant loss of work due to the fault of a passenger.
- 3.6 Should Members approve the proposed changes, a public notice will be placed in a local newspaper to inform the general public. Should any objections be received within 14 days of the notice being published, the matter will be referred back to the Licensing Committee before any increase is implemented.

- 3.7 Members should note that hackney carriage drivers are prevented by law from charging more than the maximum approved tariff for journeys beginning and ending in the town.
- 3.8 According to the taxi trade magazine *Private Hire Monthly* Hartlepool's Hackney Carriage tariffs remain some of the lowest in the country.
- 3.9 Any increase in tariffs must reflect a balance between allowing licensed drivers to generate a reasonable income whilst representing value for money for the travelling public.
- 3.10 There is no prohibition on a taxi driver charging less than the approved tariff and it would therefore be possible for a driver to charge a lower rate if they believed the proposed tariff increase was too high.
- 3.11 The proposed increase in tariffs applies only to hackney carriages as licensing authorities have no power to set fares for private hire vehicles.

4. **RECOMMENDATIONS**

4.1 That the Licensing Committee approves the proposed increase in hackney carriage tariffs as detailed in Appendix 2.
