23. Minutes of the meeting held on 17 October 2022

24. Cleveland Online Policing App (COPA) *(Project Manager, Office of the Police and Crime Commissioner for Cleveland)*

Purpose of report

To provide an outline of the Cleveland Police COPA app for reporting crime.

Issue(s) for consideration

The representative from the Office of the Police and Crime Commissioner gave a presentation to the Partnership outlining how to sign up for the app, how reporting was undertaken, how reports were monitored and statistical information gathered. It was reported that over 2800 people had now downloaded the app to their phones.

An elected Member commented that they had reported problems with off-road bikes and had been disappointed to get a message back that they would not get a response because it was a weekend. The PCC representative stated that all information was gathered and used to build up intelligence. It may be necessary, however, to change some of the initial messaging on screen so people were more aware of the hours of operation.

The Chair commented that HBC Communications Team could be asked to promote the app further. The PCC representative stated that people without smart phones or who weren't comfortable using technology could

still make reports to the 101 telephone line. The Chair requested that the presentation be shared with partners.

Decision

25. Martyn's Law and Publicly Accessible Locations Update *(Director of Neighbourhoods and Regulatory Services)*

Purpose of report

To provide the Partnership with an update of Martyn's Law previously referred to as the Protect Duty.

Issue(s) for consideration

The Assistant Director, Regulatory Services reported that an initial report was presented to the Partnership in March 2022 detailing the Governments plans, and this report will highlight the duty in more significant detail. In December 2022, the Government announced proposals for new measures to be taken to protect public venues. This had previously been referred to as the Protect Duty, however, it would now be known as 'Martyn's Law' in tribute to Martyn Hett, who was killed alongside 21 others in the Manchester Arena terrorist attack in 2017.

The report updated the Partnership on the scope of Martyn's law and how it would be applied and who it applied to. In preparation for the introduction of Martyn's Law Hartlepool Borough Council had been taking part in the Publicly Accessible Locations Pilot and had been working closely with the Counter Terrorism North East Policing team since 1st April 2022.

By participating in the Pilot Hartlepool Borough Council had established a dedicated overarching Publicly Accessible Locations Group and a number of working subgroups. This preparatory work had given the council a head start on the Martyn's Law requirements. The Council had been risk assessing its premises which may hold "qualifying activities" through a joined-up approach of Council employees and a dedicated Counter Terrorism Security Advisor who is employed by Counter Terrorism Policing North East. The Pilot had placed the Council in a good position for the impending legislative requirements as it had provided a good baseline for greater coordination of security planning, greater awareness and training in counter terrorism.

An elected Member noted that Hartlepool would have a small number of events that would qualify under Martyn's Law and noted that there had been bag searches at the last Waterfront Festival at the Marina. The elected Member asked how many people in general were stopped and searched in Hartlepool on a weekly basis. The Cleveland Police representative stated that the force had become more proactive in its approach to stop and search over recent months and had now made it

mandatory for officers to use body cams when undertaking stop and searches. Around 20 per week were currently undertaken.

There was also regular independent scrutiny of the body cam footage to ensure compliance with the regulations around stop and search. The Chief Inspector undertook to share details of the group that undertook the reviews of the videos with the Partnership as new people for the group were being recruited.

Decision

That the report be noted and that Partners consider the potential financial implications of meeting the legislative obligations.

26. Serious Violence (*Director of Neighbourhoods and Regulatory Services*)

Purpose of report

To provide an update on the Serious Violence Duty, following a previous report which was presented to the partnership in March 2022.

Issue(s) for consideration

The Assistant Director, Regulatory Services reported on the duty around, and the definitions, of serious violence. The Cleveland Specified Authorities Stockton, Redcar and Cleveland, Middlesbrough and Hartlepool have agreed to work jointly through the Cleveland Unit for the Reduction of Violence (CURV) to help meet the legal obligations specified by The Duty. CURV would have a coordinating role, carrying out data analysis, apply for funding streams and submit Home Office returns on behalf of the authorities. This has been supported by the CURV Governance Group.

In order to prepare and implement a strategy to prevent and reduce serious violence in the area, the partnership would collectively develop a strategy which would outline the multi-agency response that the partnership would take to address the drivers identified in the strategic needs assessment and work to prevent and reduce serious violence in the local area.

The strategy would contain bespoke solutions to prevent and reduce serious violence in the area, and would set out how the proposed actions will enhance and complement existing local arrangements responding to serious violence. This must be kept under review, which should be done on an annual basis and updated when necessary.

27. Independent Review Of Prevent (*Director of Neighbourhoods and Regulatory Services*)

Purpose of report

To inform the Safer Hartlepool Partnership of the findings and recommendations of the Independent Review of Prevent.

Issue(s) for consideration

The Community Safety and Operations Manager reported that the Independent Review of Prevent had paved the way for a stronger, more transparent, and proportionate approach to stopping people from being radicalised into terrorism, and recognised the need for Prevent to understand better ideology and the individual agency of people who willingly support terrorism. In total, the review made 34 recommendations that have been accepted by the government. A Summary of the headline recommendations and the Government responses were submitted as an appendix to the report.

Decision

That the report be noted.

29. Policing Update (*Director of Neighbourhoods and Regulatory Services*)

Purpose of report

To provide and update on Policing in Hartlepool

Issue(s) for consideration

The temporary Chief Inspector gave an update on Policing in Hartlepool including the following points: -

- 105 engagements in face to face meetings including ward surgeries.
- A 29% increase in neighbourhood patrols.
- Attendance at 103 incidents in November and 60 in December 2022.
- 63 arrests had been made in the last quarter.
- Burglary was down 7% though robbery was up 6%.
- Vehicle crime was up 34%. Criminal damage up 7.9%.
- There were 92 active criminal investigations ongoing.
- In January two individuals had been stopped and arrested for supplying tablets to school children.
- Operation Endurance continued with 8 off-road motorcycles being seized.

- Over £4m of drugs had been taken off the streets across the force area.
- A man had been arrested and charged with over 40 offences of stalking and harassment.

The Chief Inspector reported that the structure of the force was also changing and Hartlepool would have a dedicated Chief Superintendent and Chief Inspector.

A Member of the public questioned the use of civil injunctions particularly following Community Triggers. Officers present confirmed that the use of civil injunctions was embedded with partners and used regularly.

Subject: DOMESTIC ABUSE STRATEGY

1. PURPOSE OF REPORT

- 1.1 To update members on the progress of the Domestic Abuse Local Strategic Partnership Board in delivering the Domestic Abuse Strategy in the last year 2022 – 2023 and to discuss the proposed delivery plan for 2023 – 2024.

2. BACKGROUND

- 2.1 The Domestic Abuse Act received royal assent in parliament in April 2021 with draft statutory guidance being published in July 2021. There is a requirement for local authorities with their partners to review their Domestic Abuse Strategies to ensure that they are meeting the new statutory duties
- 2.2 A report was presented to the Safer Hartlepool Partnership in March 2022 and the strategy approved by Finance and Policy Committee.
- 2.3 The implementation of the strategy has been delivered through the Local Domestic Abuse Strategic Partnership Board

3. PROPOSALS

- 3.1 The Domestic Abuse Local Strategic Partnership Board (DALSPB) meets the requirements of the Domestic Abuse Act 2021 and consists of representatives from the local authority, health services, policing and criminal justice, voluntary organisations and representatives for the voice of both child and adult victims of domestic abuse.
- 3.2 Over the last financial year the DALSPB have been implementing an action plan (**Appendix 1**) with a focus on the key strategic priorities within the Domestic Abuse Strategy that was presented to the Safer Hartlepool Partnership on the 8th March 2022. The key strategic priorities are:

- Working with victims/ survivors (adults and children) for them to be true partners in our review and development of services;
 - Focus on supporting as early as possible – develop a prevention/ early intervention offer;
 - Re-commission support services based on lived experiences;
 - Equip the workforce to ask the right questions and to support victims of domestic abuse;
 - Develop more choice and options for safe accommodation; and
 - Consider the needs of victims/survivors with multiple and complex issues using multi agency support in order to begin to address needs.
- 3.3 Two members of the DALSPB identified themselves as survivors of domestic abuse, both as children and adults. Harbour, as the commissioned service provider, also represent the voice of the victim and the child which informed the Needs Assessment and Strategy and the expectations of the new contract that went live on the 1st October 2022, including separating services for adults and children. Harbour deliver a regular Service User Forum that received an update on the strategy and gave feedback which informed the delivery of the strategy.
- 3.4 The design and specifications for support and safe accommodation and therapeutic support for children were prepared in April 2022 and the tender process for the two lots concluded in July 2022 with Harbour being notified in August 2022 as successful in their bids for both contracts with delivery commencing on the 1st October 2022 for three years. The commission will increase opportunities of safe accommodation and a robust performance monitoring framework has been developed with regular outcome monitoring.
- 3.5 In terms of safe accommodation, Harbour continue to deliver a six bed refuge and three dispersed properties in the area. Two properties were secured by Hartlepool Borough Council to use as safe accommodation with oversight from the Housing Advice Team. The Allocations Policy was reviewed and there is a clear safe accommodation process in line with legislation changes, including victims of domestic abuse being awarded priority banding. Data returns have been submitted to the Department of Levelling Up, Housing and Communities (DLUHC) for the financial years 2021 – 2022 and 2022 – 2023. We expect to see further changes in the next financial year as the provision of safe accommodation increases. Hartlepool Borough Council continue to explore provisions with other housing providers and funding bids to increase safe accommodation options. Funding from the DLUHC also ensured the employment of a bridge worker across housing advice and substance misuse teams which will support complex domestic abuse cases. There are plans to open a second refuge and discussions have been ongoing since December 2022, which will continue into the new action plan. A task and finish group was convened to review the target hardening (sanctuary scheme) offer across the borough. North east local authorities meet regularly to monitor and share date of where victims move across boundaries and ensure appropriate provision is in place.

- 3.6 Hartlepool Borough Council has reviewed its domestic abuse policy to ensure staff who are victims of domestic abuse are appropriately supported at work. Partners also provided a commitment that they have policies in place for their workforce. The implementation of Health Advocates within the local authority, including training on responding to disclosures of domestic abuse within the workplace, has strengthened this offer. The offer of training has been reviewed and domestic abuse and DASH risk assessment training has been delivered to housing and local welfare support teams. Training continues to be delivered by Harbour and partners via workforce development and the Hartlepool and Stockton Safeguarding Children Partnership (HSSCP). Key progress has also been made in the implementation of the Safe and Together model with all children's social work teams having received training and training has been delivered to partners via HSSCP. There is a clear workforce development strategy to continue with the implementation of Safe and Together across the Council and wider partners.
- 3.7 Assurance was sought from the head teachers in schools across the local area that they are delivering relationships, sex and health education as part of their curriculum and they have a positive working relationship with our commissioned provider. A reducing parental conflict pathway and local offer has been developed with Changing Futures North East with early help workers receiving training from Department of Work and Pensions funding. All partners engage in events and communication surrounding key awareness raising campaigns including White Ribbons Day and 16 Days of Action with Harbour and Halo leading on raising awareness.
- 3.8 The Tees Safeguarding Adult Board (TSAB) are leading on the review of the Team Around the Individual (TATI) process following a serious case review and this will strengthen the response to individuals with multiple and complex issues. The Office for Police and Crime Commissioner (OPCC) and Cleveland Police are leading a Strategic Multi Agency Risk Assessment Conference (MARAC) group following a review of MARAC completed by Safe Lives in which partners are actively involved. Progress has been made with the recruitment of a new independent MARAC chair and focus on processes, reducing screening and implementing a pilot to increase the frequency of meetings. Domestic abuse services in the area are complemented with funding from the OPCC that is aligned with commissioning arrangements, including hospital, court and mental health Independent Domestic Violence Advocate's (IDVA) that operate within Hartlepool. Other organisations also receive funding from the OPCC, including Arch Teesside that provide support to adults and children who are victims of sexual abuse and Halo who receive funding from the OPCC to support with black and minorities ethnic groups.

3.9 The key strategic priorities for 2023 – 2024 will remain the same, underpinned by an action plan (**Appendix 2**) however the work of the DALSP will focus on:

- Beginning the process of reviewing the Needs Assessment to identify any changes to data and trends;
- Exploring other ways to incorporate the voice of victims and survivors, both adults and children;
- Update our offer for both domestic abuse and reducing parental conflict and improve accessibility to services online;
- Continue to promote key awareness raising campaigns with a communication strategy;
- Continue with the outcome monitoring of commissioned services, seeking feedback and addressing and gaps, including implementing service user level data for safe accommodation to identity need and meet the requirements of the DLUHC;
- Continue to implement the Safe and Together model and develop training packages within workforce development and in partnership with HSSCP and TSAB;
- Support the strategic review of MARAC and ensure this is fit for purpose and delivers appropriate outcomes and is reflected within operational MARAC;
- Implement new housing systems for homeless and housing applications, including domestic abuse risk assessments ensuring the allocations policy and banding systems are victim led;
- Implement settling into community scheme via welfare support;
- Strengthen relationships between housing providers and specialist support services and liaise with other councils and partners to ensure sufficient provision is available;
- Continue to develop the new offer of a Sanctuary Scheme;
- Secure a second refuge that is appropriate for complex needs and increases the offer of safe accommodation;
- Continue to develop accommodation pathways for perpetrators;
- Have a clear focus on perpetrators that will be implemented by the OPCC leading on a perpetrator strategy with working groups to support this; and
- Continue the TATI review process with TSAB to strengthen pathways and continue to learn from safeguarding reviews (adult and children) and address issues identified.

4. RISK IMPLICATIONS

4.1 The added duties within the Domestic Abuse Act place a pressure on the local authority and its partners. There is a risk that the current resources cannot meet the additional duties therefore resources will need to be prioritised. It will therefore be critical for all partners to work together to make the best of use of current resources.

5. FINANCIAL CONSIDERATIONS

- 5.1 There are no specific financial considerations however the above point about limited resources needs to be noted.

6. LEGAL CONSIDERATIONS

- 6.1 There are no specific legal considerations.

Two members of the DAPB have identified themselves as survivors of domestic abuse, both as children and adults.

Progress Update –**September 2022**

Domestic Abuse and Risk Assessment training has been completed with Housing and Local Welfare Support Teams and this has now been introduced to individuals presenting and disclosing domestic abuse.

Domestic Abuse Services 3 year contract to start 1st October 2022 including increased refuge and dispersed property opportunities.

North East local authorities are monitoring and sharing data of where victims have moved out of area to ensure appropriate provisions are in place.

Data return submitted to the DLUC for 2021/2022 in June 2022

Allocations Policy has been reviewed there is a clear safe accommodation process in line with legislation changes.

HBC are exploring options with other housing providers and have had discussions with Thirteen, Places for People, Anchor, New Walk, One CIC and Community Campus to secure further DA accommodation options.

One property has been secured by HBC for families and a further property is being brought online. This will provide 2 safe places with oversight from the Housing Team.

Olivia has had a discussion with Nicholas Stone from Community Safety regarding the target hardening we currently offer and gaps we need to consider and address.

September 2022

OPCC and Cleveland Police are leading a Strategic MARAC group and HBC is actively involved. Work on ISA and SOPs are underway. An observation programme of MARAC has been put in place to use learning to improve operational MARAC processes as well as developing a training package for SPOC's. Currently recruiting for a new chair.

TATI has now reconvened

HBC has secured funding from DLUHC and are in the process of recruiting a 'Bridge Worker' between START and Housing which will support with complex domestic abuse cases.

Arch Teesside are funded by the OPCC to provide support to adults and children who are victims of sexual abuse, including an ISVA service and SARC.

Subject: TERRORISM (PROTECTION OF PREMISES) DRAFT BILL

1 PURPOSE OF REPORT

- 1.1 To provide the Partnership with an overview of the Terrorism (Protection of Premises) Draft Bill previously referred to as the Protect Duty and Martyn's Law. An initial report was presented to the Partnership in March 2022 detailing the Governments plans, and a further update was provided in March 23. This report will highlight the Draft Bill in more significant detail.

2 BACKGROUND

- 2.1 The [draft Terrorism \(Protection of Premises\) Bill](#) sets out the requirements that, under Martyn's Law, venues and other organisations will have to meet to ensure public safety. 'Martyn's Law' is a tribute to Martyn Hett who was killed alongside twenty one others in the Manchester Arena terrorist attack in 2017.
- 2.2 The draft bill will be subject to pre-legislative scrutiny by the Home Affairs Select Committee, ahead of formal introduction.

3 TERRORISM (PROTECTION OF PREMISES) DRAFT BILL

- 3.1 In December 2022, the government announced that Martyn's Law will introduce a tiered model (standard tier and enhanced tier) for certain locations depending on the capacity of the premises or event and the activity taking place. The legislation will ensure venues are prepared for, and ready to respond in the event of, an attack.
- 3.2 The government has committed to working closely with businesses and other stakeholders to ensure the legislation is proportionate whilst also being effective. Dedicated guidance and support will be provided to ensure those in scope can meet their responsibilities. ProtectUK already hosts a range of expert advice, training, and guidance.

- 3.3 The standard tier will apply to public premises with a maximum capacity of 100 or more people, whilst the enhanced tier applies to public premises and events with a maximum capacity of 800 or more people. Limited exemptions to the capacity requirements apply to education establishments and places of worship. Guidance and training materials will be available to premises with a capacity of under 100, should they want additional support.
- 3.4 Standard tier premises will be required to undertake basic, low-cost activities to improve their preparedness, including terrorism protection training and evaluating the best procedures to put in place in order to minimise impact.
- 3.5 Enhanced tier premises and events have further requirements in recognition of the potential consequences of a successful attack. This will include appointing a designated senior officer who must regularly review the security of the venue/event.
- 3.6 An inspection and enforcement regime will be established to promote the requirements for each tier but there has been no indication of which agency will be given this responsibility. In the event of non-compliance, sanctions and ultimately penalties can be issued to premises.
- 3.7 The Terrorism (Protection of Premises) Draft Bill will extend to and apply across the whole of the United Kingdom and has been developed following extensive consultation with the public, businesses and campaign groups. The significant majority agree that those responsible for publicly accessible locations should take measures to protect the public from potential attacks.

4 FINANCIAL CONSIDERATIONS

- 4.1 It is likely that there will financial implications for the enforcement agency identified as responsible for the administration and enforcement of the new requirement when they are implemented.
- 4.2 Additionally, all partner agencies may be required to comply with the new requirements should they have any relevant venues/events within their scope.
