- 7. Questions by Members to responsible bodies/interested parties and/or their witnesses.
- 8. Parties may question and clarify issues raised with the consent of the Chair.
- 9. If required, responsible bodies/interested parties to be given opportunity to sum up.
- 10. If required, the applicant to be given opportunity to sum up.
- 11. Members to have the opportunity to clarify any points raised. The Chair shall ask whether all parties are satisfied they have said all they wish to.
- 12. Members to go into closed session to deliberate.
- 13. Chair informs parties of their decision, with reasons.

1. PURPOSE OF REPORT

1.1 To consider objection notices served by Cleveland Police and Hartlepool Borough Council's Environmental Health Team in respect of a Temporary Event Notice (TEN) for Enclosure Area, Hornby Park, Elizabeth Way, Seaton Carew, TS25 2AZ.

2. BACKGROUND

2.1 A Temporary Event Notice has been submitted by Mr Andrew Reece in respect of the following: -

Location	Enclosure Area, Hornby Park, Elizabeth Way, Seaton Carew, TS25 2AZ
Date of Event	1 st June 2024
Time of Event	12:30 – 22:00 hours
Duration of Event	1 day
Proposed Activities	on sale of alcohol- Beer Festival Provision of regulated entertainment (Live Music)

- 2.2 A copy of the Temporary Event Notice is attached as **Appendix 1**.
- 2.3 The Temporary Event Notice was submitted on 9th April 2024 an objection was submitted by Cleveland Police on 10th April 2024 and by the Council's Environmental Health Team on 11th April 2024 (attached as **Appendix 2 & 3**).

3. ISSUES

3.1 A Temporary Event Notice is not an application and does not require the approval or permission of the Licensing Authority unless an objection notice is made by either Cleveland Police or Hartlepool Borough Council's Environmental Health Department.


- 3.2 The Licensing Act states that either or both of the above agencies may serve an objection notice when they are satisfied that allowing the proposed event would undermine a licensing objective.
- 3.3 Cleveland Police has lodged an objection stating that the application gives significant concerns that the 4 licensing objectives will not be promoted.
- 3.4 Environmental Health has lodged an objection on the grounds of upholding licensing objectives, particularly the prevention of public nuisance. The objection primarily revolves around the proposed music playing and the potential disturbance caused by those attending the event.
- 3.5 As objections have been submitted the Licensing Authority is required to hold a hearing and, having considered all relevant evidence, make a decision as to whether the proposed event may proceed.
- 3.6 Having regard to the representations received, Members may choose to:
 - i) Approve the Event Notice with or without conditions
 - ii) Reject the Event Notice
- 3.7 Members are reminded that they must only consider those aspects of the Event Notice that are relevant to the representations received.
- 3.8 Should Members determine that the Temporary Event Notice should not be accepted, the Council will issue a 'Counter Notice' which will prevent the proposed activity from being an authorised event.

4. **RECOMMENDATIONS**

4.1 Members consider the representations presented by the applicant and the objectors, and decide whether to approve the event notice, either with or without specific conditions or to issue a counter notice.



A Temporary Event Notice has been submitted by the above premise user for On Licensed Premise, Hornby Park, Elizabeth Way Seaton Carew, TS25 2AZ

This notice was received by Cleveland Police at 1332hrs on Tuesday 9th April 2024. The premises user gave notice and stated that he intended to conduct an outdoor beer festival with the sale by retail of alcohol on 1st June 2024 1230hrs – 2200hrs

This event is to take place within the grounds of Hornby Park Sports complex. The sports club house already has a premise licence allowing on sale only along with licensable activity as follows:-

The opening hours of the premises Saturdays and Sundays 1200hrs – 1900hrs.

Supply of alcohol Saturdays and Sundays 1200hrs – 1830hrs. Live Music Saturday and Sundays 1200hrs – 1900hrs. Recorded Music Saturday and Sundays 1200hrs – 1900hrs. Performance of Dance Saturday and Sundays 1200hrs – 1900hrs. Anything similar to 2, 3 or 4 Saturday and Sundays 1200hrs – 1900hrs. Provision of facilities for making music Saturday and Sundays 1200hrs – 1900hrs.

Provision of facilities for dancing Saturday and Sundays 1200hrs – 1900hrs. Provision of entertainment facilities of a similar description to 6 or 7 Saturday and Sundays 1200hrs – 1900hrs.

Cleveland Police hereby give notice of objection under Section 104(2) Licensing Act 2003 in respect of an application for a Temporary Event Notice made by the above named person in relation to the above premises. Cleveland Police wish to object to the Temporary Event Notice for the following reasons.

- 1) In its current format the application gives significant concerns that the 4 licensing objectives will not be promoted.
- 2) The Site map provided is poor and Cleveland police are unable to identify locations of entry/ exit to the site.
- 3) There is no mention of security staff employed and it is unclear how numbers will be managed. It states 499 capacity, but that has to include staff. There will be bar staff employed as a minimum. From the application there will also be food vendors and children's activity personnel. These numbers will impact on the number of attendees and the total capacity of 499 closely monitored.

If people leave how will these numbers be counted to allow further entry to other attendees. Is this event to be ticketed or is it first come first serve.

- 4) From the sections Cleveland Police can read on the site map provided it is noted that a 'lost child point' is indicated. Although there has been some consideration to if a child is lost, no safeguarding policy is provided or a lost missing person protocol. This is something Cleveland Police would suggest is a must for an event like this.
- 5) The location of this event is surrounded by residential premises. There is no mention in the application of how the sound/volume is to be assessed to prevent distribution / annoyance to nearby residents.

To Cleveland Polices knowledge an event like this has not been tried in the area before. Cleveland Police although supportive of initiatives of the licensed premises has concerns, which need to be addressed. These concerns are surrounding the security for the event, the safety of the public attending the event, provisions for the safety of children attending the event and ultimately what steps are to be taken to prevent crime and disorder during the running of the event.

Cleveland Police strongly suggest that for event of this type the applicant needs to attend an independent safety advisory group to address these points raised. Along with several conditions to be attached to the notice.

A list of suggested conditions can be provided if our concerns are not addressed.

A Temporary Event Notice has been submitted by the above premise user for On Licensed Premise, Hornby Park, Elizabeth Way Seaton Carew, TS25 2AZ

This notice was received by Public Protection at 1332hrs on Tuesday 9th April 2024. The premises user gave notice and stated that he intended to conduct an outdoor beer festival with the sale by retail of alcohol on 1st June 2024 1230hrs – 2200hrs

The event is scheduled to occur within the confines of Hornby Park Sports Complex. The sports club house currently holds a premise license permitting on-site sales only, along with licensable activities for the outdoor area, outlined as follows:

The opening hours of the premises Saturdays and Sundays 1200hrs – 1900hrs.

Supply of alcohol Saturdays and Sundays (1200hrs – 1830hrs. Live Music Saturday and Sundays 1200hrs – 1900hrs. Recorded Music Saturday and Sundays 1200hrs – 1900hrs. Performance of Dance Saturday and Sundays 1200hrs – 1900hrs. Anything similar to 2, 3 or 4 Saturday and Sundays 1200hrs – 1900hrs. Provision of facilities for making music Saturday and Sundays 1200hrs – 1900hrs. Provision of facilities for dancing Saturday and Sundays 1200hrs – 1900hrs. Provision of entertainment facilities of a similar description to 6 or 7 Saturday and Sundays 1200hrs – 1900hrs.

Hartlepool Borough Council's Public Protection team hereby give notice of objection under Section 104(2) Licensing Act 2003 in respect of an application for a Temporary Event Notice made by the above named person in relation to the above premises. Public Protection are raising objections to the enclosed Temporary Event Notice (TEN) on the grounds of upholding licensing objectives, particularly the prevention of public nuisance. The objection primarily revolves around the proposed music playing and the potential disturbance caused by those attending the event.

- 1. There is a history of noise complaints in the vicinity, given the presence of residential properties surrounding the proposed event location. The application lacks clarity on how sound levels will be assessed to mitigate disturbance or annoyance to nearby residents.
- 2. The provided site map lacks detail, particularly concerning stage direction, which is crucial for assessing potential noise dispersion and management.
- 3. The temporary event is subject to a 499 occupancy limit, yet there's no indication of how this will be monitored and enforced during the event. Is this a ticketed event or will customers be queuing on the main highway to get into the event? This alone could give rise to public nuisance.

Granting the TEN, and allowing continuous music from 1300hrs to 2200hrs as detailed in their TEN application, poses a significant risk of noise and public nuisance.

To address these concerns, Public Protection strongly recommends that the applicant attend an independent safety advisory group meeting (ISAG) to discuss and mitigate the issues raised. Additionally, several conditions need to be attached to the notice to ensure compliance and minimise disruption.

A list of suggested conditions can be provided if our concerns are not addressed.

ANNEX 1 – Mandatory Conditions

- 1. No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 2. Each individual employed or otherwise engaged at the premises to carry out a security activity must be licensed by the Security Industry Authority.
- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

 (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or
 discounted fee to the public or to a group defined by a particular

discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
 (i) the outcome of a race, competition or other event or process, or
 (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

 (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

ANNEX 2 – Conditions consistent with the Operating Schedule

1. Except with the prior written approval of the Licensing Authority and subject to any conditions which may be attached to such approval.

No special effects, naked flames, smoke production or any process creating a risk of fire, or the illusion of smoke or fire shall be used for the purpose of providing regulated entertainment on the premises.

No explosives or highly flammable substances shall be brought into or used on the premises.

No special effects shall be used or displays given on the premises, which consist of or include the use of lasers.

Applications for consent, giving detailed descriptions of the equipment to be used and details of the event, including dates and times must be made not less than 28 days before the date of the event.

- 2. The licensee shall ensure that the electrical socket outlets in the licensed premises to be used with electrical equipment provided for the purpose of entertainment shall be protected by a residual current device being a 30 mA tripping circuit.
- 3. In the event of the fire alarm being activated a suitable relay should be provided so that the electrical power supply to all sound amplification system in the licensed premises shall be immediately intercepted so that the alarm can be clearly heard in all parts of the licensed premises.
- 4. There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials for use by patrons.
- 5. A CCTV system of a type and specification approved by Cleveland Police shall be operational during all trading hours and, where more than one camera is in operation, at least one shall be permanently directed at the sales counter so as to record all sales taking place. Images recorded by the system shall be retained for a minimum of 28 days and shall be made immediately available to police officers or other authorised officers on request.
- 6. There shall be in place a written policy to prevent the sale or supply of alcohol to persons under 18 years of age. That policy shall require any person who appears to be under the age of 21 to produce a recognised proof of age card accredited under the Proof of Age Standards Scheme (PASS), a photo driving licence, a passport or official HM Forces or EU ID card bearing photo and date of birth.

- 7. At least one notice shall be displayed at the entrance to the premises where it can be clearly seen and read and shall indicate that it is unlawful for persons under 18 years of age to purchase alcohol or for any person to purchase alcohol on behalf of a person under 18 years of age
- 8. A written record shall be maintained detailing the training provided to each member of staff authorised to sell or supply alcohol. Such a record shall be signed by the member of staff to confirm the date that such training took place.
- 9. The licence holder shall implement a policy of regular monitoring and review of all staff authorised to sell or supply alcohol. Such a policy shall include periodic analysis of CCTV footage to ensure sales and refusals correspond with till records
- 10. There shall be a means of alerting staff to verify the age of a prospective purchaser whenever an age restricted product is presented for purchase.

The following conditions relate to outdoor events only:

- 11. Volunteers shall be provided to assist in the promotion of the licensing objectives.
- 12. Regular public announcements shall be given to make people aware of hazards and rules.
- 13. Sufficient numbers of security staff shall be employed to prevent crime and disorder.
- 14. The local Police Authority and Fire Brigade shall be kept informed of events.
- 15. Suitable signage shall be in place warning people of possible hazards and exits.
- 16. First Aid staff shall be in attendance.
- 17. The crowd shall be monitored and sufficient numbers of security staff employed to assist in crowd management.
- 18. Risk Assessment to be carried out prior to any event.
- 19. No adult entertainment, services or activities will take place.
- 20. All outdoor events to be held at the premises must first go through ISAG at least 6 weeks prior to the planned event.
- 21. All outdoor events must be concluded by 19:00hrs on the day the event has been scheduled for.

ANNEX 3 – Conditions attached after a hearing by the Licensing Authority

- 1. The last entry to the Clubhouse for new customers be restricted to 9:00pm.
- 2. The sale of alcohol outside of the Clubhouse be restricted to between 10:00am and 6:30pm.
- 3. Except for the maximum of four outside events per year, external drinking areas shall be closed at 10:00 pm.
- 4. The maximum cumulative attendance at any external event be limited to 1,000 people.

This notice was received by Cleveland Police at 1332hrs on Tuesday 9th April 2024. The premises user gave notice and stated that he intended to conduct an outdoor beer festival with the sale by retail of alcohol on 1st June 2024 1230hrs – 2200hrs

This event is to take place within the grounds of Hornby Park Sports complex. The sports club house already has a premise licence allowing on sale only along with licensable activity as follows:-

The opening hours of the premises Monday - Sundays 10:00 – 00:00 New Year's Eve Until 01:00

Supply of alcohol – Monday – Sunday 10:00 – 23:30 Live Music – Monday – Sunday 12:00 – 23:30 Recorded Music - Monday – Sunday 12:00 – 23:30 The above activities are extended to 00:30 on New Year's Eve

Cleveland Police hereby give notice of objection under Section 104(2) Licensing Act 2003 in respect of an application for a Temporary Event Notice made by the above named person in relation to the above premises. Cleveland Police wish to object to the Temporary Event Notice for the following reasons.

- 1) In its current format the application gives significant concerns that the 4 licensing objectives will not be promoted.
- 2) The Site map provided is poor and Cleveland police are unable to identify locations of entry/ exit to the site.

3) There is no mention of security staff employed and it is unclear how numbers will be managed. It states 499 capacity, but that has to include staff. There will be bar staff employed as a minimum. From the application there will also be food vendors and children's activity personnel. These numbers will impact on the number of attendees and the total capacity of 499 closely monitored.

If people leave how will these numbers be counted to allow further entry to other attendees. Is this event to be ticketed or is it first come first serve.

- 4) From the sections Cleveland Police can read on the site map provided it is noted that a 'lost child point' is indicated. Although there has been some consideration to if a child is lost, no safeguarding policy is provided or a lost missing person protocol. This is something Cleveland Police would suggest is a must for an event like this.
- 5) The location of this event is surrounded by residential premises. There is no mention in the application of how the sound/volume is to be assessed to prevent distribution / annoyance to nearby residents.

To Cleveland Polices knowledge an event like this has not been tried in the area before. Cleveland Police although supportive of initiatives of the licensed premises has concerns, which need to be addressed. These concerns are surrounding the security for the event, the safety of the public attending the event, provisions for the safety of children attending the event and ultimately what steps are to be taken to prevent crime and disorder during the running of the event.

Cleveland Police strongly suggest that for event of this type the applicant needs to attend an independent safety advisory group to address these points raised. Along with several conditions to be attached to the notice.

A Temporary Event Notice has been submitted by the above premise user for On Licensed Premise, Hornby Park, Elizabeth Way Seaton Carew, TS25 2AZ

This notice was received by Public Protection, Environmental Health Team at 1332hrs on Tuesday 9th April 2024. The premises user gave notice and stated that he intended to conduct an outdoor beer festival with the sale by retail of alcohol on 1st June 2024 1230hrs – 2200hrs

The event is scheduled to occur within the confines of Hornby Park Sports Complex. Presently, the sports club house is granted a premise license that allows for on-site sales only, in addition to licensable activities for the outdoor area, as detailed in the attached Appendix PS373A, with specific attention drawn to condition 21.

Hartlepool Borough Council's Environmental Health team hereby give notice of objection under Section 104(2) Licensing Act 2003 in respect of an application for a Temporary Event Notice made by the above named person in relation to the above premises. Environmental Health are raising objections to the enclosed Temporary Event Notice (TEN) on the grounds of upholding licensing objectives, particularly the prevention of public nuisance. The objection primarily revolves around the proposed music playing and the potential disturbance caused by those attending the event.

 There is a history of noise complaints in the vicinity, given the presence of residential properties surrounding the proposed event location. The application lacks clarity on how sound levels will be assessed to mitigate disturbance or annoyance to nearby residents.

- 2. The provided site map lacks detail, particularly concerning stage direction, which is crucial for assessing potential noise dispersion and management.
- 3. The temporary event is subject to a 499 occupancy limit, yet there's no indication of how this will be monitored and enforced during the event. Is this a ticketed event or will customers be queuing on the main highway to get into the event? This alone could give rise to public nuisance.

Granting the TEN, and allowing continuous music from 1300hrs to 2200hrs as detailed in their TEN application, poses a significant risk of noise and public nuisance.

To address these concerns, Environmental Health strongly recommends that the applicant attend an independent safety advisory group meeting (ISAG) to discuss and mitigate the issues raised. Additionally, several conditions need to be attached to the notice to ensure compliance and minimise disruption.

A list of suggested conditions can be provided if our concerns are not addressed.
