2 PURPOSE OF REPORT

- 2.1 To consider an application for a new Premises Licence in respect of The Barn, The Raby Arms, Front Street, Hartlepool. A Summary of the application is outlined below:
- 2.2 Applicant: Raby Arms Hart Limited

Premises: The Barn

The Raby Arms Front Street Hartlepool TS27 3AJ

2.3 The applicant has applied for a Licence for the following activities: -

Live Music Monday – Sunday 10:00hrs – 23:00hrs

(on the premises only)

Recorded Music Monday – Sunday 10:00hrs – 23:00hrs

(on the premises only)

Supply of Alcohol Monday – Sunday 09:00hrs – 23:00hrs (on & off premises)

A copy of the application is attached as **Appendix 1**.

Street view images of the premises are attached as **Appendix 2** and a map of the area is attached as **Appendix 3**.

2.4 The applicant states on the application that the premises is a barn/ shed converted into a function room with its own bar, the function room will offer a maximum of sixty covers.

3. BACKGROUND

- 3.1 The application has been advertised in the prescribed manner and four representations have been received by the Licensing Authority.
- 3.2 Representations have been provided by four members of the public, these representations are attached as **Appendix 4**, **Appendix 5**, **Appendix 6** and **Appendix 7**. Between the representations all four of the licensing objectives are quoted:
 - The prevention of crime and disorder
 - Public Safety
 - The prevention of public nuisance
 - The protection of children from harm
- 3.3 The applicant has agreed conditions for the premises license with Cleveland Police, Environmental Health (Commercial Services) and Environmental Health (Environmental Protection).
- 3.4 At the time of writing this report the premises does not benefit from Building Regulations for the proposed use, the planning permission requirements are being investigated. The applicant is working with both Planning and Building Control to address these matters.
- 3.5 The Hartlepool Borough Council Statement of Licensing Policy states:
 - 5.34 Premises for which a licence is required must have a suitable, appropriate authorised use under planning legislation.
 - 5.35 The licensing authority will not normally entertain an application for a licence unless the applicant can demonstrate that the premises has either an appropriate (in terms of the activity and hours sought) planning consent, or an appropriate certificate of lawful use or development. Exceptions may be made where the applicant can demonstrate compelling reasons why the application

should not be refused and the planning status of the premises has not yet been finalised.

4. PROPOSALS

- 4.1 As relevant representations have been received, a hearing must be held for Members to consider the application (unless all parties agree a hearing is unnecessary).
- 4.2 Having regard to the representations received, Members may take any of the following steps for the promotion of the licensing objectives:
 - i) To approve the application in its entirety
 - ii) To approve the application in part with or without the addition of further conditions
 - iii) To reject the whole or part of the application
- 4.3 Members are reminded that they must only consider those aspects of the licence application that are relevant to the representations received.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

No supply of alcohol may be made under the premises licence-

- (a) At a time when the designated premises supervisor in respect of the premises licence, or
- (b) At a time when the designated premises supervisor does not hold a personal license or his personal license is suspended

Every supply of alcohol under the premises license must be made or authorised by a person who holds a premises license

- 2. In relation to the exhibition of films, the admission of children must be restricted in accordance with the classification designated by the British Board of film classification (BBFC) or other authority designated by the video recording act 1984 for the film, or films being exhibited
- 3. Each individual employed or otherwise engaged at the premise to carry out a security activity must be licensed by the security Industry Authority
- 4 (1) The responsible person must ensure that staff on the relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premise.
- (2) in this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premise.
- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

i)drink a quantity of alcohol with a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol),or

ii)drink as much alcohol as possible (whether in a time limit or otherwise)

- (b)Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) Provision of free or discounted alcohol or any other things as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective

- (d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premise which can reasonably be considered to condone, encourage or glamourise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) Dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 5. The responsible person must ensure that a free potable water is provided on the request of customers where it is reasonably available
- 6.(1) The premise license holder or club premises certificate holder shall ensure that an age verification policy is adopted in respect of the premise in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises license must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 7. The responsible person shall ensure that -
- (a) where any of the following alcoholic drinks is old or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for the sale or supply in a securely closed container) it is available to customers in the following measures –
- (i) beer or cider. ½ pint
- (ii) gin,rum,vodka,whisky: 25ml or 35ml
- (b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises and
- (c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 8.(1) a relevant person shall ensure that no alcohol is sold or supplied for the consumption on or off the premises for a price which is less than the permitted price
- (2) for the purpose of the condition set out in paragraph 1 –
- (a) "duty" is to be construed in accordance with the alcoholic liquor Duties Act 1979(6);
- (b) "permitted price" is the price found by applying the formula-

$$P = \mathcal{D} + (D \times V)$$

Where-

- (i) P is the price permitted
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
 - (c) "relevant person" means, in relation to the premise in respect of which there is in force a premises license-
 - (i) the holder of the premises license,
 - (ii) the designated premises supervisor (if any) in respect of such a license, or

- (iii)the personal license holder who makes or authorises a supply of alcohol under such a license;
- (d) "relevant person" means, in relation to the premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994(7).
- (3) where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1) sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Conditions consistent with the operating schedule

1. Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours includes:

New year's Eve from the end of permitted hours on New Years Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

- (h) The taking of alcohol from the premises by a person residing there; or
- (i) The supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide

- entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (j) The supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the license, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises
- Staff Shall be given in advance training regarding the law relating to alcohol sales, including selling to under 18 years olds and drunkenness.
- 3. There shall be no irresponsible drinks promotions
- 4. The premise shall become a member of the local pub watch scheme.
- 5. External drinking is prohibited after the hours of 23.00
- 6. Suitable signs shall be displayed in prominent positions requesting customers to leave the premises and area quietly.
- 7. There shall be maintained on the premise at all times an adequate and appropriate supply of first aid equipment and materials for use by patrons
- 8. The premises manager shall be trained in how to deal with illegal activities, aggressive customers, and the reusing to customer already drunk
- 9. There shall be external lighting of the car parks and walkways
- 10. There shall be no external regulated entertainment.

b) The prevention of crime and disorder

The system will have a minimum of a simplex multiplexing facility and be recording for 24 hours a day.

The system will incorporate a means of transferring images from the hard-drive to a format that can be played back on any desktop computer.

4. A "Challenge 25" policy will be implemented with all staff insisting on evidence of age from any person appearing to be under 25 years of age and who is attempting to buy alcohol. There shall be notices displayed at all points of sale and at all entrances and exits to

inform customers and remind staff that the premises is operating a "Challenge 25" policy.





To the Licensing Team,

I am writing to object to the application for sale or supply of alcohol and provision of late night refreshments by The Barn, Raby Arms, Front Street, Hartlepool, TS24 8AY.

I am objecting on a number of grounds as follows:

Noise - granting this Licence is likely to add to the existing noise nuisance caused by excessive noise levels from music events at the Raby Arms. The new structure is closer to private dwellings and is likely to be less insulated. Due to the nature of the structure, doors are also unlikely to remain closed at times when live or recorded music is played. There have been a number of occasions over the previous year where noise levels have been excessive. It would be interesting to know if The Raby Arms have undertaken any noise levels checks as described in the Licensing requirements.

Littering - Instances of littering from patrons of the establishment are likely to increase. I have seen Instances of discarded beer glasses and smashed bottles/glasses in the area near the car park entrance and beyond.

Anti social behaviour - This is likely to increase during and after the type of events likely to be held. There have been instances of noise nuisance and drug use in the car park after closing time.

Timing of events - The application would allow for events to be held at any time on any date with no restrictions. I would call the current incidence of events occasional but allowing this application could lead to large numbers of events disrupting the lives of local residents on a weekly or even daily basis.

Planning infringements - I have looked on the planning portal and have not been able to see any planning applications relating to the new structure. It would be interesting to know if the required application has been made as the structure is already in place and has been used prior to the granting of this application.

I would like these grounds for objection to be taken into account and the application to be rejected. The Raby Arms is described as a village pub and kitchen and granting this application would move it further away from this description and would not be appropriate in my opinion.

Dear Licensing Team,

I am writing to formally object to the licensing application submitted by Raby Arms Hart Limited for The Barn, The Raby Arms, Front Street, Hartlepool, TS27 3AJ.

I am a local resident who is already significantly impacted by the Raby Arms and their late night patrons. There has been drug taking in the car park and significant noise disturbances.

My concerns regarding the application for the sale or supply of alcohol and the provision of late-night refreshment are as follows:

1. Public Nuisance:

Extended alcohol sales and late-night refreshments could lead to increased noise levels, disrupting the peace of local residents. This may include loud music, disturbances from patrons leaving the premises late at night, and additional traffic.

2. Crime and Disorder:

Late-night alcohol sales can contribute to anti-social behavior, vandalism, and public disorder, negatively impacting the safety and security of the community.

3. Public Safety:

Increased footfall and potential intoxication could lead to safety risks such as littering, accidents, and rowdy behavior in the surrounding area.

4. Protection of Children from Harm:

To the Licensing Team,

I am writing to object to the application for sale or supply of alcohol and provision of late night refreshments by The Barn, Raby Arms, Front Street, Hartlepool, TS24 8AY.

My grounds for objection are:

The new building is not a stone structure and is less likely to be insulated against any noise. Levels of noise from current events are already loud enough to be heard within our house with doors and windows closed. The vibration of bass during current music events is excessive. The pub doors and windows are not all closed during events. The new building is closer to our house. The noise is currently causing me distress and making it impossible for me to sit in the garden during events. If the application is granted this will become more frequent and louder. There is no part of our house that I can go to to escape the noise and vibrations.

People leaving the pub are already noisy in the car park and the new application is likely to lead to more instances of anti-social behaviour.

Cars are sometimes in the pub car park in the early hours of the morning. They have been revving engines, playing loud music, shining headlights and drug taking.

Our garden fence is shared with the pub car park and pub garden. This means it is in close proximity to our property and any noise and other anti-social behaviour.

This close proximity to neighboring residents is currently not being taken into account so any issues are only likely to get worse.

As far as I know there is no planning permission for the barn. The building is already in place and in use some of the time.

I believe the owners are trying to run the pub like a noisy town pub rather than a local village pub in a residential area.

I would like these grounds for objection to be seriously considered due to the impact on my well being and I feel that the application should be rejected.
