#### 1. PURPOSE OF REPORT

1.1 To inform Members of the Forum that Sandra Saint (Healthy Schools Coordinator) and Deborah Gibbin (Teenage Pregnancy Co-ordinator) have been invited to attend this meeting to provide a demonstration of primary and secondary school activities undertaken as part of sex and relationship education for young people in Hartlepool.

### 2. BACKGROUND INFORMATION

- 2.1 Members will recall that at the meeting of this Forum on 8 January 2007 the Terms of Reference and Potential Areas of Inquiry/Sources of Evidence were approved by the Forum for this scrutiny investigation.
