## Subject: CORPORATE PLAN 2007/08: PROPOSED OBJECTIVES AND ACTIONS

### 1. PURPOSE OF REPORT

1.1 To provide the opportunity for the Children's Services Scrutiny Forum to consider the proposed objectives and actions for inclusion in the Corporate Plan 2007/08.

### 2. BACKGROUND INFORMATION

- 2.1 The Government introduced the Best Value regime as part of its programme to modemise local government and the Corporate (Best Value Performance) Plan for 2007/8 must be approved and published by the Council by 30 June 2007. This is the Council's top-level corporate plan. It sets out the Council's top priorities and contributions for delivering the Community Strategy aims in 2007/8.
- 2.2 The Corporate Plan is an important document because it formally communicates the council's vision and priorities. The process for producing the plan has been designed to ensure the risk is minimised and that the Corporate Plan is fit for purpose.
- 2.3 The focus of the Corporate Plan for 2007/8 is on priority activities for improvement at a strategic level rather than day to day service delivery objectives. The operational service delivery objectives are picked up through Departmental service plans which are reported to individual portfolio holders.
- 2.4 At a meeting of the Scrutiny Co-ordinating Committee held on 19 January 2006 it was agreed that the Corporate Plan proposals should be considered by each of the Scrutiny Forums. Each Scrutiny Forum will see the proposals relating to the Community Strategy themes that fall under their remit.

2.5 The comments/observations of each Forum will be fed back to the meeting of the Scrutiny Co-ordinating Committee to be held on 19 March 2007 and will be used to formulate the formal Scrutiny response to Cabinet on 16 April 2007.

### 3 THE CORPORATE PLAN

- 3.1 As in previous years the plan will be produced in two parts. Part 1 describes the Council's overall aim, contributions to the Community Strategy aims and organisational development priorities.
- 3.2 Part 2 will continue to contain the detailed supporting information relating to performance statistics which the Council is required to publish. This will include the Best Value performance indicators for 2006/07 and targets for 2007/08, 2008/09 and 2009/10. This information can not be collected until after 31 March 2007, and is therefore not available at present.
- 3.3 **Appendix A** details those objectives and actions that are proposed for inclusion in the 2007/08 Corporate Plan that fall under the Children's Services Scrutiny Forum remit.

### Subject: SCRUTINY OF THE PROGRESS OF THE CHILDREN AND YOUNG PEOPLE'S PLAN

### 1. PURPOSE OF REPORT

To inform members of the progress in completing the Children & Young People's Plan (CYPP) and the outcomes of the first 6 monthly monitoring exercise.

#### 2. BACKGROUND

Hartlepool Borough Council has a duty under the Children Act 2004 to prepare and publish a Children & Young People's Plan in co-operation with key partners. In preparing the Plan there was a strong focus on ensuring meaningful consultation with children and young people, as part of the extensive consultation process that was undertaken.

The Children's Services Scrutiny Forum considered the second draft of the CYPP on 7<sup>th</sup> February 2006. Cabinet considered the Scrutiny Forum's findings in relation to the second draft on 13<sup>th</sup> March 2006 and referred the third draft of the Children & Young People's Plan to full Council for approval. The plan was approved by Council on 13<sup>th</sup> April 2006.

#### 3. IMPLEMENTATION OF SCRUTINY FINDINGS

During the meeting of the Forum on 7<sup>th</sup> February 2006 a number of interim findings/conclusions were reached. These included a number of specific actions which the Forum wished to see completed and progress on these is outlined below:

• The Forum agreed that it was better to produce the Plan with separate documents for each of the 5 outcomes (Be Healthy, Stay Safe, Enjoy & Achieve, Make a Positive Contribution, Achieve Economic Wellbeing). This was to make it easily accessible to people wishing to focus on specific parts of the Plan. The final version of the Plan has been produced in this format, with additional, separate documents providing an

introduction and executive summary and service management and supplementary information.

- Suggestions were made about a potential format to enhance accessibility of the document for young people. Subsequently, through Hartlepool's participation network, a group of young people were commissioned to produce a children and young people's version of the CYPP. This meant that the young people's version is something that has been produced by young people for young people, rather than being an adult edited version of the full Plan.
- It was suggested that it would be useful to highlight the priorities for young people in the summary section of part one of the Plan. Part one of the final version of the Plan includes a section which gives an overview of the current position, key priorities and main success criteria for each of the Every Child Matters outcomes.
- The forum noted that young people themselves identified a lack of physical activity as a problem. It was recommended that this should be reflected in the 'Be Healthy' section of the Plan. This has been incorporated in activity 1.3 'Action is taken to promote children and young people's physical health'.
- Members recommended that the Children's Services Scrutiny Forum should examine the Plan twice yearly. The current report provides members with information about the first 6 monthly monitoring exercise and a full evaluation will be undertaken at the end of the first full year of the Plan. A further report will be provided to the Forum once that exercise has been completed.
- The Forum recommended that a member of the Forum should chair the participation Network. This suggestion will be discussed further with the Forum as part of the development of the Participation Strategy.

### 4. ENGAGEMENT OF STAKEHOLDERS

Following approval by Cabinet of the CYPP 2006-09, the Plan was circulated to the following: strategic leads of key partners (e.g. health, police, HVDA), headteachers, libraries, Councillors, regional local authority directors, tourist information centre, outcome leads, senior officers, housing officers, Corporate Management Team and Children's Services Management Team, independent consultant providing support to NQTs in Hartlepool. In addition a summary version of the report was provided to all those listed above plus all governors, Civic Centre reception, Hartlepool Education Development Centre reception, Children's Information Service reception, community centres, health visitors and nurses.

The children and young people's version of the Plan was circulated during the autumn term to all children aged 7 years and over via schools.

Key partners responsible for delivering the outcomes in the Plan are all members of Hartlepool Children and Young People's Strategic Partnership, which is chaired by the lead member for Children's Services.

### 5. PROCESS FOR MONITORING PROGRESS ON THE PLAN

Each of the outcome areas for the Children and Young People's Plan has a lead officer who is responsible for ensuring that appropriate action plans are developed to address the priorities. Monitoring the progress of the plan is undertaken twice a year, with outcome lead officers presenting a report on progress to the Children's Services Planning and Evaluation Group. The first 6 monthly monitoring exercise was completed during October by the lead officers for each of the outcome areas. This initial 'health check' on progress was undertaken by means of a traffic light system against each of the specific actions within the five outcome areas. Green is used to indicate achieved or dearly on target, amber to indicate expected to achieve the required milestone and red would indicate failure to make progress/not expected to achieve the target. All 148 individual actions are currently rated green or amber. It should be recognised, however, that this exercise was only the first 6 monthly monitoring of a 3 year plan. At this early stage much of what can be reported represents activities which have been initiated and it is too early to identify outcomes or impact. A report on the 6 monthly monitoring exercise was taken to the Children and Young People's Strategic Partnership on 28th November 2006. The report provided evidence of specific progress against the key priorities in the Plan. This report is attached as Appendix A.

During the first year of the Plan it has also been subjected to detailed scrutiny by means of the Joint Area Review. The inspection team received a copy of the Plan and the Lead Inspector attended the Children and Young People's Strategic Partnership on 28<sup>th</sup> November, when the 6 monthly monitoring report was presented. Feedback form the inspection process is currently embargoed until the final inspection report is available but there were no indications that inspectors had any serious concerns about Hartlepool's Children and Young People's Plan.

### 6. EVALUATION

A full evaluation exercise on the first year of the Plan will commence in January 2007 as part of the corporate planning cycle.

### 7. **RECOMMENDATIONS**

Members are recommended to comment on progress during the first 6 months of the Children and Young People's Plan.

Hartlepool Children & Young People's Plan has been in place since April 2006 when it was formally approved by Hartlepool Council. The first six monthly monitoring exercise has now been completed by the lead officers for each of the outcome areas of the plan (Be Healthy, Stay Safe, Enjoy and Achieve, Make a Positive Contribution, Achieve Economic Well Being). Monitoring has been undertaken by means of a traffic light system against each of the specific actions within the five outcome areas. Green indicates achieved or clearly on target, amber indicates expected to achieve required milestone and red would indicate failure to make progress/not expected to achieve target. All 148 individual actions are currently rated green or amber. How ever, it should be recognised that this is only the first six monthly monitoring of a three year plan.
