The Scrutiny Support Officer informed Members that the Healthy Schools Coordinator and Teenage Pregnancy Co-ordinator had been invited to this meeting to provide a demonstration of primary and secondary school activities undertaken as part of sex and relationship education for young people in Hartlepool. Also in attendance was a school nurse who also undertakes these less ons within schools in Hartlepool.

The Healthy Schools Co-ordinator had brought a set of the Lucinda and Godfrey books which were used in schools for sex and relationship education from Reception through to Year 6. Members were informed that a request had been received for Hartlepool officers to show case the partnership working undertaken throughout the sex and relationship education in the town at the regional Active Citizenship Conference. Members asked what preparation was provided for parents. The Healthy Schools Co-ordinator indicated that letters and leaflets were sent to parents several weeks prior to the lessons commencing. Support was also provided for parents through sessions being organised for them to attend and a Speak Easy Accreditation course was being piloted by PATCH (Parent and Toddler Care in Hartlepool). The Healthy Schools Co-ordinator informed Members that positive feedback had been received from parents in relation to the briefing sessions. Members were then invited to participate in two activities currently used within schools as part of the sex and relationship education lesson.

The officers involved and the school nurse were thanked for their attendance and participation in this meeting and for answering Members questions. Members felt it was a very informative session which would help formalise

their recommendations for this inquiry.

ADDITIONAL INFORMATION REPORT

1. PURPOSE OF REPORT

1.1 To provide an opportunity for the Children's Services Scrutiny Forum to consider additional information regarding the investigation into the provision of sex and relationship education in Hartlepool schools

2. BACKGROUNDINFORMATION

- 2.1 The latest figures for under 18 conception rates were published on 22 February 2007. The under 18 conception rate for Hartlepool for 2005 is 78 per 1000 females aged 15 17. This compares with the under 18 rate for England which is 41.1. This demonstrates a 3% rise in the rate from the base line in 1998 which was 75.6, this increase in the under 18 conception rate highlights the importance of accelerating the implementation of our local Teenage Pregnancy Strategy.
- 2.2 As reported at a previous meeting considerable progress has been made to improve: Sex and Relationship Education in the school, non school setting, for parents and access to Contraception and Sexual Health Services.
- 2.3 In order to strengthen the delivery of SRE in secondary schools a new programme is currently being developed that will begin in Year 7, (as both a progression of the spiralling primary curriculum and to facilitate smooth transition), and will end in Year 11. The programme is based on evidence from OFSTED which demonstrates that comprehensive and early SRE empowers and encourages young people to have sex later and use contraception when they do so. OFSTEDs report into Sex and Relationships Education stresses the importance of comprehensive approaches to facilitate effective SRE that enables young people to gain the skills to make informed,

healthy choices about relationships and to be able to resist pressure to have sex.

- 2.4 OFSTED also highlight the difference in the quality of teaching in SRE by specialists and non-specialist tutors demonstrating that the quality of teaching is unsatisfactory in twice as many lessons taught by tutors as by specialist teachers. This picture is not new and it has been stated that 'the most effective teaching was by teachers with a special interest and expertise in SRE, while nearly all the poor teaching was by form tutors'. At present 2 out of the 6 mainstream secondary schools use a specialist team approach to delivering SRE.
- 2.5 The APUA SE programme w hich is currently delivered in Hartlepool secondary schools provides important data from a Year 11 questionnaire w hich reflects young peoples views over time in terms of their knowledge about sexually transmitted infections and contraception (table 1) and how they felt about their sex and relationship education (table 2). In addition there is important evidence regarding young people's sexual activity (table 3)

It is important that schools continue to see the value of SRE and invest in staff to enable them to deliver high quality teaching and learning in SRE. There is a place for external agencies to support schools in the delivery of SRE and where this is most effective, it is planned to add value to the existing planned programme.

1. PURPOSE OF REPORT

1.1 To inform Members of the Forum that David Messinger, SRE Co-ordinator, South Tyneside Council has been invited to attend this meeting to provide evidence in relation to the ongoing investigation into the provision of sex and relationship education (SRE) for young people in Hartlepool schools.

2. BACKGROUNDINFORMATION

- 2.1 Members will recall that at the meeting of this Forum on 8 January 2007 the Terms of Reference and Potential Areas of Inquiry/Sources of Evidence were approved by the Forum for this scrutiny investigation.
- 2.2 As part of the approved timetable for the investigation, it was intended that three members of the Forum would visit South Tyneside Council to observe their strategies/practices. During the course of discussions to identify a suitable date, officers from South Tyneside Council indicated that they would be available to come to Hartlepool and present the required information directly to the full Children's Services Scrutiny. - 2.3 Chair's approval has obtained for provision of the required information to the full Forum and consequently, David Messinger, SRE Co-ordinator, from South Tyneside Council has been invited to attend this meeting to provide details of the Council's strategies and practices with a view to identifying possible areas of improvement in Hartlepool.

 - d) How could SRE provision in South Tyneside be further improved?
 - e) When does SRE provision start in South Tyneside schools?
 - f) If SRE education begins in primary schools is there gap in provision at any point?
 - g) How does South Tyneside Council work with outside agencies/bodies to provide SRE?
 - h) What is the staffing structure and size of the division/section responsible for the provision of SRE in South Tyneside?
