The premises trading as Meraki is a ground floor and basement café by day, cocktail by night venue, offering a small artisan breakfast menu, pizza and charcuterie. The venue is located at 7a Church Square, Hartlepool, TS247EY

**Concept & Situation** The venue is intended as a vibrant, flexible space, serving the town from morning through to evening. By day, it will function as a calm, Scandinavian-inspired coffee bar, appealing to remote workers, freelancers and the local community with quality refreshments and high-speed internet. By night, it will transition into a contemporary cocktail bar offering a relaxed, sophisticated setting that adds a new dimension to Hartlepool's hospitality offering within the Church Street Conservation Area.

**Layout** The ground floor and basement will operate as a single, integrated hospitality space, accessed via the main front entrance, with the ground floor accommodating the principal bar area including customer seating, a central bar servery and customer toilet facilities, while the basement provides an additional lounge-style bar area with further seating and independent toilets.

The premise includes a small back of house kitchen, commercial bin storage and store cupboards

**b) The prevention of crime and disorder**

- A digital CCTV system will be installed, maintained and fully operational whilst the premise is open, covering all public areas inside and outside the immediate entrance/exit
- Recordings will be kept for a minimum of 31 days and footage will be made available to the police upon reasonable request.
- Staff training and responsible alcohol service.
- Ongoing liaison with local authorities and Police Licensing.
- Staff will be trained to recognize signs of intoxication and will refuse service to anyone who appears drunk
- An incident log shall be kept at the premise.

**c) Public safety**

- Staff first aid training
- Toilets maintained to a high standard
- Regular fire risk assessments and compliance with H&S regulations
  
- The number of persons permitted in the premises at any one time (excluding staff) shall not exceed the limit set by the FRA (Approximately 80 covers)

**d) The prevention of public nuisance**

- Doors and windows will be kept closed after 2300hrs, except for immediate access and egress to prevent noise breakout.
- Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
- The placing of bottles into external receptacles shall not take place between 2300 and 0800 hours to minimise noise disturbance
- The surrounding outdoor areas shall be kept clean and tidy at all times.

**e) The protection of children from harm**

- Challenge 25 policy implemented and enforced
- No unaccompanied under-18s on site
- Staff trained to identify and deal with underage attempts to purchase alcohol
- A refusal register will be kept and updated whenever a sale of alcohol is refused to Person under the age of 18.
