LICENSING OBJECTIVES

a) General – all four licensing objectives (b,c,d,e)

The premises will be operated in a responsible manner at all times, with the four licensing objectives being actively promoted by the Premises Licence Holder, Designated Premises Supervisor and all staff. Staff will receive appropriate training on licensing requirements, responsible alcohol sales, age verification, dealing with intoxicated customers, prevention of crime and disorder, public safety and the prevention of nuisance. Training will be recorded and refreshed as necessary. The Premises Licence Holder will maintain appropriate records of relevant incidents, refusals of alcohol sales and complaints. Any issues arising will be investigated and appropriate action taken. The premises will cooperate with the Police, Council and other Responsible Authorities and will comply with all conditions attached to the Premises Licence.

b) The prevention of crime and disorder

Staff will be trained to recognise and deal appropriately with incidents of crime, disorder and anti-social behaviour. A strict Challenge 25 age-verification policy will be operated for the sale of alcohol, with acceptable photographic identification required where a customer appears under 25. Staff will refuse the sale of alcohol where there are reasonable grounds to believe that the customer is underage or is already intoxicated. Any incidents of violence, disorder, suspected drug use, theft or other criminal activity will be recorded and, where appropriate, reported to the Police. CCTV will be provided and maintained where appropriate to the premises, with coverage of relevant public areas and entrances/exits. CCTV recordings will be made available to the Police or authorised officers when lawfully requested. Staff will monitor customers and the premises to prevent disorder and will take reasonable steps to prevent individuals who are causing problems from remaining on the premises. The premises will not knowingly permit the use or supply of illegal drugs.

c) Public safety

The premises will be maintained in a clean, safe and suitable condition for customers, staff and visitors. Fire exits and escape routes will be kept clear and readily accessible whenever the premises are occupied. Appropriate fire safety equipment and procedures will be maintained and staff will be made aware of emergency procedures. Staff will monitor the premises for hazards, including spills, obstructions, damaged equipment and overcrowding, and appropriate action will be taken promptly. Any accidents or significant incidents will be recorded and investigated where appropriate. The premises will operate within any applicable capacity limits and staff numbers will be appropriate for the activities taking place. Any relevant safety equipment and systems will be regularly checked and maintained.

d) The prevention of public nuisance

Continued from previous page...

The premises will be operated in a manner that minimises disturbance to nearby residents and businesses. Staff will monitor noise levels and take reasonable steps to prevent excessive noise escaping from the premises. Doors and windows will be managed appropriately where necessary to reduce noise disturbance. Customers will be encouraged to leave the premises quietly and considerately, particularly during late-night hours. Staff will monitor the immediate area outside the premises for unreasonable noise, anti-social behaviour or litter associated with customers. Waste will be stored and disposed of responsibly and the area immediately outside the premises will be kept clean and free from litter. Any complaints concerning noise, nuisance or anti-social behaviour will be recorded, investigated and appropriate action taken.

e) The protection of children from harm

A Challenge 25 policy will be operated for the sale of alcohol, with appropriate photographic identification requested from anyone who appears to be under 25. Staff will receive training in the prevention of underage sales and will understand the legal requirements relating to the sale of alcohol to children. The premises will not knowingly sell or supply alcohol to anyone under the age of 18. Where appropriate, staff will monitor young persons on the premises and take reasonable steps to prevent them accessing age-restricted products or activities. Any concerns regarding the welfare or safety of children will be taken seriously and dealt with appropriately. Staff will be aware of safeguarding procedures and will report serious concerns to the appropriate authorities where necessary. The premises will comply with all legal requirements and licence conditions relating to the protection of children.

NOTES ON REGULATED ENTERTAINMENT

Continued from previous page...

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
